

**2.10.2: Beneficiaries**

Omit the reference to clause 9.2.5 in the 5th line of this clause and *substitute* '9.2.6'.

**2.11.2: Minimum Charge**

Omit the charge of 52 cents and *substitute* 60 cents

**2.11.3: Season Tickets**

Omit the minimum charge of \$4.87 and *substitute* \$5.00

**2.12 to 2.12.7 inclusive: Bulk Travel Accounts**

Omit these clauses

**2.13: New Zealand Travelpass**

Renumber this clause 2.12

**2.13.1: Conditions**

Renumber this clause 2.12.1

Omit the excess charge of \$22.00 for sleeping berths and *substitute* \$26.00

**2.13.2: Availability**

Omit this clause and *substitute*—

"2.12.2: Availability

The low season Travelpass shall be available for 8, 15 or 22 consecutive days during the period 1 February to 14 December, both dates inclusive. A further high season high pass is available if purchased overseas for 8, 15 or 22 consecutive days during the period of 15 December to 31 January, both dates inclusive."

**2.13.3: Fares**

Omit this clause and *substitute*—

"2.13.3: Fares

Travelpass shall be charged as follows:

Passes for periods overlapping into the High Season will be charged at the high season fare. Children under four years of age and accompanied by a responsible person will travel free and children 4 years of age and under 15 years of age may be issued a Travelpass at half fare."

**2.13.4: Extension to Travelpass**

Omit this clause and *substitute*—

"2.12.4: Extension to Travelpass

The pass may be extended up to a further 6 successive days at an additional charge as under:

**2.14.3 to 2.15.3**

Omit the reference to clause 2.14.6 in clause 2.14.5 and *substitute* 2.13.5

Omit the reference to clause 2.14 in clause 2.15.1 and *substitute* 2.13

Renumber these clauses to read 2.13.2 to 2.14.3

**2.15.4: Lost Season Tickets**

Omit the minimum charge of \$3.10 and *substitute* \$4.00. Renumber the clause to read 2.14.4

**2.15.5 to 2.17.2**

Renumber these clauses to read 2.14.5 to 2.16.2

**Section 4: Long Distance Rail Passenger Services: Ordinary Fares****4.1 to 4.7**

Omit these clauses and *substitute*—

"4.1: Silver Fern railcar service fares

The Auckland-Wellington adult single ordinary fare is \$69.00. Fares to and between intermediate timetabled stopping stations are as shown in the Corporation's Fares and Timetable booklet.

4.2: Northerner service fares

The Auckland-Wellington adult ordinary fare is \$64.00. The Auckland-Wellington adult sleeper fare is \$90.00. The Auckland-Wellington children, eligible beneficiaries or blind persons and attendants fare
