ALL that area in the Otago Land District, Bruce County bounded by a line commencing at mean high-water mark of the sea at the middle of the mouth of the Tokomairiro River and proceeding generally north-westerly up the middle of that river to a point in line with the eastern boundary of Section 35, Block VI, Akatore Survey District; thence northerly to and along that boundary and westerly along the northern boundary of Section 33 aforesaid to the south-eastern corner of Section 24, Block I, Akatore Survey District; thence north-westerly along the north-eastern boundaries of the said Section 24 and Sections 25, 364R, 26, 1 of 27, 1 of 28 and 29, Block I aforesaid to the northernmost corner of Section 31, Block I aforesaid; thence south-easterly along the north-eastern boundary of Section 31 aforesaid to the north-western boundary of Section 45A, Block I aforesaid; thence north-easterly and easterly along the north-western and northern boundaries of that section and the production of the last-mentioned boundary to the middle of an unnamed road; thence generally northerly along the middle of that road and its production to the middle of an unnamed road forming the north-western boundary of Section 1, Block I, Akatore Survey District; thence north-easterly along the middle of that road to a point in line with the middle of an unnamed road forming the north-eastern boundary of Section 1 aforesaid; thence south-easterly and north-easterly along the middle of that road and its production across Lindsay Road to the south-western side of closed road in Block VIII, Tokomairiro Survey District; thence south-easterly, north-easterly, north-westerly and south-westerly along the south-western, south-eastern, north-eastern and north-western sides of that closed road to a point in line with the middle of Wests Road; thence to and along the middle of that road to a point in line with the south-eastern boundary of Section 6, Block I, Tokomairiro Survey District; thence north-easterly to and along the south-eastern boundaries of that Section and Sections 5 and 4, Block I aforesaid, and north-westerly along the north-eastern boundary of the last-mentioned section and its production to and along the north-eastern boundaries of Sections 9 and 16, Block II, Tokomairiro Survey District and the production of the last-mentioned boundary to the middle of State Highway 1; thence north-easterly along the middle of that State highway to a point in line with the middle of Milburn Circle Hill Road; thence to and along the middle of that road and its production to the middle of Bruce Road; thence south-westerly along the middle of Bruce Road and its production to the middle of North Branch road; thence north-westerly along the middle of that road to a point in line with the western boundary of Section 123, Block XV, Tokomairiro Survey District; thence southerly to and along the western boundary of that section to the westernmost corner of Section 124, Block XV, aforesaid; thence south-easterly along the south-western boundary of that section and Section 125, Block XV aforesaid to the north-western boundary of Section 127, Block XV aforesaid; thence south-westerly along the north-western boundaries of that section and Sections 128 and 129, Block XV aforesaid and the production of the last-mentioned boundary to the middle of an unnamed road; thence north-westerly along the middle of that road and its production to the middle of Alexander Road; thence south-westerly along the middle of that road and its production to the middle of the Tokomairiro River West Branch; thence generally south-easterly down the middle of that river to its intersection with the middle of State Highway 1; thence generally south-westerly along the middle of State Highway 1 to a point in line with the south-western boundary of Section 19, Block I, Hillend Survey District; thence south-easterly to and along the south-western boundaries of that section and Sections 18, 17 and 6, Block I aforesaid and the production of the last-mentioned boundary to the western shore of Lake Tuakitoto; thence generally southerly and south-easterly along the generally western and south-western shore shores of Lake

Tuakitoto to the northernmost corner of Lot 2, D.P. 12389; thence south-westerly along the north-western boundary of that lot, and south-westerly and south-easterly along the north-western and south-western boundaries of Lots 1, 4 and 3, D.P. 12389 to the southernmost corner of the last-mentioned lot; thence north-easterly along the south-eastern boundary of Lot 3 aforesaid to the boundary of the Kaitangata Ward hereinbefore described; thence generally northerly, easterly and southerly along that boundary to a point in line with the southern boundary of Section 1, Block VIII, Kaitangata Survey District; thence easterly to and along that boundary and the southern boundary of Section 2, Block VIII aforesaid and its production to the middle of an unnamed road; thence generally northerly along the middle of that road intersecting Block VIII aforesaid and Block V, Kaitangata Survey District and its production to the middle of an unnamed road forming the generally western boundary of Block VI, Kaitangata Survey District; thence generally south-easterly along the middle of that road and its production to the middle of an unnamed road forming the northern boundary of Lot 1, D.P. 17265; thence generally easterly along that road and generally north-easterly and northerly along the middle line of the unnamed road forming the generally south-eastern and eastern boundaries of Block VI aforesaid and intersecting Block III, Kaitangata Survey District to a point in line with the north-western boundary of Section 18, Block III, aforesaid; thence north-easterly to and along that boundary to its intersection with the middle of Shagree Creek; thence generally south-easterly down the middle of Shagree Creek to the mean high-water mark of the sea; thence north-easterly along that mean high-water mark to the point of commencement, excluding therefrom the Milton Ward.

MATAU WARD

ALL that area in the Otago Land District, Bruce County, bounded by a line commencing at the middle of the mouth of Shagree Creek at the mean high-water mark of the sea, and proceeding generally south-westerly along that mean high-water mark to the middle of the mouth of the Koau Branch of the Clutha River; thence generally north-westerly up the middle of that branch of the Clutha River to its intersection with the boundary of the Borough of Balclutha as described in *New Zealand Gazette*, 1955, page 1093; thence generally northerly along that Borough boundary to its intersection with the middle of State Highway 1; thence generally north-easterly and northerly along the middle of State Highway 1 to a point in line with the south-western boundary of Section 19, Block I, Hillend Survey District; thence generally easterly along the generally southern boundary of Tokomairiro Ward hereinbefore described to the point of commencement, excluding the Kaitangata Ward also hereinbefore described.
