ORDER

1. This order may be cited as the Levin Airport Authority Establishment Order 1986 and revokes the Levin Airport Establishment Order 1985 (*New Zealand Gazette*, 1985, No. 132, page 3046).

2. Consent is hereby given to the Levin Borough Council to establish, maintain, operate and manage an airport and to acquire land for such purpose within the Horowhenua County on the following condition:

The Airport that will be established shall be classified as a public aerodrome under regulation 184(1)(a) of the Civil Aviation Regulations 1953.
