Including Land in a Maori Reservation

WHEREAS by notice dated 29 November 1962 published in the *New Zealand Gazette*, No. 77, page 2148, the land described in the First Schedule hereto was set apart as a Maori reservation for the purpose of a meeting place for the common use and benefit of the members of the Ngati Turanga hapu of the Raukawa Tribe.

And whereas by notice dated 8 August 1985 published in the *New Zealand Gazette*, No. 145, page 3337, the area of the aforesaid Maori reservation was reduced consequent upon an exchange of part Himatangi 2A1B Block for the land described in the Third Schedule hereto.

And whereas by virtue of the said notice dated 8 August 1985 the description of the land in the said Maori reservation is as set out in the Second Schedule hereto.

And whereas it is now desired to extend the reservation to include the land described in the Third Schedule hereto.

Now therefore pursuant to section 439 (2) of the Maori Affairs Act 1953, it is hereby declared that the land described in the Third Schedule hereto is included in the aforesaid Maori reservation.

FIRST SCHEDULE

WELLINGTON LAND DISTRICT
