*The Traffic (Mangonui County) Notice No. 1, 1986*

PURSUANT to the Transport Act 1962, a delegation from the Minister of Transport, and a subdelegation from the Secretary for Transport, I, Carne Maurice Clissold, Chief Traffic Engineer, give the following notice:

NOTICE

THIS notice may be cited as the Traffic (Mangonui County) Notice No. 1, 1986.

The area specified in the Schedule is declared to be a closely populated locality for the purposes of section 52 of the Transport Act 1962.

SCHEDULE

SITUATED within Mangonui County at Whatuwhiwhi and Tokerau Beach.

All that area bounded by a line commencing on the shore line of Doubtless Bay due east of the southern termination of Harreine Place; thence due west to the said termination; thence northerly, generally, to the eastern termination of Paremata Nexus Road; thence northerly, generally, to a point on the southern side of Simon Urlich Road 500 metres measured easterly, generally, from Inland Road; thence across Simon Urlich Road by a right line from its southern side to its northern side; thence northerly, generally, to a point on the south-eastern side of Inland Road 1200 metres measured westerly, generally, from Doubtless Bay Drive; thence north-westerly across Inland Road from its south-eastern side to its north-western side; thence northerly and easterly, generally, along the northern and western side of Inland Road and Matai Bay Road to a point on the western side of Matai Bay Road 250 metres measured northerly, generally, from Doubtless Bay Road; thence across Matai Bay Road at right angles from its north-western side to its south-eastern side; thence due east to a point due north of the intersection of Whatuwhiwhi Road and Matariki Place; thence due south to the coastline of Doubtless Bay; thence westerly and southerly, generally, along the said coastline to the commencing point.
