

2. Exchange rates—Where under any provisions of the Customs Act 1966 any amount which is required to be taken into account for the purpose of assessing duty or any other purpose is not an amount in New Zealand currency, the amount to be so taken into account shall be the equivalent in New Zealand currency of that amount ascertained in accordance with the rate of exchange set out in the Schedule to this notice.

3. Revocation—The Customs Exchange Rates Notice (No. 25) 1986, published in the *New Zealand Gazette*, No. 199, dated 11 December 1986, on page 5319 is hereby revoked.

The Water Recreation (Gisborne) Notice 1986, New Zealand National Surfing Championships

I, Beryl Ann Ranger, Senior Executive Officer (Harbours and Foreshores), pursuant to the Water Recreation Regulations 1979* and in exercise of powers delegated to me pursuant to sections 8 and 9 of the Ministry of Transport Act 1968, hereby give the following notice.

NOTICE

1. (a) This notice may be cited as the Water Recreation (Gisborne) Notice 1986.

(b) This notice shall come into force on 30 December 1986 and shall remain in force until 14 January 1987.

2. Subject to the conditions set forth in the Second Schedule hereto, pursuant to regulation 13 of the Water Recreation Regulations 1979, the area of water described in the First Schedule hereto shall be reserved for the use of surfboards with preference to be given to competitors and supporting crews of the New Zealand National Surfing Championships.

FIRST SCHEDULE

ALL that area of water within 200 metres of the foreshore of Midway (West of Stanley Road), Wainui or Makorori Beaches as marked red on plan M.D. 16208, deposited in the office of the Secretary for Transport at Wellington.

SECOND SCHEDULE

1. All persons in charge of a vessel shall adhere to and keep the provisions of all other Acts and regulations not specifically exempted by this notice.

2. A suitable notice as may be approved by the Regional Secretary, Ministry of Transport, Wellington, shall be erected at sites deemed necessary by the regional secretary.
