

Lots 2 and 1, D.P. 46728, Lot 1, D.P. 14806, Lots 48 and 52, D.P. 1429, and Lots 5 and 1, D.P. 16560, to the northernmost corner of the said Lot 1; thence generally south-westerly along the north-western boundary of the said Lot 1 and its production across Country Road to the western boundary of the North Island Main Trunk Railway and along that boundary to the north-eastern side of Mill Road and along a right line bearing 239° 38" distance 20.86 metres to the south-western side of Mill Road; thence generally westerly along that side to and along the south-eastern boundary of Lot 1, D.P. 28990, and its production to the left bank of the Haruatai Stream, and along that bank to the easternmost corner of Lot 7, D.P. 15552; thence south-westerly along the south-east boundary of the said Lot 7 and its production across Arthur Street to the easternmost corner of Lot 1, D.P. 14903; thence south-westerly along the north-western boundaries of a Service Land and the North Island Main Trunk Railway to peg IV as shown on S.O. Plan 13061; thence north-westerly along a right line bearing 322° 43" distance 15.34 metres to a point in State Highway No. 1; thence generally south-westerly along the generally north-western boundaries of part of that highway shown coloured burnt sienna on S.O. Plans 20089 and 20090 to and along the south-eastern boundaries of Lots 7 and 4, D.P. 20945, Lot 2, D.P. 26621, and Lot 8, D.P. 20945, and along a right line to the intersection of the south-western side of Riverbank Road and the western side of State Highway No. 1; thence generally north-westerly along the south-western side of Riverbank Road to the easternmost corner of Lot 2, D.P. 51525, and proceeding south-westerly along the south-eastern boundary of Lot 2 aforesaid to the southernmost corner of the said Lot 2; thence generally north-westerly along the south-western boundaries of Lots 2 and 1, D.P. 51525, and Lots 2 and 1, D.P. 46977, to the westernmost corner of Lot 1 aforesaid, thence north-easterly along the eastern boundary of part Lot 1, D.P. 6893, and its production to the right bank of the old course of the Otaki River (Ngatoko Stream), and along the bank to the westernmost corner of Lot 4, D.P. 13970; thence generally northerly along the western boundary of Maungapiharau Block and its production to the middle of the Maungapiharau Creek and down the middle line of that creek to its confluence with the Rangiuru Stream; thence due north to the southern boundary of Lot 8, D.P. 3364, thence easterly along the southern boundaries of Lots 8 and 11, D.P. 3364, and north-easterly along the south-eastern boundary of the said Lot 11 to the south-western side of Tasman Road; thence north-westerly along that side to the northernmost corner of Lot 5, D.P. 3364; thence generally south-westerly along the generally north-western boundary of that lot and its production to the left bank of the Rangiuru Stream and along that bank to the north-eastern side of Rangiuru Road; thence generally easterly along that side and the generally northern side of that road to the western boundary of Takapu Block; thence southerly and easterly along the western and southern boundaries of that block to the right bank of the old course of the Otaki River (Ngatoko Stream); thence generally westerly along that bank to and along the generally southern boundaries of Lot 86, D.P. 762, Lots 1 and 2, D.P. 41261, and Lot 87, D.P. 762, to the westernmost corner of that lot; thence generally north-easterly along the north-western boundaries of Lot 87 aforesaid, Lots 9 and 8, D.P. 15133, and the left bank of the Rangiuru Stream as shown on D.P. 762 to the intersection of the eastern side of Kapiti Lane with the north-eastern side of Atkinson Avenue; thence north-westerly to and along the north-eastern side of Atkinson Avenue to the sea coast; thence north-easterly along the line of the mean-high water mark.

*Murupara Borough—Whakatane District Boundary Definition Notice 1986*

PURSUANT to section 48 of the Local Government Act 1974, the Secretary for Local Government gives the following notice:

NOTICE

1. This notice may be cited as the Murupara Borough—Whakatane District Boundary Definition Notice 1986.

2. The boundaries of Murupara Borough and Whakatane District are hereby defined as set out in the Schedules hereto, those boundaries having been altered by Order in Council published in the *New Zealand Gazette*, 4 July 1985, No. 128, page 2901 and which came into force on 1 July 1985.

FIRST SCHEDULE

BOUNDARIES OF MURUPARA BOROUGH

ALL that area in the South Auckland Land District containing 644 hectares, more or less, bounded by a line commencing in the middle of Whirinaki River in Block XIII, Galatea Survey District, at a point in line with the former north-western boundary of Whirinaki

1, Section 2B, (M.L. Plan 10446) and proceeding southerly to and along that last-mentioned former boundary to a point in line with the southern boundary of part Whirinaki 1, Section 2, Native School Site (M.L. Plan 16150); thence westerly to and along that boundary and the southern boundaries of parts Whirinaki 1, Section 2F and Section 2F 2 and the last-mentioned boundary produced to the middle of State Highway No. 38; thence north-westerly along the middle of that highway to a point in line with the north-western boundary of Lot 4, D.P. S. 28038; thence south-westerly along a right line to the northern corner of Lot 4, D.P. S. 28038, thence north-westerly along the south-western side of State Highway No. 38 to the eastern boundary of Lot 8, D.P. S. 11090; thence southerly along that eastern boundary and north-westerly along the southern boundaries of Lots 8, 7, 6, 5, 4, 3, D.P. S. 11090 to the eastern boundary of Lot 9, D.P. S. 11090; thence southerly along that eastern boundary and its production to the south-western boundary of Lot 3, D.P. S. 24816; thence north-westerly along that south-western boundary to the eastern side of an unnamed public road; thence southerly along that eastern side to and southerly along the eastern boundary of Section 34, Block XIII, Galatea Survey District and its production to the right bank of the Rangitaiki River; thence south-westerly along a right line bearing 241° 30' to the middle of Kiorenui Road; thence northerly along the middle of Kiorenui Road and Railway Road to a point in line with the southern boundary of part Karatia 3B1C; thence easterly to and along that boundary as shown on M.L. 11986, and its production to the middle of the Rangitaiki River crossing the intervening Pokairoa Road; thence southerly up the middle of that river (see air photo S.N. 8165/C/3, dated 24/1/83) to the middle of the Whirinaki River; thence generally southerly up the middle of that river to the point of commencement.

SECOND SCHEDULE

BOUNDARIES OF WHAKATANE DISTRICT

ALL that area in the South Auckland and Gisborne Land Districts containing 4310 square kilometres, more or less, bounded by a line commencing on the line of mean high water of the Bay of Plenty of the north-eastern corner of Waewaeahikitea 1 Block, in Block IV, Waihi South Survey District, and proceeding generally south-easterly along the said mean high water line to the easternmost point of the Ohope Land Spit, on the western shore of the entrance to Ohiwa Harbour, in Block VII, Whakatane Survey District; thence due south for a distance of 100.58 metres; thence due south-west to a right line from the southernmost point of Lot 1, D.P. S. 497 (part Ohakana Island), and passing through a point 20.12 metres due north of the northernmost point of Allotment 284, Waimana Parish (Uretara Island); thence westerly along that right line to the southernmost point of Lot 1 aforesaid; thence westerly along a right line to a point 201.17 metres due west of the northernmost point of Allotment 127, Waimana Parish (Whitiwhiti Point); thence southerly along a right line to a point, bearing 119° 28', distance 30.26 metres from peg XIII on S.O. Plan 17197, on the line of mean high water along the shore of the Ohiwa Harbour, on the eastern side of Wainui Road; thence westerly along the boundary of Lot 2, D.P. 12843, on the bearing of 299° 28', and its production to the western side of Wainui Road; thence generally south-easterly along the generally south-western side of Wainui Road to its intersection with the western side of No. 2 State Highway, at the northernmost corner of Allotment 183A, Waimana Parish, situated in Block XI, Whakatane Survey District; thence southerly along the western side of No. 2 State Highway to the north-eastern corner of Allotment 185, Waimana Parish, situated in Block XI, Whakatane Survey District, southerly along the generally eastern boundaries of Allotments, Parts 185, 185B1A, Part 186, Waimana Parish, Lots 2 and 1, D.P. S. 11207, Allotments, Part 188, Parts 189, 190, Parts 191, 536, 535, Waimana Parish to the northern corner of Lot 2, D.P. S. 17649 situated in Block XV, Whakatane Survey District; thence south-easterly along the north-eastern boundary of the said Lot 2, and the production of that boundary to the eastern side of No. 2 State Highway; thence south-easterly along the north-eastern boundaries of Part Allotment 195, Allotment 488, Part Allotment 195, and Part Allotment 196, Waimana Parish, to the easternmost corner of the said Part Allotment 196; thence south-westerly along the south-eastern boundaries of Part Allotment 196, Part Allotment 197, Allotment 487, and Part Allotment 197, Waimana Parish, and along a right line to the easternmost corner of that part of Allotment 197 south of No. 2 State Highway; thence generally southerly along the generally western side of No. 2 State Highway to the intersection with the production northerly of the western side of Bell Road, situated in Block IV, Waimana Survey District; thence southerly to and along the western side of Bell Road aforesaid, to the south-easternmost corner of Allotment 223, Waimana Parish, as shown on D.P. 4734; thence easterly along a right line across Bell Road to and along the northern boundaries of Lot 3, D.P. 9715, and Lot 1, D.P. S. 3146 to the western side of a public road; thence south-easterly along a right line to and along the north-eastern boundaries of Lots 4, 5, and 3, D.P. S. 3146 to the easternmost corner of the said Lot 3; thence south-westerly along the south-eastern boundaries of the said Lot 3, Section 5, Block IV, Waimana Survey District, Waimana 1C1B, crossing a public road, Waimana 1C1C2, 1C1C3,
