

SCHEDULE

AREA OF SUPPLY

ALL that area in the Hawke's Bay and Wellington Land Districts bounded by a line commencing on the sea coast in the middle of the mouth of the Waimata Stream and proceeding along the middle of that stream to a point in line with the south-western boundary of Section 1, Block XIII, Tautane Survey District; thence north-westerly to and along that boundary to old Trig. Station 39A (Taumata O te Atua); thence north-westerly along right lines through Trig. Stations O (Oturehau), 41A (Mount Arthur) and P (old Pukehou) to the southernmost corner of Section 10, Block XV, Weber Survey District, being a point on the northern side of Falls Road; thence easterly and northerly generally along the northern and western sides of said road to the southern boundary of Section 10, Block XVI, Weber Survey District; thence north-westerly generally along the southern and western boundaries of the said Section 10 and of Section 11, Block XV, Weber Survey District to and across Grey Road, along the eastern boundary of Lot 4, D.P. 1412, to and across Oporae Road and along the north-eastern boundary of Lot 1, D.P. 1411 to the boundary between Section 3, Block XIV, Weber Survey District and Section 18, Block I, Weber Survey District; thence northerly along that boundary to the south-eastern boundary of Puketoi 6B Block; thence south-westerly generally along the south-eastern boundaries of Puketoi 6B and 6A Blocks to and westerly along the southern boundary of said 6A Block and the middle of the Mangatoro Stream and along the southern boundary of Lot 1, D.P. 7164 to and across the Makuri-Ongaha Main Highway and along the southern boundary of Section 10, Block XV, Tahoraiti Survey District to a rabbit fence reserve; thence southerly and westerly along the eastern and southern side of that reserve to its intersection with the north-western boundary of D.P. 4376; thence westerly generally along the northern boundaries of said D.P. 4376 to the western boundary of Section 13, Block III, Makuri Survey District; thence northerly along that boundary to the rabbit fence reserve; thence north-westerly along the western side of that reserve to the southern boundary of Section 1, Block XIII, Tahoraiti Survey District; thence easterly, northerly and westerly along the southern, eastern and northern boundaries of the said Section 1 and the last-mentioned boundary produced to the middle of a public road; thence northerly along the middle of that road to a point in line with the eastern boundary of Section 39, Block XIII, Tahoraiti Survey District; thence again northerly to and along that boundary and its production to the middle of another public road; thence north-easterly generally along the middle of that road and Druce Road to a point in line with the southern boundary of original Section 19 of said Block XIII; thence westerly along that boundary to and along the south-eastern boundary of Section 42, Block XIII aforesaid to the north-eastern boundary of Section 43, Block XIII; thence south-westerly generally along the south-eastern boundary of said Section 43 and its production to the middle of the Pahaheke Road; thence south-westerly along the middle of that road to a point in line with the western boundary of Section 37, Block XIII, Tahoraiti Survey District; thence southerly to and along that boundary, including the crossing of Waituna Road, to the south-eastern corner of Section 24, Block XIII aforesaid; thence westerly along the southern boundary of said Section 24, including the crossing of Waituna Road, the southern boundaries of Section 36, Block XIII aforesaid, Section 5, Block IX, Woodville Survey District, the crossing of Piert Road, the southern boundary of Section 63, Block IX aforesaid, the crossing of a public road, the southern boundaries of Sections 2 and 1, Block IX aforesaid, including the crossing of River Road and the production of the last-mentioned boundary to the middle of the Manawatu River; thence along the middle of that river to a point in line with the summit of the Tararua Range; thence south-westerly to and along that summit to Trig. Station Arawaru, Block I, Tararua Survey District; thence south-westerly along a right line towards Mount Dundas in Block XI, Tararua Survey District, passing through Trig. Station Ngapuketurua, Block VIII, Tararua Survey District, to its intersection with a right line bearing 297° from Trig. Station Tawhero in Block XIII, Tararua Survey District; thence south-easterly along that right line to Trig. Station Tawhero and along the summit of the Tawhero Range to the north-western boundary of Section 9, Block IV, Mikimiki Survey District; thence south-westerly along that boundary and its production to the middle of the Ruamahanga River; thence generally south-easterly along the middle of that river to a point in line with the north-western boundary of Section 71, Opaki District in Block VIII, Mikimiki Survey District, to and along that boundary and the north-eastern boundary of that section, and along its south-eastern boundary for a distance of 295.3 metres and along a right line to the westernmost corner of Section 69, Opaki District, being a point on the southern boundary of Lot 6, D.P. 16214; thence easterly and northerly along the southern and eastern boundaries of said Lot 6 to and along the southern boundary of Section 25, Block V, Kopuaranga Survey District and its production to the eastern side of Jacksons Line, along that side to and along the southern boundary of Section 28, Block V aforesaid and its production to the middle of the Kopuaranga River, up the middle of that river to a point in line with the southern boundary of Section 51, Rangitumau District, to and along that boundary and the eastern boundary of that section,

crossing Dorsets Road along the southern boundary of Section 100, Block V aforesaid, the western and northern boundaries of Lot 1, D.P. 14895, a right line across a public road to and along the northern boundaries of Lot 2, D.P. 14895, Lot 1, D.P. A/2167 and Lot 1, D.P. A/1146 and its production to the eastern side of Stuckeys Road; thence generally southerly along that side to the northern boundary of Section 42, Block II, Kopuaranga Survey District; thence generally south-easterly along that boundary, the western and southern boundaries of part Section 208, Rangitumau District, and the production of the last-mentioned boundary to the eastern side of No. 52 State Highway; thence along that side to the road corner eastward of I.T. XXXVIII on S.O. 24544, thence along a right line to a point in line with the western boundary of Lot 2, D.P. 3243 and 221.3 metres southward from the south-western corner of that Lot, along a right line to that corner, along the south-western boundaries of the said Lot 2 and Lot 1, D.P. A/345 to the south-eastern boundary of that Lot; thence generally northerly along that boundary and its production to the northern side of Clelands Road, along that side to and along the eastern boundary of Section 108, Rangitumau District, to the southern boundary of Section 110, Rangitumau District; thence generally south-easterly along that boundary and a right line across Mangareia Road to and along the south-western boundaries of part Section 235, Rangitumau District and D.P. 42977, to and north-easterly along the eastern boundaries of said D.P. 42977, said Section 235 and Section 139, Rangitumau District, to and along the south-eastern, south-western and north-western boundaries of Lot 1, D.P. 4826, a right line across Wairiri Road to and along the north-western and north-eastern boundaries of Lot 2, D.P. 4826, the north-western boundaries of said Lot 2, Lots 1 and 2, D.P. 17545, Lot 3, D.P. 9135, Section 24, Rangitumau District, crossing a public road and Lot 1, D.P. 9135 to the south-western boundary of Section 237, Rangitumau District in Block I, Mangapakeha Survey District; thence generally south-easterly along that boundary and a right line from the southernmost corner of that section to the northernmost corner of Section 148, Whareama District, along the southern boundary of Lot 4, D.P. 2131 and the north-eastern boundary of Lot 2, D.P. 20290 and its production to the middle of Tauweru River; thence generally north-easterly up the middle of the river to a point in line with the south-western boundary of Section 823, Whareama District; thence generally easterly to and along that boundary and the generally southern boundary of that Section to its eastern boundary; thence generally north-easterly along that boundary and the generally north-western boundary of Lot 1, D.P. 9604, the north-western boundaries of Sections 16, 10, 15 again 10, 14 again 10, 39 again 10 and the north-western boundary of the said Section 10 all of Block XVI, Puketoi Survey District, to the southern side of Tiraumea Road; thence generally northerly along a right line to and along the western boundaries of Sections 13, 9 and 12, the northern boundary of the said Section 12 to and north-easterly along the south-eastern boundaries of Sections 192 and part 193, Whareama District to the south-western corner of Section 14, Block XII, Puketoi Survey District; thence generally easterly along the south-western boundaries of said Section 14 and Sections 15, 22 and 19, Block XII aforesaid to the western boundary of Lot 1, D.P. 13267; thence northerly along that boundary and the western boundary of Section 18, Block XII, Puketoi Survey District and easterly along the northern boundaries of that Section and Section 21, Block XII aforesaid, to the north-eastern corner of the said Section 21; thence generally south-easterly along the eastern boundary of that section to its south-eastern corner and along right lines bearing 190° 46' 8" distance 20.1 metres, 144° 36' 38" distance 534.8 metres and 161° 02' 43" distance 902.8 metres to the northern boundary of Block XVI, Puketoi Survey District; thence easterly along that northern boundary to and down the middle of the Pakowhai River to and generally down the middle of the Mataikona River to the sea coast; thence generally north-easterly along the sea coast to the point of commencement.

The said area being more particularly shown outlined in black on plan numbered NZE 2108 (sheets 1 to 7) deposited in the office of the Electricity Division of the Ministry of Energy at Wellington.

Electric Lines Licence

I, Robert James Tizard, Minister of Energy, acting pursuant to section 21 of the Electricity Act 1968, hereby license the Christchurch City Council hereinafter referred to as "the licensee", to lay, construct, put up, place or use the electric lines described in the Schedule hereto.

This licence is issued subject to the following conditions:

CONDITIONS

1. This licence may be cited as the "Christchurch City Council Electric Lines Licence 1986".
