- 1. This order may be cited as the Lee Pest Destruction District Redefinition of Boundaries Order 1986.
- 2. This order shall come into force on the day after the date of its notification in the New Zealand Gazette.
- 3. The boundaries of the Lee Pest Destruction District which was constituted by Order in Council on the 31st day of August 1960 are hereby altered and redefined and as and from the day on which this order shall come into force, the boundaries of the said district shall be those specified in the Schedule hereto.
