A PROCLAMATION

PURSUANT to section 421 of the Maori Affairs Act 1953, I, the Most Reverend Sir Paul Alfred Reeves, the Governor-General of New Zealand, hereby declare the land described in the Schedule hereto and comprised in a roadway laid out by the Maori Land Court by an order dated 4th June 1982, to be road, and to be vested in The Taumarunui County Council.

PURSUANT to section 15 of the Selwyn Plantation Board Act 1953, I, The Most Reverend Sir Paul Alfred Reeves, the Governor-General of New Zealand, hereby revoke the reservation for plantation purposes over the land described in the Schedule hereto.

PURSUANT to section 8A of the Harbours Act 1950, His Excellency the Governor-General, acting by and with the consent of the Executive Council, hereby amends the Manawatu Catchment Board Waters Control Order 1980\* by:

Inserting the words, "and all the waters of the Waikanae River from its source to the sea", after the words "all the waters of the Makakahi River from its source to its confluence with the Mangatainoka River" in the First Schedule.

The order shall come into force 14 days after its publication in the *New Zealand Gazette*.
