**1. Title and commencement**—(1) This notice may be cited as the Auckland Fire District Notice 1986.

(2) This notice shall come into effect on the 1st day of June 1986.

**2. Auckland Fire District constituted**—The Auckland Fire District constituted a fire district by the Auckland Fire District Notice 1981 is hereby abolished and a fire district to be known as the Auckland Fire District is hereby constituted.

**3. Boundaries of Fire District defined**—The boundaries of the Auckland Fire District constituted by this notice are hereby defined in the Schedule hereto.

**4. Revocation**—The following notice is hereby revoked: *New Zealand Gazette*, 1981, page 1763, The Auckland Fire District Notice 1981.

## SCHEDULE

ALL that area in the North Auckland Land District, in the cities of Auckland, Papakura, Mount Albert and Manukau, the boroughs of New Lynn, Newmarket, Mount Eden, Mount Roskill, Onehunga, One Tree Hill, Ellerslie, Mount Wellington, Otahuhu, and Howick

and the county of Franklin and including all the reclaimed land adjoining those territorial authorities, bounded by a line commencing at the easternmost corner of Lot 21, D.P. 43825, on the left bank of the Whau River in Block III, Titirangi Survey District, and proceeding southerly, then northerly and easterly, generally along the line of mean high water of the Whau River and the Waitemata Harbour, crossing the mouths of creeks, rivers and inlets and including the Auckland Harbour Bridge approaches and the Auckland wharves and continuing along the said line of mean high water to the south-eastern corner of Lot 2, D.P. 42113, in Block III, Orere Survey District; thence westerly along the southern boundary of that Lot 2 and that boundary produced across East Coast Road to the western side of that road; thence north-westerly, generally, along the south-western side of the aforesaid road, Orere Matingarahi Road and Kawakawa Orere Road to the junction of the last-mentioned roadside and the southern boundary of part Orere and Taupo Block shown on D.P. 27557, in Block X, Wairoa Survey District; thence westerly generally along that southern boundary and the southern boundary of part Orere and Taupo Block shown on D.P. 12971, to the eastern boundary of part Mataitai No. 4 Block, in Block IX, Wairoa Survey District; thence southerly along the western boundary of part Kiripaka Block to the south-eastern boundary of Lot 11, Deeds Plan 71 blue; thence south-westerly along that boundary to its intersection with the middle of the Aroaro Stream; thence north-westerly generally up the middle of that stream to its junction with the northern side of Ness Valley Road; thence westerly along that northern side of Ness Valley Road, crossing the intervening Phillip Road, to the eastern boundary of part Mataitai No. 6 Block, comprised in certificate of title 546/156; thence southerly along a right line across Ness Valley Road to and along the western boundaries of Lot 1, D.P. 96565, in Block VIII, Wairoa Survey District, to and easterly, southerly and westerly along the northern, eastern and southern boundaries of Lot 1, D.P. 42119 (now part of Lot 1, D.P. 96565), to and westerly along the southern boundary of part Mataitai No. 6 Block comprised in certificate of title 1504/27 and continuing along the northern boundaries of Lot 2, D.P. 98848 to its northernmost corner; thence southerly and easterly along western and southern boundaries of that Lot 2, to and southerly along the western boundary of Allotment 21, Otau Parish, to and easterly along the northern side of Otau Mountain Road to a point due north of the easternmost corner of Allotment 25, Otau Parish in Block XII, Wairoa Survey District, thence due south along a right line to and westerly along the southern boundary of that Allotment 25 and that boundary produced across McNicol Road and the Wairoa River to a point on the left bank of the said Wairoa River, thence southerly along that left bank to the easternmost corner of Allotment 112A, Hunua Parish; thence westerly along the northern boundary of Allotment 112A and Lots 3 and 1, D.P. 78762 to the eastern side of Highridge Road; thence south-westerly generally along the generally south-eastern side of Highridge Road, crossing the intervening public roads, along a right line across Sky High Road, to and along the generally south-eastern sides of McGregor Road and a public road, forming the north-western boundaries of Allotments NW176, M176 and SW176, to the westernmost corner of the last-mentioned Allotment, all aforesaid Allotments of Hunua Parish; thence north-westerly along a right line, across Jones Road, to the northernmost corner of Allotment 391, Hunua Parish; thence north-easterly along another right line across a public road and continuing northerly along the western side of a public road, to and along the generally southern boundaries of Allotment 390, Hunua Parish and the last boundary produced across a public road to the easternmost corner of Allotment 389, Hunua Parish; thence south-westerly generally along an arc of 8.045 kilometres radius from the easternmost corner of Allotment 206, Section 11, Village of Papakura (Papakura Fire Station) to its intersection with the western boundary of Lot 1, D.P. 19546, in Block VIII, Drury Survey District; thence southerly along a right line to the easternmost corner of Allotment 93, Suburban Section 2, Opaheke Parish, in Block XII, Drury Survey District; thence south-westerly along another right line to a point on the northern boundary of part Allotment 362, Opaheke Parish, due south of the southernmost corner of Ambush Road; thence north-westerly along another right line to a point due west of the northernmost corner of part Allotment 172, Karaka Parish, on the northern side of State Highway No. 22, in Block VII, Drury Survey District; thence due north along another right line to its intersection (being in part Allotment 233, Karaka Parish) with an arc of 8.045 kilometres radius from the easternmost corner of Allotment 206, Section 11, Village of Papakura (Papakura Fire Station); thence north-westerly along that arc, crossing the Whangamaire Creek to its junction with the line of mean high water of the Manukau Harbour in Block XIII, Otahuhu Survey District; thence easterly and northerly generally, along the line of mean high water of the Manukau Harbour and including the Onehunga wharves, to a point in line with the eastern boundary of Allotment 384, Waikomiti Parish, in Block VII, Titirangi Survey District; thence northerly along a right line across Taunton Terrace, to and along the last-mentioned eastern boundary and the southern and eastern boundaries of Allotment 381, Waikomiti Parish, to and westerly along the southern side of Connaught Street to its junction with the eastern side of Portage Road; thence northerly along that eastern side to a point in line
