

with the south-eastern boundary of part Allotment 363, Waikomiti Parish (New Lynn Domain described in *New Zealand Gazette*, 1938, page 1552); thence north-easterly along a right line, to and along the south-eastern boundary of the said part Allotment 363, to and northerly along the eastern boundary of that part Allotment 363, and the last boundary produced, to and easterly along the northern side of Heaphy Street, to and again northerly along the eastern boundary of the said part Allotment 363, to and westerly along the northern boundary of that part Allotment 363 to the left bank of the Avondale Stream; thence south-westerly generally along the said left bank to its intersection with the middle line of Portage Road; thence northerly along the middle of Portage Road, to its intersection with the middle line of Golf Road; thence westerly and south-westerly along the middle of Golf Road to a point in line with the western boundary of Lot 1, D.P. 91822 in Block VII, Titirangi Survey District; thence northerly along a right line, to and along the western boundaries of Lot 1 aforesaid, Lots 1, 2, 3, 4, 5, 6, 7, 8, 48 (access way), 9, 10, part 11, part 13, Lots 14, 15, 16, 17, and 18, D.P. 46801 and Lot 1, D.P. 46392 crossing the intervening Grandison Crescent, along a right line, being the production south-westerly of the south-eastern boundary of Lot 15, D.P. 10738 to the middle line of Arahoe Road; thence northerly along the middle of Arahoe Road to the middle line of Hutchinson Avenue; thence south-westerly along the middle of Hutchinson Avenue, to and northerly along the south-western side of Parker Avenue to the eastern corner of Lot 7, D.P. 40481; thence south-westerly along the south-eastern boundaries of the said Lot 7 and Lot 6, D.P. 40481; thence north-westerly along the south-western boundary of Lot 5, D.P. 60351 and the last boundary produced, to and along the south-western boundaries of Lots 3, 2 and 1, D.P. 60351, and the last boundary produced, to and along the south-western boundaries of Lots 2 and 1, D.P. 57908; thence north-westerly along a right line across West Lynn road to the easternmost corner of Lot 2, D.P. 98774; thence northerly along the eastern boundaries of the said Lot 2, Lot 5, D.P. 39449 and Lot 9, D.P. 23375 (Plantation Reserve) in Block III, Titirangi Survey District; thence south-westerly along a right line across Titirangi Road to the easternmost corner of Allotment 138, Waikomiti Parish; thence north-westerly along the north-eastern boundary of the said Allotment to the easternmost corner of Lot 2, D.P. 48735; thence north-easterly along a right line, to and along the north-western boundary of Lot 1, D.P. 44544 to the northernmost corner of the said Lot 1, along a right line across Croyden Road to its intersection with the alignment of the north-eastern side of Croyden Road and the middle line of Fruitvale Road, along the middle of Fruitvale Road to a point in line with the north-eastern boundary of Lot 3, D.P. 52893; thence north-westerly along a right line, to and along the north-eastern boundaries of Lot 3 aforesaid and Lot 2, D.P. 49084; thence north-easterly along the south-eastern boundaries of Lots 26, 25, 24 and 23, D.P. 20071, and the last boundary produced across Tahī Terrace, to and along the south-eastern boundary of part Lot 22, D.P. 20071 to its easternmost corner; thence along a right line bearing 288° 01' distant 83.17 metres to a point in line with the western boundary of Lot 3, D.P. 76570; thence northerly along a right line, to and along the western boundaries of Lot 3 aforesaid, Lots 2 and 1, D.P. 76570, and the last boundary produced to the middle line of Great North Road; thence easterly along the middle of Great North Road, to and northerly along the middle of Lynwood Road to a point in line with the northern boundary of Allotment 196, Waikomiti Parish; thence westerly along a right line, to and along the northern boundary aforesaid, to and northerly along the eastern boundaries of Allotment 198, Waikomiti Parish, Lot 2, D.P. 31889 and Lot 23, D.P. 47198 and the last boundary produced across Rimu Street, to and along the eastern boundaries of Lots 9, 5 and 4, D.P. 47198, Lot 2, D.P. 62445, Lots 2 and 1, D.P. 47198, Lots 10, 9, 8, 7, 6, 5, 4, and 3, D.P. 43457 and Lot 16, D.P. 43825 and the last boundary produced across Alston Avenue and Lots 21 and 20, D.P. 43825 to the southernmost corner of Lot 11, D.P. 43164, and continuing along the western boundary of Lot 20, D.P. 43825, to and easterly along the northern boundaries of the said Lot 20 and Lot 21, D.P. 43825, to the point of commencement, including Puketutu Island and the Auckland Metropolitan Drainage Works ponding areas; Pollen, Browns, Wiroa, Shark and Motukaraka Islands and all other adjacent islands in adjoining inlets and creeks, but excluding Lot 2, D.P. 50858 and Papatoetoe City as described in *New Zealand Gazette*, 1960, page 1058 and all that area in the North Auckland Land District in the cities of Takapuna, East Coast Bays and Birkenhead, the boroughs of Devonport and Northcote and the country of Rodney bounded by a line commencing at the junction of the line of mean high water of the Okura River and the southern boundary of Lot 8, D.P. 95985, in Block XV, Waiwera Survey District proceeding westerly along the southern boundaries of the said Lot 8, Lot 1, D.P. 95984, part Lot 2, D.P. 95983 and Lot 1, D.P. 100141 and the last boundary produced across East Coast Road, to the easternmost corner of Allotment 87, Okura Parish; thence southerly and westerly along the eastern and southern boundaries of the aforesaid Allotment, and the south-eastern boundary of Lot 2, D.P. 70015, and that boundary produced across Bawden Road, to and north-westerly along north-eastern boundary of Allotment 206, Pukeatua Parish to its northernmost corner; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of Allotment 205 and the south-western

boundary of Allotment 202, to and south-westerly and north-westerly along the south-eastern and south-western boundaries of Allotment 200 and the south-western boundary of Allotment 199, all the aforesaid Allotments being in Pukeatua Parish, to the eastern side of Bawden Road; thence westerly along a right line across Bawden Road to the southernmost corner of Lot 11, D.P. 65853 and continuing north-westerly along the south-western boundaries of Lots 11 and 10, D.P. 65853, and the south-western boundary of part Allotment 198, Pukeatua Parish to the eastern side of Jeffs Road; thence south-westerly along the south-eastern side of Jeffs Road and Lower Jeffs Road to and south-easterly along the north-eastern side of State Highway No. 1 to its junction with the eastern boundary of part Allotment 415, Pukeatua Parish, thence southerly along a right line across State Highway No. 1 to the northernmost corner of Allotment 331, Pukeatua Parish in Block XIV, Waiwera Survey District; thence southerly along the western boundary of the said Allotment 331, to and south-westerly generally along the right bank of Dairy Stream to its junction with the left bank of the Rangitopuni Stream; thence along a bearing of 225° to the right bank of the Rangitopuni Stream, and continuing southerly generally along that right bank to its junction with the left bank of Walsh Creek in Block II, Waitemata Survey District; thence south-westerly generally along that left bank to its intersection with the north-eastern boundary of Allotment 218, Paremoro Parish; thence north-westerly and south-westerly along the north-eastern and north-western boundaries of that Allotment; thence southerly generally along the generally eastern boundary of the Riverhead State Forest being the generally eastern boundaries of Section 38H, a closed road, Sections 40H, 41H, a closed road, Section 43, a closed road, Sections 44H, 45H, a closed road, Sections 52H and 71H, all the aforesaid sections being in Riverhead Homestead Settlement, part Sections 53H and 51H, Riverhead Homestead Settlement, part Allotment 165, Paremoro Parish and part Section 51H, Riverhead Homestead Settlement, part Allotment 69, Paremoro Parish, part Section 51H, Riverhead Homestead Settlement a closed road, Sections 50H, 59H, and 65H, Riverhead Homestead Settlement, to the westernmost corner of part Lot 2, D.P. 56967; thence westerly generally continuing along the generally southern boundary of the Riverhead State Forest being the generally southern boundaries of the last-mentioned Section 65H, Section 64H, a closed road, Sections 63H, 66H, 62H, crossing the intervening Old North Road all the aforesaid sections being in Riverhead Homestead Settlement, part Allotments 160, and 48, a closed road, part Allotments 64 and 61 all the aforesaid Allotments, being in Paremoro Parish and situated in Blocks V, Waitemata and VII, Kumeu Survey Districts, part Section 60H, Riverhead Homestead Settlement and Section 73H, Riverhead Homestead Settlement and the last boundary produced across Old North Road; to the southernmost corner of Lot 3, D.P. 63537; thence westerly along the southern boundaries of the said Lot 3 and Lots 2 and 1, D.P. 63537, to and north-westerly along the south-western boundary of the last-mentioned Lot 1, to its junction with the left bank of the Ararimu Stream; thence westerly and south-westerly along that left bank to its intersection with the southern side of Old North Road; thence westerly along that southern side crossing the intervening Waikoukou Valley Road to the northernmost corner of part Lot 13, D.P. 9170, in Block IV, Kumeu Survey District; thence south-westerly along the north-western boundary of that Lot 13, the north-western boundaries of Lots 2 and 1, D.P. 64861, and the last boundary produced to the western side of Taylor Road, in Block VII, Kumeu Survey District; thence southerly along that western side to the northernmost corner of Lot 13, D.P. 64506; thence westerly along the northern boundaries of Lots 13 and 15, D.P. 64506, and the last boundary produced to the middle of the Whararua Stream; thence southerly generally down the middle of that stream, to and westerly generally down the middle of the Kaipara River to a point in Block VI, Kumeu Survey District, due north of the intersection of the eastern boundary of Pukeatua Block shown on D.P. 2207, and the left bank of the Kaipara River, thence southerly along a right line, to and along the left bank of a tributary of the Kaipara River, across the North Auckland Railway, to and westerly and southerly along the northern and western boundaries of part Pukeatua Block, shown on D.P. 2235, to and south-easterly along the north-eastern side of State Highway No. 16 to the southernmost corner of part Ururua 2B1 Block, shown on ML 13343; thence southerly along a right line across State Highway No. 16, to and along the eastern boundary of part Ururua 2B and the last boundary produced across Lot 11, D.P. 103287, Woodhill Park Road, and Lot 10, D.P. 103287 to the north-eastern boundary of Section 36, Block VI, Kumeu Survey District; thence north-westerly along the north-eastern boundary of the said Section 36, and the last boundary produced to a point on Woodhill Park Road, being a point in line with the south-eastern boundary of part Ururua No. 2 Block (0 acres 2 roods 31 perches); thence south-westerly along a right line to and along the south-eastern boundary of the last-mentioned part Ururua No. 2 Block, and the south-eastern boundary of Ururua 2C2 Block to the westernmost corner of Lot 5, D.P. 103288; thence southerly along the western boundaries of the said Lot 5 and Lot 4, D.P. 103288, to and westerly along the northern boundaries of Lot 3, D.P. 93288, Lots 2 and 1, D.P. 100191, to and south-easterly generally along the generally north-eastern boundaries
