Henderson Fire District Notice 1986

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Henderson Fire District Notice 1986.

(2) This notice shall come into effect on the 1st day of June 1986.

2. Henderson Fire District constituted—The Henderson Fire District declared to be a fire district by the Fire Service Act 1975 is hereby abolished and a fire district to be known as the Henderson Fire District is hereby constituted.

3. Boundaries of Fire District defined—The boundaries of the Henderson Fire District constituted by this notice are hereby defined in the Schedule hereto.

SCHEDULE

ALL that area in the North Auckland Land District, Borough of Henderson, and City of Waitemata, bounded by a line commencing at the westernmost corner of Lot 1, D.P. 42401 in Block XIV, Waitemata Survey District and proceeding south-easterly along the north-eastern boundaries of Lots 6, 31, 32, 33, 34, 35, 36, 37, 38, 43 and 56, D.P. 46606 to the line of mean high water of Huruheru Creek; thence south-westerly generally along that line of mean high water to the easternmost corner of part Lot 3, D.P. 4070; thence south-easterly along a right line to the northernmost corner of Lot 13, D.P. 20991; thence north-easterly generally along the line of mean high water of the right bank of Huruheru Creek and southerly generally along the line of mean high water of Henderson Creek to

the southernmost corner of part Lot 16, D.P. 62437; thence south-easterly along a right line to the intersection of the eastern side of Central Park Drive and the southern line of mean high water of Henderson Creek; thence north-westerly along that south-western roadside to the southern side of Awaroa Road; thence westerly along that southern roadside to the eastern side of Sunhill Road; thence southerly along that eastern roadside to the southern side of Sunnyside Road; thence westerly along that southern roadside to the easternmost corner of Lot 5, D.P. 45245; thence south-westerly along the north-western boundaries of part Allotment 248A and part Allotment 508, Waikomiti Parish, and the production of the last-mentioned boundary to and along the south-eastern boundary of Allotment 98, Waari Hamlet to the right bank of the Waikumete Stream; thence westerly along that right bank to a point in line with the eastern boundary of part Allotment 14, Waikomiti Parish; thence southerly to and along that boundary to its southernmost point; thence westerly generally along the northern side of West Coast Road to the north-eastern side of Parrs Cross Road; thence north-westerly generally along that north-eastern roadside crossing Seymour Road to and along the southern boundary of Lot 15, D.P. 73596 to the right bank of Oratia Stream; thence southerly along that right bank to the southern side of Parrs Cross Road; thence along a right line to a point 50.29 metres distant from, and measured at right angles to, the aforesaid roadside; thence north-westerly along a series of right lines parallel to and 50.29 metres distant from Parrs Cross Road, (road as defined on D.P. 48196) to the south-eastern side of Forest Hill Road, along a right line diagonally across that road to and along the generally south-western boundaries of Lots 28, 24, 23, 22 and 21, D.P. 44540, along a right line to and along the south-western boundaries of Lots 20, 19, 18, 17, 16, 15, 14, 13, 12, 11, 10 and 9, D.P. 44540, along a right line to and along the south-western boundaries of Lots 7, 6, 5 and 4, D.P. 44540, along a right line to and along the south-western boundaries of Lots 3, 2 and 1, D.P. 44540 and along a right line to the southernmost angle in the eastern boundary of Lot 1, D.P. 34656; thence south-westerly, north-westerly and north-easterly along the south-eastern, south-western and north-western boundaries of Lot 1, D.P. 34656 to its northernmost corner; thence northerly along a right line to the southernmost corner of Lot 11, D.P. 44111; thence easterly along the northern side of Henderson Valley Road, to the eastern side of Candia Road; thence northerly generally along the eastern side of Candia Road crossing Sturges Road to the southern side of Simpson Road; thence northerly generally along that southern roadside crossing all intervening roads to a point on the production of the south-eastern boundary of Lot 1, D.P. 41584; thence south-westerly along that production to the western side of Simpson Road; thence northerly along that western roadside to the south-eastern corner of Lot 2, D.P. 102056; thence westerly along the northern boundaries of Lots 40 and 54, D.P. 22288 to the eastern side of Candia Road; thence northerly along the eastern side of Candia Road to a point in line with the southern boundary of part Allotment 200, Waipareira Parish; thence westerly to and along that southern boundary and northerly along the western boundary of the said Allotment 200 to its westernmost corner; thence westerly along the southern boundary of Allotment 192, Waipareira Parish to its southernmost corner; thence northerly along the eastern side of O'Neills Road to a point in line with the southern boundary of part Lot 5, D.P. 14646; thence westerly to and along that boundary and along the southern boundary of Lot 4, D.P. 95461 for a distance of 480 metres; thence along a right line bearing 9° for a distance of 300 metres; thence along a right line bearing 277° to the eastern side of Christian Road; thence northerly along the eastern side of Christian Road and Tram Valley Road to the northernmost corner of Tram Valley Road; thence westerly along the northernmost side of Tram Valley Road and its production for a distance of 157.8 metres (784.4 links) from that northernmost corner;
