#### *Titirangi Fire District Notice 1986*

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

#### NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Titirangi Fire District Notice 1986.

(2) This notice shall come into effect on the 1st day of June 1986.

**2. Titirangi Fire District constituted**—The Titirangi Fire District declared to be a fire district by the Fire Service Act 1975 is hereby abolished and a fire district to be known as the Titirangi Fire District is hereby constituted.

**3. Boundaries of Fire District defined**—The boundaries of the Titirangi Fire District constituted by this notice are hereby defined in the Schedule hereto.

#### SCHEDULE

thence south-westerly along that right line to the westernmost corner of Lot 1, D.P. 46392; thence southerly along the western boundaries of that Lot 1, Lots 18, 17, 16, 15, 14 and part Lot 13, D.P. 46801, the production of the last-mentioned boundary to and along the western boundaries of part Lot 11 and Lots 10, 9, 48, 8, 7, 6, 5, 4, 3, 2 and 1, D.P. 46801 and Lot 1, D.P. 91822 and the production of the last-mentioned boundary of the middle of Golf Road; thence southerly to and along that western boundary and the eastern boundary of part Allotment 363, Waikomiti Parish to the northern side of Kinross Street in Block VII, Titirangi Survey District; thence westerly along that northern roadside to the eastern side of Portage Road; thence southerly along that eastern roadside to the southern side of Connaught Street; thence easterly along that southern roadside to the eastern boundary of Allotment 381, Waikomiti Parish; thence southerly and westerly along the eastern and southern boundaries of that Allotment 381 to and southerly along the eastern boundary of Allotment 384, Waikomiti Parish and the last boundary produced to the line of mean high water of the Manukau Harbour;
