A PROCLAMATION

PURSUANT to section 63B (1) of the Forests Act 1949 (as substituted by section 19 of the Forests Amendment Act 1976), I, The Most Reverend Sir Paul Alfred Reeves, the Governor-General of New Zealand, hereby set apart the State forest land described in the Schedule hereto as State forest park which shall hereby form part of the Whakarewarewa State Forest Park.

SOUTH AUCKLAND LAND DISTRICT—ROTORUA DISTRICT

598 square metres, being part Section 6, Block I, Tarawera Survey District; as shown marked "M", "N" and "O" on S.O. Plan 51529. Part *New Zealand Gazette*, 1191, page 701.

313 square metres, being part Section 6 and part Section 4, Block I, Tarawera Survey District; as shown marked "P" on S.O. Plan 51529. Part *New Zealand Gazette*, 1898, page 1457 and 1911, page 701.

7435 square metres, being part Section 4, Block I, Tarawera Survey District; as shown marked "Q" and "R" on S.O. Plan 51529 and "S" on S.O. Plan 51527. Part *New Zealand Gazette*, 1898, page 1457.

A PROCLAMATION

PURSUANT to subsection (6) of section 5 of the Education Lands Act 1949, I, The Most Reverend Sir Paul Alfred Reeves, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto, being an area vested

in the Canterbury Education Board as a site for a school, shall be vested in Her Majesty the Queen, freed and discharged from every educational trust affecting the same, but subject to all leases, encumbrances, liens, or easements affecting the same at the date hereof.
