PURSUANT to section 422 of the Maori Affairs Act 1953, I, The Most Reverend Sir Paul Reeves, the Governor-General of New Zealand, hereby declare the land described in the Schedule hereto and used as a roadway, to be road, and to be vested in The Dunedin City Council.

**1. Title and commencement**—(1) This notice may be cited as the High Court Registry (Tauranga) Notice 1987.
