

TARIFF INDUSTRY ASSISTANCE (DECISION) NOTICE NO. 1987/26
Decisions of the Minister of Customs in respect of Part I and Part II of the Customs Tariff

- 1 Notice is hereby given that the following decisions have been made in respect of the goods published in the Schedules to this notice.
2 SCHEDULE 2 - Decisions cancelled. The cancellations listed in this schedule take effect seven days from *Gazette* date unless otherwise specified, eg, WEF (date).
3 SCHEDULE 3 - Limited Decisions
