

*Declaring Land to be Road and Road Stopped in Blocks X and XIV, Wharepapa Survey District, Otorohanga District*

PURSUANT to Part VIII of the Public Works Act 1981, the Minister of Works and Development:

- (a) Pursuant to section 114, declares the land described in the First Schedule hereto to be road and vested in The Otorohanga District Council.
- (b) Pursuant to sections 116 and 117, declares the portions of road described in the Second Schedule hereto to be stopped and added to the adjoining Ngaroma Scenic Reserve, being land held as a reserve for scenic purposes under and by virtue of a notice published in the *New Zealand Gazette*, 1980, page 1345 (S.O.
