*Land Declared to be Road, Road Stopped and Land Taken in Blocks II, V and VI, Alexandra Survey District, Raglan County*

PURSUANT to Part VIII of the Public Works Act 1981, the Minister of Works and Development:

- (a) Pursuant to section 114, declares the land described in the First Schedule hereto to be road which, pursuant to section 11(1A) of the National Roads Act 1953, shall form part of State Highway No. 23.
- (b) Pursuant to sections 116 and 117, declares the areas of road described in the Second Schedule hereto to be stopped and added to the adjoining Four Brothers Scenic Reserve being land held as a reserve for scenic purposes under and by virtue of a notice published in *New Zealand Gazette*, 1973, page 563 (S.O. Plan 45241).
