A PROCLAMATION

PURSUANT to section 63B (1) of the Forests Act 1949 (as substituted by section 19 of the Forests Amendment Act 1976), I, The Most Reverend Sir Paul Alfred Reeves, the Governor-General of New Zealand, hereby set apart the State forest land described in the Schedule hereto as State forest park which shall hereby form part of the Ruahine State Forest Park.

PURSUANT to section 63B (2) of the Forests Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby declares that the area of State forest land described in the Schedule hereto, having been set apart as part of the Coromandel State Forest Park by a Proclamation dated the 5th day of August 1977 and published in the *New Zealand Gazette*, of 11 August 1977, page 2186, hereby ceases to be part of Coromandel State Forest Park, as from the date of publication hereof.
