

situated in, Block VIII, Rangiora Survey District, and proceeding southerly along that mean high-water mark to the middle of the Waimakariri River; thence north-westerly generally up the middle of that river and the middle of the Kaiapoi River to a point on the production of a line parallel to and 50.29 metres east of the eastern side of Commercial Street; thence northerly along that line to a point in line with the northern side of Cass Street; thence westerly along a right line to the intersection of that roadside with the eastern boundary of the Feldwicks Drain, part R.S. 320; thence northerly along that boundary and its production to the middle of Beach Road; thence westerly along the middle of that road to a point in line with the eastern boundary of Lot 2, D.P. 18101; thence northerly to and along that boundary and westerly along the northern boundary of that lot to a point 50.29 metres east of the eastern side of Williams Street; thence northerly along a line parallel to and 50.29 metres east of that roadside to the southern boundary of part R.S. 1260 comprised in certificate of title 177/100; thence easterly along that boundary and northerly along the eastern boundary of the land in that certificate of title to the southern boundary of Lot 2, D.P. 47497; thence easterly along that boundary to a western boundary of part Lot 3, D.P. 17065 comprised in certificate of title 730/2; thence northerly along that boundary and the western boundary of Lot 1, D.P. 4532 to the north-eastern corner of Lot 1, D.P. 19186; thence westerly along the northern boundary of that lot and its production to a line parallel to, and 10.06 metres east of the western side of Main North Road; thence northerly along that parallel line to a point in line with the southern boundary of R.S. 1295; thence westerly to and along that boundary to the eastern boundary of Section 200, Maori Reserve 873; thence generally southerly along that boundary and westerly along the southern boundary of that section of the Old Main North Road; thence westerly along a right line across the Old Main North Road to the southernmost corner of Section 201A, Maori Reserve 873; thence north-westerly along the south-western boundary of that section to the left bank of the Cam River; thence generally south-westerly along that bank to a point in line with the middle of Cam Road; thence westerly to and along the middle of that road to the middle of Revells Road; thence southerly along the production of the middle line of Revells Road to the north-eastern boundary of R.S. 41554; thence south-easterly along the last-mentioned boundary and the north-eastern boundary of Lot 54, D.P. 576, south-westerly along the north-western boundary of Lot 55, D.P. 576, to the northern bank of the Kaiapoi River; thence north-westerly along that bank to a point in line with the original middle line of Revells Road; thence southerly along the production of that middle line to the middle of the Kaiapoi River; thence westerly up the middle of that river to a point in line with the middle of Main Drain Road; thence north-westerly to and along the middle of that road, Boundary Road and Oxford Road (State Highway 72), to a point in line with the eastern side of Kennedys Hill Road, being the western boundary of Lot 10, D.P. 3396; thence southerly along the production of that roadside to a point in line with the northern side of Springbank Road, being the southern boundary of R.S. 4425; thence westerly to and along that roadside to the eastern boundary of Lot 17, D.P. 33937; thence southerly along that boundary and its production to the middle of Woodfields Road; thence generally north-westerly along the middle of that road and Tram Road to the middle of North Eyre Road; thence north-westerly along the middle of that road and its production to a point in line with the original northern side of Oxford Road (State Highway 72); thence easterly along that original roadside to the eastern boundary of R.S. 4214; thence northerly along that boundary to a fence, as shown on Red Map 60 held in the office of the Chief Surveyor, Christchurch; thence generally easterly along that fence to a point in line with the middle of the road forming the eastern boundary of Reserve 713; thence northerly to and along the middle of that road to a point in line with the northern boundary of Reserve 713; thence westerly to and along that boundary to the eastern boundary of R.S. 10176; thence northerly along that boundary and along the eastern boundary of R.S. 11124 and its production to the middle of Glews Road; thence generally westerly along the middle of that road to the middle of Bennetts Road; thence generally northerly along the middle of that road, Carleton Road and Bowicks Road to the right bank of the Ashley River; thence due north along a right line to the middle of that river; thence generally easterly down the middle of that river to the point of commencement.

## NOTICE

1. This notice may be cited as the North Taranaki District Boundary Definition Notice 1987.

2. The boundaries of North Taranaki District are hereby defined as set out in the Schedules hereto, those boundaries having been altered by Order in Council published in the *New Zealand Gazette*, 7 August 1986, No. 123, page 3311 and which came into force on 1 October 1986.

## SCHEDULE

### BOUNDARIES OF NORTH TARANAKI DISTRICT

ALL that area in the Taranaki Land District, bounded by a line commencing at a point on the mean high water mark of the Tasman Sea being the northern corner of Section 26, Block IV, Cape Survey District, and proceeding south-easterly along the north-eastern boundary of the said Section 26, to the northern side of Coast Road; thence south-easterly along a right line to and along the middle of Puniho Road to a point where the end of that road abuts the Egmont National Park; thence south-easterly along a right line to the summit of Mount Taranaki or Mount Egmont; thence north-easterly along a right line to the source of the Waiwakaiho River; thence northerly generally down the middle of that river to a point in line with the southern boundary of part Araheke M4; thence easterly to and along that boundary, the southern boundary of Araheke M4B, to and across Kaipoi Road, to and again easterly along the southern boundary of Araheke M3 and its production to the middle of the Araheke Stream; thence southerly up the middle of that stream to a point in line with the northern boundary of the northern part Section 47, Hua and Waiwakaiho Hundred; thence easterly to and along that boundary and its production to the eastern side of Egmont Road; thence southerly along the eastern side of that road to the northern boundary of Section 46, Hua and Waiwakaiho Hundred; thence easterly along that boundary to the left bank of the Mangaoraka Stream; thence southerly along that left bank to a point in line with the northern boundary of Section 28, Tarurutangi District; thence easterly along a right line to and along that boundary to and across Upland Road, to and again easterly along the northern boundary of Section 33, Tarurutangi District, to and southerly along the eastern boundary of the said Section 33 to the northern boundary of Section 42, Tarurutangi District; thence easterly along that boundary to the western side of King Road; thence northerly along that road to a point in line with the northern boundary of Section 49, Tarurutangi District; thence easterly along a right line to and along that boundary and northerly and easterly along the western and northern boundaries of Section 53, Tarurutangi District and the last-mentioned boundary produced to the eastern side of Hursthouse Road; thence southerly along the eastern side of that road to the northern boundary of Section 54, Tarurutangi District; thence easterly along that boundary, the northern boundary of part Section 200, Huirangi District, (crossing Lepper Road) and its production across Mountain Road (No. 3A State Highway) and the Marton - New Plymouth Railway to the right bank of the Waiongana Stream; thence northerly generally along that bank to the north-western boundary of Section 98, Huirangi District; thence north-easterly along that boundary and its production to the eastern side of Wortley Road; thence northerly along the eastern side of that road to and north-easterly along the north-western boundary of Section 111, Huirangi District, to the south-western boundary of Section 121, Huirangi District; thence south-easterly along that boundary to and north-easterly along the south-eastern boundary of the said Section 121 and its production to the eastern side of Richmond Road; thence northerly along the eastern side of that road to the southern boundary of Section 128, Huirangi District; thence easterly along that boundary to and southerly along the western boundaries of the former Sections 137, 136, 135 and 134, Huirangi District (D.P. 4840), to the northern boundary of part Section 1, D.P. 5879; thence easterly along that boundary and northerly generally along the western boundaries of Sections 23 and 22, Block XIII, Waitara Survey District, to the north-western boundary of the said Section 22; thence north-easterly along that boundary to and north-westerly along the north-eastern boundaries of part Section 145 and Section 144, Huirangi District, to the south-eastern boundary of Section 152, Huirangi District; thence north-easterly along that boundary and the south-eastern boundary of Section 153, Huirangi District, and its production to the middle of York Road; thence southerly along the middle of that road to a point in line with the southern boundary of Lot 1, D.P. 12532; thence easterly to and along that boundary and its production to the middle of Clarke Road; thence southerly along the middle of that road and south-easterly along the middle of Roddy Road to a point in line with the south-western boundary of Section 167, Huirangi District; thence south-easterly to and along that boundary and its production to the middle of the Mangapotoa Stream; thence north-easterly generally down the middle of that stream to and northerly generally down the middle of the Manganui River to its confluence with the Waitara River; thence northerly generally down the middle of that river to a point due west of the northernmost corner of Section 95, Waitara East District; thence easterly to that corner and easterly generally along the northern boundary of the said Section 95 and the southern boundary of
