THE SECRETARY OF ENERGY

1. I have decided that certain information sought by Balcairn Mining Investments Ltd. and solicitors Graham & Company from the Ministry of Energy, namely, all relevant reports or information relating to the investigation of the Rotokawa Geothermal Field, including the report compiled by M. A. Mongillo in 1985 and RK.4 Well Testing and Completion Reports (Ministry of Works and Development, 1985), should not be made available to Balcairn Mining Investments Ltd. and Graham & Company notwithstanding the Chief Ombudsman's recommendation to that effect under section 30(1) of the Official Information Act 1982 (the "Act"), and accordingly, pursuant to section 32(1)(a) of the Act, I hereby direct you not to release such information.

2. The grounds for the direction are:

- (a) That the release of the information could reasonably be expected to prejudice significantly the competitive commercial activities of the Gas and Geothermal Trading Group of the Ministry of Energy.
- (b) That the release of the information could reasonably be expected to interfere significantly with negotiations related to the competitive commercial activities of the Gas and Geothermal Trading Group.
- (c) That the withholding of the information is necessary to enable the Gas and Geothermal Trading Group to carry out, without prejudice or disadvantage, its commercial activities and the withholding of the information is not outweighed by other considerations which render it desirable, in the public interest, to make that information available.

3. The advice on which this direction is based has been received from the Secretary of Energy. The purport of the advice is as set out above.

Order for Confiscation of a Motor Vehicle
