A PROCLAMATION

PURSUANT to section 26 of the Public Works Act 1981, I, The Most Reverend Sir Paul Alfred Reeves, the Governor-General of New Zealand, declare the land described in the Schedule hereto to be taken for the generation of electricity and further declare that the land shall vest in the Crown on the 14th day after the date of the publication of this proclamation in the *New Zealand Gazette*.
