The Traffic (Woodville District) Notice No. 1, 1987

PURSUANT to the Transport Act 1962, a delegation from the Minister of Transport, and a subdelegation from the Secretary for Transport, I, Carne Maurice Clissold, Chief Traffic Engineer, give the following notice:

NOTICE

THIS notice may be cited as the Traffic (Woodville District) Notice No. 1, 1987.

The roads specified in the First Schedule are declared to be closely populated localities for the purposes of section 52 of the Transport Act 1962.

The road specified in the Second Schedule is declared to be a 70 kilometres an hour speed limit area pursuant to regulation 21 (2) of the Traffic Regulations 1976.

The Traffic (Woodville Borough) Notice No. 1, 1978, dated the 14th day of September 1978*, issued pursuant to section 52 of the Transport Act 1962, and regulation 21 (2) of the Traffic Regulations 1976 is revoked.

FIRST SCHEDULE

SITUATED within Woodville District at Woodville Riding:

All roads within Woodville Riding with the exception of:

No. 2 State Highway (Pokeno - Wellington via Gisborne): from a point 50 metres measured easterly, generally, along the said State highway from Burgoyne Street to the eastern boundary of Woodville Riding.

No. 3 State Highway (Hamilton - Woodville via New Plymouth): from Gordon Street to the western boundary of Woodville Riding.

SECOND SCHEDULE

SITUATED within Woodville District at Woodville Riding:

No. 2 State Highway (Pokeno - Wellington via Gisborne): from a point 50 metres measured easterly, generally, along the said State highway from Burgoyne Street to a point 200 metres measured easterly, generally, along the said State highway from Gladstone Street.
