

DPS 20016, Lots 85 and 84, DPS 20018, and Lots 83 and 82, DPS 20017, to the southern corner of the last-mentioned lot; thence north-westerly and westerly along the north-eastern and northern boundaries of parts Ngatiwhakaue Amalgamated Block and the last mentioned boundary produced across Utuhina Road, to and north-westerly along the northern boundary of part Tihiotonga A and north-easterly along the south eastern boundary of the said Block and its production to the middle of the Utuhina Stream; thence generally north-easterly down the middle of that stream to a point in line with the south-western boundary of part Kaitao Rotohokahoka 3D; thence north-westerly to and along that boundary, produced across Great West Road, to the westernmost corner of the said part 3D, along a right line to the southern corner of Lot 10, DPS 3153, along the south-western boundaries of that lot and Lots 11, 20, 12, 13, and 14, DPS 3153, and its production to and along the south-western boundaries of Lots 15 and 16, DPS 3153 and Lots 1 and 2 DPS 40636, to the south-western corner of the said Lot 2; thence north-westerly along a right line bearing 308°08' to a point in line with the middle of Malfroy Road west; thence north-easterly along a right line to the middle of Pukehang Road; thence generally north-westerly along the middle of Pukehang Road and Paradise Valley Road to a point in line with the north-western boundary of Lot 1, DP 31483; thence generally north-easterly to and along that boundary, the western and northern boundaries of Lot 1, DPS 7516, the northern boundaries of Lots 5 and 4, DPS 8697, the western boundaries of Lot 3 DPS 38833 and Lots 1 and 2, DPS 12759, the northern boundaries of the said Lot 2, the north-western boundaries of Lots 1, 2, 3 and 4 DPS 34317, and Lot 4 DPS 12759 to the northernmost boundary of the said Lot 4, and its production to the middle of Mountain Road; thence generally north-easterly along the middle of that road to a point in line with the south-western boundary of Part Rotohokahoka D North 4D; thence generally north-easterly to and along that boundary and the south-eastern boundary of the said block and the last-mentioned boundary produced to the middle of SH 5; thence north-westerly along the middle of that State Highway to a point in line with the south-eastern boundary of part Kawaha 3L1 situated in Block XVI, Rotorua Survey District; thence north-easterly to and along that boundary and its production across the Rotorua Branch Railway to the middle of Parawai Road; thence south-easterly along the middle of that road to a point in line with the south-eastern boundary of Kawaha 3H2; thence north-easterly to and along that boundary and the south-eastern boundary of Kawaha 3G to the point of commencement.

EAST CAPE

All that area bounded by a line commencing at a point on the sea coast being the easternmost corner of Kaiaua 1 situated in Block IV, Uawa Survey District and proceeding southerly along the eastern boundary of Kaiaua 1; thence westerly generally along the southern boundary of the said Kaiaua 1, across Kaiaua Road, to and along the aforementioned boundary to the south-western boundary of Kaiaua 1, along the eastern, southern, and western boundaries of Kopuatarakihi 1A to the easternmost corner of Kopuatarakihi 1B4, along the southern and western boundaries of the said Kopuatarakihi 1B4, westerly along the southern boundaries of Anaura C, and part Anaura E across SH 35, to and along the southern boundary of Lot 4 DP 6297 and its production to the middle of the Hikuwai River; thence north-westerly generally up the middle of that river to a point in line with the north-western boundary of Lot 1, DP 3154, and the abutment of land reserved from sale to and along that boundary, along the south-western boundaries of Tauwhareparae 1F and Section 7, Block XIV, Tokomaru Survey District, along the western boundary of the aforementioned Section 7, to a point due east of Trig Station 171, Puakato, in Block XIII, Tokomaru Survey District, along a right line to the said trig station, along the southern boundary of Lot 18, DP 3426, crossing a public road, to and along the western boundary of the said Lot 18, across a public road to and again along the aforementioned western boundary and the south-western boundary of Lot 14, DP 3393 for a distance of approximately 100 metres; thence easterly and north-westerly generally, along several right lines bearing 74°30' distance 905.26 metres, bearing 9°30' distance 1327.71 metres, bearing 273° distance 1508.76 metres, bearing 315° distance 321.87 metres, bearing 298°30' distance 2373.78 metres, bearing 267° distance 452.63 metres, bearing 258° distance 905.26 metres, bearing 20°29' distance 3419.86 metres to the northernmost corner of Lot 14, DP 3393 being a point on the south-western boundary of Tauwhareparae 2B, along that boundary and its production to the middle of the Mangamaunu Stream, down the middle of that stream to and up the middle of the Mata River to a point in line with the north-western boundary of Lot 1, DP 2227 in Block VI, Tutamoe Survey District; thence southerly to and along that north-western boundary, the north-western boundary of Lot 3, DP 2228 and its production to the middle of Tarnedale Road, along the middle of that road, to a point in line with the eastern boundary of Section 2, Block IX, Tutamoe Survey District, to and along that boundary, the eastern boundaries of Section 3, Block IX, Tutamoe Survey District, Lot 1, DP 5736, to and along the north-eastern and eastern boundaries of Lot 1, DP 6941 and the production of the last-mentioned boundary to the middle of the Mangatuamaru Stream, down the

middle of that stream to a point in line with the north-western boundary of Section 2, Block II, Waingaromia Survey District, to and along that boundary, the north-western and south-western boundaries of Section 3, Block II, Waingaromia Survey District, along the south-western boundary of Section 2, Block II, Waingaromia Survey District and its production to the middle of the Waingaromia River, down the middle of that river to a point in line with the north-eastern boundary of part Lot 3, DP 1696, to and along that boundary and its production to the middle of the Kanakanaia Road; thence north-easterly generally, along the middle of that road to its junction with the Waimata-Hokoroa Road; thence southerly generally along the middle of that road to a point in line with the generally eastern boundary of Section 8, Block VIII, Waingaromia Survey District, to and along that boundary, the south-western boundary of the said Section 8, along the south-western boundary of Section 6 and Section 10, Block VIII, Waingaromia Survey District, across the Waimata-Hokoroa Road to and along the south-western boundary of part Section 3, Block VII, Waingaromia Survey District to the eastern corner of Section 3, Block XI, Waingaromia Survey District, along the south-eastern boundaries of that section and part Section 1, Block XI, Waingaromia Survey District and the production of the last-mentioned boundary to the middle of the Kaitangata Stream, up the middle of that stream to and up the middle of the Hinakiwawahia Stream to a point in line with the southern boundary of Section 5, Block XVI, Waingaromia Survey District, to and along that boundary to the western side of the Waimata-Hokoroa Road, south-easterly along that roadside to and along the southern boundary of Section 5, Block XV, Waingaromia Survey District, along the eastern boundaries of Lots 3, 4 and 6, DP 6573, to the south-eastern corner of Lot 6, DP 6573; thence westerly generally, along the southern boundary of the said Lot 6, the south-western boundaries of that lot and Lot 5, DP 6573 to the easternmost corner of part Section 1, Block XIV, Waingaromia Survey District, along the south-eastern boundary of that part section, the southern and south-western boundaries of Papakorokoro 10 and along the southern boundary of Papakorokoro 9A, to the eastern boundary of Mangaoae 2B, southerly generally, along the eastern boundaries of Mangaoae 2B, Mangaoae 2C, part Mangaoae 2A6, and the production of the last-mentioned boundary to the middle of the Mangaoae Stream, down the middle of that stream to a point in line with the western boundary of Papakorokoro 3, to and along that boundary, the north-western boundary of part Lot 1, DP 2175 and its production to the middle of the Mangaruaki Stream, down the middle of that stream to a point in line with the eastern boundary of Ahirau 2F, to the along that boundary and the southern boundary of Ahirau 1A and its production to the middle of the Mangataikehu Stream, down the middle of that stream, to and up the middle of the Waipoa River, the middle of the Waikohu River, and up the middle of the Wharekopae River to a point due north of the north-western corner of part Waikohu Block, along a right line to that north-western corner, north-westerly along the north-eastern boundary of part Okahuatiu 1C, along the abutment of a public road again along the north-eastern boundary of part Okahuatiu 1C and Section 3, Block I, Waikohu Survey District to the easternmost corner of Section 26, Block I, Waikohu Survey District, along the southern boundary of that section, to a point in line with the eastern boundary of Lot 1, DP 3117, across Hihiroroa Road to and along that boundary, the southern and western boundaries of that lot along the north-western boundary of part Section 27, Block I, Waikohu Survey District, to the north-eastern boundary of Section 81, Block I, Waikohu Survey District, along that boundary, the eastern, southern, and western boundaries of Lot 1, DP 2248 to the southern boundary of Section 81, Block I, Waikohu Survey District, westerly along that boundary and its production to the middle of the Hihiroroa Stream, up the middle of that stream to a point in line with the southern boundary of part Wharekopae 2A, to and along that boundary and the south-western boundary of part Wharekopae 2A, along the south-eastern boundary of Section 2 of 3, Block VII, Ngatapa Survey District and its production to the middle of the Makaretu Stream, down the middle of that stream and up the middle of the Ngatapa Stream to a point in line with the southern boundary of Section 6, Block VII, Ngatapa Survey District, to and along that boundary, the southern boundaries of Lot 2, DP 4650 and part Section 5, Block VII, Ngatapa Survey District, and the production of the last-mentioned boundary to the middle of a public road, northerly generally along the middle of that road and Smart Road to a point in line with the eastern boundary of Section 2, Block VI, Ngatapa Survey District, to and along that boundary and the southern boundaries of the said Section 2, Sections 5 and 6 of the said Block VI, along the south-western boundaries of Sections 6 and 8, Block VI, Ngatapa Survey District, along the western boundary of Section 12, Block II, Ngatapa Survey District and the production of that boundary to the middle of the Rakauraoa-Tahora Road, along the middle of that road to a point in line with the south-eastern boundary of Section 2, Block IV, Koranga Survey District, to and along that boundary, the southeastern boundaries of Section 4 and Section 5 of the said Block IV and Section 1, Block VIII, Koranga Survey District to the north-eastern boundary of part Tahora 2C3 Section 1, southerly
