

along that boundary and along the southern boundary of that section to its westernmost corner, along a right line to Trig Station Te Wana, being a point on the watershed between the Waioka and Wairoa Rivers, along that watershed to and along the south-eastern watershed of the Tauranga and Waimana Rivers, to a point due east of the intersection of the middle of Mangatoatoa Stream with a right line, produced north-easterly from Trig Station 2128, Whakatakoa, situated in Block I, Waikaremoana West Survey District, through Trig Station 2126, Maungapohatu, situated in Block XII, Ruatahuna Survey District along a right line to that intersection; thence north-westerly along right lines to Trig Station Pawairoto, situated in Block III, Ruatahuna Survey District and Trig Station 2163, Te Rangaaranuku, situated in Block XIV, Urewera Survey District, and the north-eastern corner of Section 1, Block II, Ahikereru Survey District; thence northerly along right lines to Trig Station 2121 (Hikurangi) in Block VII, Galatea Survey District, and the south-eastern corner of Oputea Block in Block III, Galatea Survey District; thence generally northerly along the generally eastern boundaries of Oputea Block, the south-eastern boundaries of Waiohau Part 1A1D2, B9A and 1A2B Blocks, the southern and eastern boundaries of Tawhia Block, and the generally eastern boundaries of Pukehou, Tapapakiekie, Tukutoroniro, and Mokorua Blocks to the easternmost corner of the said Mokorua Block, situated in Block VIII, Rangitaiki Lower Survey District; thence north-westerly along the north-eastern boundaries of that block and Onapu Block crossing a public road to and north-easterly along the south-western boundaries of Tuararanga Block and part Section 3, Block IV, across a public road and along the south-western boundary of Section 2, Block IV, Rangitaiki Lower Survey District, to the north-eastern corner of the said Section 2; thence westerly along the northern boundaries of that section, part Section 1, Block IV, and Section 4, Block IV, Rangitaiki Lower Survey District, to its north-western corner; thence south-westerly along the north-western boundary of that section to the north-eastern corner of Section 2, Block III, Rangitaiki Lower Survey District; thence westerly along the northern boundaries of that section and part Section 1 of the said Block III to the eastern shore of Lake Matahina; thence northerly along the said shore to a point in line with the northern boundary of part Matahina A1D and westerly to and along the said boundary, crossing the intervening Tahuna Road and Murupara Branch Railway, and along the production of the said northern boundary to Trig Station 16, Putauaki; thence westerly along a right line to a point at the intersection of the middle of the Tarawera River and the western boundary of Block XIII Rangitaiki Upper Survey District; thence westerly up the middle of the Tarawera River to a point in line with the western boundary of part Kawerau B; thence northerly to and along the said boundary to and westerly along the northern boundary of Tarawera I Block, in Block XVI Rotoma Survey District to a peg bearing $189^{\circ}54'30''$, distant 2.53 metres from ISXXXIII, M.L. 19837; thence north-westerly along right lines to Trig C as shown on S.O. 14267 and Trig 7751; thence generally northerly along right lines bearing $273^{\circ}00'$, distant 1560 metres, $337^{\circ}00'$, 600 metres and $35^{\circ}00'$, to the south-eastern boundary of Part Allotment 39A3E, Matata Parish; thence north-easterly along that boundary, a right line crossing Tamarangi Drive, the south-eastern boundary of Part Allotment 39A2B, Matata Parish, and its production to the middle of the Tarawera River; thence north-easterly down the middle of the said river to a point in line with the northern boundary of Lot 2 DPS 2476; thence easterly to and along the said boundary, the southern boundary of Section 36, Block IX Rangitaiki Upper Survey District and the production of the last mentioned boundary to the middle of Kawerau Road; thence north-easterly along the middle of Kawerau Road and SH 30 to a point in line with the eastern boundary of Lot 1 DPS 9041, to and southerly along the said boundary to its south-eastern corner; thence easterly along the production of the southern boundary of the said Lot 1 to the middle of Tahuna Road, northerly along the middle of Tahuna Road, easterly along the middle of SH 30 and northerly along the middle of Western Drain Road to a point in line with the southern boundary of Lot 3 DPS 29595; thence to and along the said southern boundary and the eastern boundary of the said Lot 3 to the northern boundary of Lot 4 DPS 31500, easterly along the northern boundary of the said Lot 4 and generally easterly along the generally northern boundary of Lot 5 DPS 31500 produced to the middle of SH 30; thence north-easterly along the middle of the said Highway to a point in line with the southern boundary of Lot 1 DPS 23061, to and easterly along the said boundary and southern boundaries of part Allotment 11 Rangitaiki Parish, Allotments 11C, 89A, 31P3F, aforesaid, part Lot 4 DP 14700 produced to the middle of a public road adjoining Omataroa Rangitaiki 2; thence southerly along the middle of the said public road to a point in line with the southern boundary of part Allotment 32H1 Rangitaiki Parish, to and easterly along the said boundary and northerly along the eastern boundary to the southern boundary of Allotment 32FB Rangitaiki Parish; thence easterly along the said southern boundary and northerly along the western boundaries of Parts Allotments 32G and 32E5B, westerly along the northern boundary of part Allotment 32E5B and northerly along the western boundary of Allotment 32E5A Rangitaiki Parish to its north-

western corner; thence easterly and northerly along the southern and eastern boundaries of part Allotment 320 Rangitaiki Parish, easterly along the southern boundaries of Lot 3 DP 25530, Allotment 31P3E aforesaid, crossing the intervening Taneaetua Branch Railway and White Pine Bush Road, easterly along the southern boundaries of Lots 4 and 3 DPS 33438 produced to the middle of the Whakatane River; thence generally northerly down the middle of the said River to the mean high water mark of the sea coast; thence generally easterly and generally southerly along that mean high water mark, crossing the mouths of all harbours and inlets, to the point of commencement, including White, Motuhora and other adjacent islands.

All that area bounded by a line commencing at a point on the sea coast being the north-eastern corner of part Takararoa 5231A Block in Block XIII, Paritu Survey District, and proceeding north-westerly generally along the north-eastern boundary of the said part block and across Mahanga Road, again along the said north-eastern boundary and its production to the middle of the Waiou Stream, up the middle of that stream to a point in line with the southern boundary of part Lot 6, DP 1026, to and along that boundary, across the Palmerston North-Gisborne Railway, along the southern and western boundaries of the said part Lot 6 and the south-western boundary of part Lot 1, DP 2315 to the north-eastern boundary of Section 34, Block XI, Nuhaka North Survey District, along that boundary, the south-eastern and south-western boundaries of Section 17, Block XI, Nuhaka North Survey District, across SH 2, to and along the south-western boundary of Section 16, Block XI Nuhaka North Survey District, to the westernmost corner of that section, along the generally western boundary of the said Section 16, to the intersection of Maraetaha and Tarewa-Tokonui Roads, along the eastern end of Maraetaha Road to and along the generally western side of the Tarewa-Tokonui Road and along the production of the last right lined roadside south of the Nuhaka River to the middle of that river, down the middle of that river to a point in line with the south-western boundary of part Section 3, Block X, Nuhaka North Survey District to and along that boundary, the south-eastern boundaries of part Section 2, Block VI, Nuhaka North Survey District, and Lot 1, DP 16751 (Hawke's Bay Registry) to the southernmost corner of that lot, along the western boundary of Lot 1 aforesaid, to the north-eastern corner of Nuhaka 2B2A1, along the generally northern boundary of Nuhaka 2B2A1 to the eastern boundary of Section 9, Block V, Nuhaka North Survey District, southerly along that boundary to the northern side of Mangapahi Road, along that roadside to the south-western corner of Section 2, Block V, Nuhaka North Survey District; thence northerly along the western boundary of the said Section 2, the western and northern boundaries of Section 6, Block V, Nuhaka North Survey District, along the western boundary of part Mangapoike B, across the Waingake-Mangapoike (Paparatu) Road and along the production of that western boundary to the middle of the Mangapoike River; thence north-westerly generally down the middle of that river to its confluence with the Mangarangi Stream, up the middle of that stream to a point in line with the south-eastern boundary of part Mangapoike 2D, to and along that boundary to Trig Station F4 in Block VIII, Opoiti Survey District, northerly along a right line to Trig Station K in Block III, Opoiti Survey District, along the south-eastern, western, and generally southern boundaries of part Lot 1, DP 1381, to its westernmost corner, northerly along the western boundary of the said part Lot 1, across SH 36, and along the production of that western boundary to the middle of the Hangaroa River, up the middle of that river to a point in line with the southern boundary of part Tauwharetoi 3A in Block XIV, Hangaroa Survey District, to and along that boundary to the south-western corner of the said part Tauwharetoi 3A, along the eastern boundaries of Tauwharetoi 3B1A, the eastern boundary of Section 11, Block IX, Hangaroa Survey District, across a public road to and along the western boundary of part Section 2, Block X, Hangaroa Survey District, westerly along the southern and western boundaries of Section 3, Block V, Hangaroa Survey District, along the south-western boundary of Section 1A, Block V, Hangaroa Survey District and the production of the last-mentioned boundary to the middle of Bushy Knoll Road, south-westerly along the middle of that road to a point in line with the south-eastern boundary of Section 1, Block VIII, Tuahu Survey District, to and along that boundary, the south-eastern boundary of part Lot 20, DP 1950, and the production of the last-mentioned boundary to the middle of the Ohinetawai Stream, down the middle of that stream and down the middle of the Kawaimanga Stream to the middle of the Hangaroa River, up the middle of the Hangaroa River to a point in line with the western boundary of Section 13, Block XIII, Ngatapa Survey District, westerly along a right line to Trig Station F in Block IV, Tuahu Survey District, being a point on the north-eastern boundary of part Lot 20, DP 1950, along the north-eastern boundaries of the said part Lot 20 and Lot 19, DP 1950, to and along the northern boundary of the last-mentioned lot, the northern boundaries of part Lots 24 and 23, DP 1952, along the north-eastern boundaries of part Lot 18, DP 1970 and Section 2, Block XV, Koranga Survey District, southerly along the western boundaries of that section and the aforementioned part Lot 18, across
