

Papuni Road and again along the western boundary of the aforementioned part Lot 18 to its intersection in Block II, Tuahu Survey District, with a right line between Trig Station Puketapu in Block VII, Tuahu Survey District, and Trig Station 2126, Maungapohatu, in Block XII, Ruatahuna Survey District, along that right line to the said Trig Station 2126, Maungapohatu, being a point on the south-eastern watershed of the Tauranga and Waimana Rivers; thence north-easterly generally, along that watershed and the watershed between the Waioeka and Wairoa Rivers to Trig Station Te Wana; thence easterly generally, along a right line from Trig Station Te Wana to the westernmost corner of part Tahora 2C3 Section 1, along the southern and northeastern boundaries of that section to the westernmost corner of Section 21, Block VIII, Koranga Survey District; along the northwestern boundaries of the said Section 21 and Section 7, Block V, Ngatapa Survey District, Section 7, Block I, Ngatapa Survey District, and the production of the last-mentioned boundary to the middle of the Rakauroa-Tahora Road, along the middle of that road to a point in line with the eastern boundary of part Lot 1, DP 2127, to and along that boundary and the eastern boundaries of part Lot 8, DP 1820 and Section 1, Block V, Ngatapa Survey District to the southern corner of Section 6, Block VI, Ngatapa Survey District, along the southern boundaries of that section and section 5 of the aforementioned Block VI, along the southern and eastern boundaries of Section 2, Block VI, Ngatapa Survey District and the production of the last-mentioned boundary to the middle of Smart Road, southerly generally, along the middle of that road and a public road to a point in line with the southern boundary of part Section 5, Block VII, Ngatapa Survey District, to and along that boundary and the southern boundaries of Lot 2, DP 4650, and Section 6 of the aforementioned Block VII, and along the production of the last-mentioned boundary to the middle of the Ngatapa Stream, down the middle of that stream and up the middle of the Makaretu Stream to a point in line with the north-western boundary of Section 6, Block VIII, Ngatapa Survey District, to and along the generally northern boundaries of that section, the northern boundary of Section 3 of the aforementioned Block VIII and its production to the middle of the Hihiroroa Stream, down the middle of that stream to a point in line with the northern boundary of Section 1, Block V, Waikohu Survey District, to and along that boundary to the north-western corner of Lot 1, DP 2248, along the western, southern, and eastern boundaries of that lot to the northernmost corner of the said Lot 1, along the western and northern boundaries of part Section 27, Block I, Waikohu Survey District and the western and southern boundaries of Lot 1, DP 3117, along the eastern boundary of that lot and its production across Hihiroroa Road to and along the southern boundary of Section 26, Block I, Waikohu Survey District to the northernmost corner of Section 3, Block I, Waikohu Survey District, along the north-eastern boundary of that section and the north-eastern boundary of part Okahuati 1C, along the abutment of a public road to the north-western corner of part Waikohu Block, due north along a right line to the middle of the Wharekopae River, down the middle of that river, the Waikohu River and down the middle of the Waipaoa River to and up the middle of the Mangataikehu Stream to a point in line with the north-western boundary of Ahirau 1B; thence north-easterly generally, to and along that boundary, the northern boundaries of Ahirau 1B, and Lot 8, DP 2165, along the western boundary of Ahirau 2G and its production to the middle of the Mangaruaki Stream, up the middle of that stream to a point in line with the eastern boundary of part Papakorokoro 2A1, to and along that boundary and its production to the middle of the Mangaaoe Stream, up the middle of that stream to a point in line with the south-western boundary of Papakorokoro 9E, to and along that boundary, the western boundaries of Papakorokoro 9D, 9C, and 9B, the northern and eastern boundaries of Papakorokoro 9B, along the northern boundary of Papakorokoro 8, the north-western, north-eastern and south-eastern boundaries of Section 8, Block XIV, Waingaromia Survey District, along the south-western boundaries of Lots 5 and 6, DP 6573, the southern boundary of the said Lot 6, northerly along the eastern boundaries of Lots 6, 4, and 3, DP 6573 to the north-western corner of Lot 1, DP 908, along the northern boundary of that lot and along the western side of the Waimata-Hokoroa Road to the southern boundary of Section 5, Block XVI, Waingaromia Survey District, along that boundary and its production to the middle of the Hinakiwawahia Stream, down the middle of that stream and the Kaitangata Stream to a point in line with the north-western boundary of Section 2, Block XI, Waingaromia Survey District, to and along the north-western boundaries of that section and Section 9, Block XI, Waingaromia Survey District, along the north-eastern boundary of the said Section 9, across the Waimata-Hokoroa Road, to and along the north-eastern boundary of Section 12, Block XII, Waingaromia Survey District to the southernmost corner of Section 8, Block VIII, Waingaromia Survey District, northerly along the generally eastern boundary of the said section and its production to the middle of the Waimata-Hokoroa road, along the middle of that road to and along the middle of the Kanakanaia Road, to a point in line with the south-western boundary of Lot 1, DP 1104, north-westerly to and along that boundary and its production to the middle of the Waingaromia River, up the

middle of that river to a point in line with the south-western boundary of Section 2, Block II, Waingaromia Survey District, to and along that boundary, the south-western boundary of Section 3, the northern boundary of that section and Section 2, Block II, Waingaromia Survey District and the production of the last-mentioned boundary to the middle of the Mangatuamaru Stream, up the middle of that stream to a point in line with the north-western boundary of part Section 1, Block XIV, Tutamoe Survey District, to and along the generally north-western boundary of the said part Section 1 to the south-western corner of Lot 12, DP 2047, along the western boundary of that lot, the south-western boundaries of Lots 7 and 4, DP 2230, along the western boundaries of Lot 3, DP 2228 and Closed Road, again along the western boundary of the said Lot 3 and its production to the middle of Tarnedale Road, along the middle of that road to a point in line with that western boundary of Lot 3, to and along that boundary, the western boundary of Lot 1, DP 2227, along the production of the last-mentioned boundary to the middle of the Mata River; thence south-easterly generally down the middle of that river to and up the middle of the Mangamaunu Stream to a point in line with the north-eastern boundary of Lot 8, DP 2115, to and along that boundary, the north-eastern boundaries of Lot 9 DP 2115, Lot 3A, DP 2128, and Lot 3, DP 2785 to the northernmost point of Lot 14, DP 3393 in Block VIII, Tutamoe Survey District, south-easterly along several right lines bearing 200°29' distance 3419.86 metres, bearing 78° distance 905.26 metres, bearing 87° distance 452.63 metres, bearing 118°30' distance 2373.78 metres, bearing 135° distance 321.87 metres, bearing 93° distance 1508.76 metres, bearing 189°30' distance 1327.71 metres, bearing 254°30' distance 905.26 metres, to a point on the eastern boundary of part Lot 8, DP 1104, approximately 100 metres north of the westernmost corner of Lot 18, DP 3426, southerly along the eastern boundary of the said part lot 8 crossing a public road to the north-western corner of Lot 4 DP 7053, along the northern boundary of the said Lot 4, across a public road, along the northern boundary of Lot 5, DP 7053, and part Lot 19 DP 3395 to Trig Station 171, Puakato, in Block XIII, Tokomaru Survey District; thence due east along a right line to the eastern boundary of Lot 18 DP 3426, southerly along that boundary and the eastern boundary of part Lot 19, DP 3395, the north-eastern boundaries of Section 5, Block II, Uawa Survey District, Mangatokerau 1C, part Section 1, Block III, Uawa Survey District, and along the north-western boundary of Lot 1, DP 3154, the abutment of land reserved from sale, and the production of that north-western boundary to the middle of the Hikuwai River, down the middle of that river to a point in line with the northern boundary of part Kopuatarakihi 2A, to and along that boundary, across SH 35, and again along the aforementioned northern boundary, along the eastern boundary of part Kopuatarakihi 2A, to and along the northern and eastern boundaries of part Kopuatarakihi 1B1, along the northern boundaries of Kopuatarakihi 1C2B1 and 1C2A, along the western and northern boundaries of Kaihua 2A, across Kaihua Road and again along the northern boundary of Kaihua 2A to the western boundary of Marau Block; thence northerly along the western boundary of that block to the sea coast in Block IV, Uawa Survey District; thence southerly generally along the sea coast crossing the mouths of all harbours and inlets to the point of commencement.

#### WAIKAREMOANA

All that area bounded by a line commencing at a point on the sea coast being the north-eastern corner of Part Takararoa 5231A Block in Block XIII, Paritu Survey District and proceeding north-westerly generally along the north-eastern boundary of the said part block and across Mahanga Road, again along the said north-eastern boundary and its production to the middle of the Waiua Stream, up the middle of that stream to a point in line with the southern boundary of Part Lot 6, DP 1026, to and along that boundary, across the Palmerston North-Gisborne Railway, along the southern and western boundaries of the said Part Lot 6 and the south-western boundary of Part Lot 1, DP 2315 to the north-eastern boundary of Section 34, Block XI, Nuhaka North Survey District, along that boundary the south-eastern and south-western boundaries of Section 17, Block XI, Nuhaka North Survey District, across SH 2, to and along the south-western boundary of Section 16, Block XI, Nuhaka North Survey District, to the westernmost corner of that section, along the generally western boundary of the said Section 16, to the intersection of Maraetaha and Tarewa-Tokonui Roads, along the eastern end of Maraetaha Road to and along the generally western side of the Tarewa-Tokonui Road and along the production of the last right lined road side south of the Nuhaka River to the middle of that river, down the middle of that river to a point in line with the south-western boundary of Part Section 3, Block X, Nuhaka North Survey District, to and along that boundary, the south-eastern boundaries of Part Section 2, Block VI, Nuhaka North Survey District and Lot 1, DP 16751 (Hawke's Bay Registry) to the southernmost corner of that lot, along the western boundary of Lot 1 aforesaid to the north-eastern corner of Nuhaka 2B2A1, along the generally northern boundary of Nuhaka 2B2A1 to the eastern boundary of Section 9, Block V, Nuhaka North Survey District, southerly along that boundary to the northern side of Mangapahi Road, along that roadway to the south-western corner of Section 2, Block V,
