

Nuhaka North Survey District; thence northerly along the western boundary of the said Section 2, the western and northern boundaries of Section 6, Block V, Nuhaka North Survey District, along the western boundary of Part Mangapoike B, across the Waingake-Mangapoike (Paparatu) Road and along the production of that western boundary to the middle of the Mangapoike River; thence north-westerly generally down the middle of that river to its confluence with the Mangarangi Stream, up the middle of that stream to a point in line with the south-eastern boundary of Part Mangapoike 2D, to and along that boundary to Trig Station F4 in Block VIII, Opoiti Survey District, northerly along a right line to Trig Station K in Block III, Opoiti Survey District along the south-eastern, western and generally southern boundaries of Part Lot 1, DP 1381, to its westernmost corner, northerly along the western boundary of the said Part Lot 1, across SH 36 and along the production of that western boundary to the middle of the Hangaroa River, up the middle of that river to a point in line with the southern boundary of Part Tauwharetoi 3A in Block XIV, Hangaroa Survey District, to and along that boundary to the south-western corner of the said Part Tauwharetoi 3A, along the eastern boundaries of Tauwharetoi 3B1A, the eastern boundary of Section 11, Block IX, Hangaroa Survey District, across a public road to and along the western boundary of Part Section 2, Block X, Hangaroa Survey District, westerly along the southern and western boundaries of Section 3, Block V, Hangaroa Survey District, along south-western boundary of Section 1A, Block V, Hangaroa Survey District and the production of the last-mentioned boundary to the middle of Bushy Knoll Road, south-westerly along the middle of that road to a point in line with the south-eastern boundary of Section 1, Block VIII, Tuahu Survey District, to and along that boundary, the south-eastern boundary of Part Lot 20, DP 1950 and the production of the last-mentioned boundary to the middle of the Ohinetewai Stream, down the middle of that stream and down the middle of the Kawaimanga Stream to the middle of the Hangaroa River, up the middle of the Hangaroa River to a point in line with the western boundary of Section 13, Block XIII, Ngatapa Survey District, westerly along a right line to Trig Station F in Block IV, Tuahu Survey District, being a point on the north-eastern boundary of Part Lot 20, DP 1950, along the north-eastern boundaries of the said Part Lot 20 and Lot 19, DP 1950, to and along the northern boundary of the last-mentioned lot, the northern boundaries of Part Lots 24 and 23, DP 1952, along the north-eastern boundaries of Part Lot 18, DP 1970 and Section 2, Block XV, Koranga Survey District, southerly along the western boundaries of that section and the aforementioned Part Lot 18, across Papuni Road and again along the western boundary of the aforementioned Part Lot 18 to its intersection in Block II, Tuahu Survey District, with a right line between Trig Station Puketapu in Block VII, Tuahu Survey District and Trig Station 2126, Maungapohatu, in Block XII, Ruatahuna Survey District and along that right line to the said Trig Station 2126, Maungapohatu, on the generally southern boundary of the Tarawera Electorate hereinbefore described; thence generally westerly along the generally southerly boundary of the Tarawera Electorate to the middle of the Waikato River; thence generally southerly up the middle of the Waikato River to a point in line with the middle of the Waipuwawera Stream; thence north-westerly up the middle of the said stream to the south-eastern boundary of SH 1; thence south-westerly along the said boundary to Peg XXIVc as shown on SO 44183; thence westerly by a right line to an angle on the western side of Poihipi Road opposite IT XV as shown on SO 41900; thence south-westerly along a right line to the northernmost corner of Rangatira 5; thence south-westerly along the north-western boundary of the said block to its westernmost corner; 2 thence south-westerly along a right line to an angle on the north-eastern boundary of Part Rangatira 8A (being 52°02' 17.08 metres from IT XI shown on ML 19097); thence generally south-easterly along the north-eastern boundary of Part Rangatira 8A to the north-eastern corner of Rangatira B615; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of the said block to the middle of Acacia Bay Road; thence south-westerly along the middle of the said road to a point in line with the north-eastern corner of a public road (as defined on ML 16214); thence south-easterly by a right line on a bearing of 165°00' to the shore of Lake Taupo; thence generally westerly, southerly and easterly along the shore of Lake Taupo to Te Anaputarua Point being on the western boundary of Part Tauranga-Taupo 1B2; thence south-easterly along the south-western boundary of the said block, crossing SH 1 and south-easterly along the south-western boundary of Section 5, Block III, Tokaanu Survey District to the south-western corner of the said Section 5; thence south-easterly to Trig Station Whakamoenga; thence south-easterly to Trig Station 37, Tekaka; thence south-easterly along the south-western boundaries of Tauranga-Taupo 1A1, 1A2 and Part 1A produced to the middle of the Tauranga-Taupo River; thence generally south-easterly up the middle of the said river to a point in line with the south-western boundary of Part Tauranga-Taupo 3A; thence south-easterly to and along that boundary to the south-western corner of the said Part 3A; thence easterly along a right line to Trig Station 1123, Ahipapa, situated in Block XIV, Waitahanui Survey District; thence generally south-easterly along the western and southern

boundaries of Kaimanawa 1B, the west boundary of Kaimanawa Part 1A and the last-mentioned boundary produced to the middle of Te Waiatupuritia Stream; thence generally south-easterly down the middle of the said stream to its confluence with Ngaruroro River; thence down the middle of that river and up the middle of the Taruarau River to a point in line with the south-western boundary of Block 97, Maraekakaho Crown Grant District; thence south-westerly along a right line to Trig Station Y, situated in Block XII, Pukeokahu Survey District; thence generally southerly along the summit of the Ruahine Range to its intersection with a right line between Trig Station 30 (Old Aorangi) in Block XI, Pukeokahu Survey District (Wellington Land District) and the confluence of the Makaroro River and the Makaroro Stream in Block IX, Wakarara Survey District (Hawke's Bay Land District); thence south-westerly along that right line to the said confluence; thence easterly along a right line to a point in the middle of the Mangamauku Stream due north of the northernmost point of Lot 1, DP 16107 in Block XI, Wakarara Survey District; thence south-easterly generally down the middle of the Mangamauku Stream to a point in line with the western boundary of Block I, Gwavas Crown Grant District; thence northerly generally to and along that boundary, the western boundaries of Block 5, again Block 1 and Block 3, all Gwavas Crown Grant District; thence easterly generally along the northern boundary of that Block 3, along a right line across Kereru Road to and again along that said northern boundary and its production to and down the middle of Mangaonuku Stream to a point in line with the north-western boundary of Section 7, Block X, Maraekakaho Survey District; thence north-easterly generally to and along that boundary, to and along the western, northern and eastern boundaries of Lot 1, DP 10207, to and along the north-western boundary of Section 8, Block X, Maraekakaho Survey District and the north-western and northern boundaries of Sections 9, 4 and 6, Block XI, Maraekakaho Survey District, to and along the western and northern boundaries of Part Lot 3, DP 2207 and the production of the last-mentioned boundary to the middle of the Raukawa-Te Onepu Road, along the middle of that road and the middle of Valley Road to a point in line with the southern side of SH 50, along a right line to and along the western boundary of Lot 1, DP 12156 and its production to the middle of the Ngaruroro River; thence easterly generally along the middle of the Ngaruroro River to a point in line with the north-western boundary of Part Lot 1, DP 6071; thence north-easterly generally to and along the north-western boundary of Part Lot 1, DP 6071 and its production to the middle of the Tutaeuri-Waimate Stream, down the middle of that stream to a point in line with the north-eastern boundary of Lot 1, DP 16776, to and along that boundary and its production to the middle of SH 50, along the middle of that highway, Waiohiki Road and the Redclyffe Bridge and its production to and south-westerly along the middle of Springfield Road to a point in line with the western boundary of Lot 11, DP 12805; thence northerly generally, to and along that boundary and the western boundaries of Lot 10, DP 12805, Lot 12, DP 17045, Part Lot 1, DP 17210, Lot 1, DP 18523, Lot 1, DP 17045, Lot 7, DP 19569, Lots 2 and 3, DP 19745 and the production of the last-mentioned boundary to the northern side of Puketapu Road; thence north-westerly generally along that side of Puketapu Road to the southernmost corner of Lot 6, DP 17146; thence northerly along the western boundaries of Lots 6 and 5, DP 17146, to the north-western corner of Lot 5, aforesaid; thence easterly along the northern boundaries of Lots 5, 3 and 1, DP 17146 to the north-eastern corner of Lot 1, aforesaid; thence north-easterly generally along the north-western boundaries of Lots 43, 44, 45, 26, 27 and 28, DP 19578 and the abutment of Cumberland Rise and the northern boundary of Lot 29, DP 19578 to the north-eastern corner of Lot 29, DP 19578; thence easterly and southerly along right lines bearing 101°, distance 107.03 metres, bearing 191°, distance 226.83 metres, bearing 211°, distance 58.34 metres, to the north-western corner of Lot 5, DP 11897; thence south-easterly along the north-eastern boundaries of Lots 5, 4, 3, 2 and 1, DP 11897 and Lots 10, 9, 8, 7, 6 and 1 DP 10160, to and southerly along the western side of Church Road to a point in line with the southern boundary of Lot 1, DP 6685; thence easterly to and along that boundary and its production to and northerly along the middle of the Taipo Stream to and westerly along the southern boundary of Lot 5, DP 11734; thence northerly along the western boundaries of the said Lot 5 and Lots 9 and 10, DP 11649, to the westernmost corner of Lot 1, DP 19585; thence north-easterly along the north-western boundaries of Lot 1, aforesaid, Lot 2, DP 12650, Lot 2, DP 13228 and Lot 3, DP 15019 and easterly along the northern boundary of the last-mentioned lot to the south-western corner of Lot 4, DP 17195; thence north-westerly generally along the north-western boundaries of Lot 4 aforesaid to and along the middle of the Taipo Stream to Church Road; thence northerly along the eastern side of that road and Puketitiri Road to the southern boundary of Suburban Section 113 Meeanee; thence easterly, northerly and westerly along the southern, eastern and northern boundaries of Suburban Section 113 Meeanee to the south-easternmost corner of Lot 1, DP 12689; thence north-westerly along the north-eastern boundary of Lot 1 aforesaid to the eastern side of Oak Road; thence northerly along the eastern side of that road to a point in line with the north-
