

Railway; thence generally northerly along the middle of that railway to a point in line with the southern boundary of Lot 4, DP 9455 shown as 255°47' for 217.24 metres; thence easterly along a right line to and along that boundary and the southern boundaries of Sections 7, 11, and 5, Block XIV, Mapara Survey District, to the south-eastern corner of the said Section 5; thence northerly along the eastern boundaries of the said Section 5 and Section 4, Block XIV, Mapara Survey District, to the south-western corner of Section 4, Block III, Pahi Survey District; thence easterly along the southern boundaries of the said Section 4 and Section 3, Block III, Pahi Survey District, to the south-eastern corner of the said Section 3; thence northerly along the eastern boundary of that section to the southern boundary of Section 5, Block III, Pahi Survey District; thence easterly along the southern boundaries of that section, Section 7, Block III, Pahi Survey District, and a right line to and along the southern boundary of Section 1, Block II, Ongarue Survey District, to the eastern corner of that section; thence generally easterly along the generally southern boundaries of former Rangitoto Tuhua 36A1B2A2 as shown on ML 14216 and former Rangitoto Tuhua 36A1A2 as shown on ML 12124 to the south-eastern corner of the said former Rangitoto Tuhua 36A1A2; thence southerly along the eastern boundary of former Rangitoto Tuhua 36A1B2 and Rangitoto Tuhua 54A2 and the last mentioned boundary produced to the middle of the Ongarue River; thence generally easterly up the middle of that river to its source in Block VII, Hurakia Survey District; thence north-easterly along a right line to Trig Station 1390, Pureora; thence northerly along the eastern boundaries of Maraeroa A2 and part A3A Blocks to the north-eastern corner of the last-named block, being a point on the generally eastern boundary of Waipa Electorate hereinbefore described; thence generally northerly along that boundary to a point in line with the northern boundary of the land on DP 21718; thence generally easterly along the generally northern boundaries of the said land, Lots 1 and 2 DP 21950 and part Lot 5 DPS 12209 to Trig Station Te Teko 802; thence north-easterly along the south-eastern boundaries of part Section 22 Block VII Patetere South Survey District, Lot 1 DPS 16529, Section 16 Blk VII Patetere South Survey District, Part Section 15 Blk VII and Lot 1 DPS 30166 to the eastern most corner of the said Lot 1; thence by a right line across Paraonui Road to the western most corner of Lot 1 DPS 7490 and along the said Lot 1 southern boundary and the southern boundaries of Lots 1 and 2 DPS 31442 and a right line across the North Island Main Trunk Railway to the south-western corner of part Lot 3 DP 23866; thence north-easterly along the south-eastern boundary of the said Lot, a right line across SH 1 and the south-eastern boundaries of Lot 1 DPS 16097 and part Lot 3 DP 24035 and its production to the middle of Pokaiwhenua Stream; thence easterly along the middle of the said stream to a point in line with the eastern boundary of part Lot 3 DP 26224; thence northerly to and along the said boundary to the northern most corner of Part Lot 1 DP 20030 and south-easterly along the north-eastern boundary of the said Lot, Lot 12 DP 20030 and part Lot 1 DP 20030 to Trig Station 818 Pukerimu; thence easterly along the northern boundaries of Lot 1 DP 20031, Lot 3 DP 20031 and Lot 1 DP 20031 to the south-eastern corner of Lot 2 DPS 9824; thence northerly along the eastern boundaries of the said Lot 2 and Lot 1 DPS 9824 to the northern most corner of part Patetere South 1A; thence south-easterly along the north-eastern boundary of the said Block, and a right line to the northern most corner of Patetere South 1B3; thence southerly along the eastern boundaries of part Lot 1 and Lot 2 DP 20031 and part Lot 2 DP 25485 to the north-western corner of part Lot 10 DP 12325; thence southerly along the western boundaries of the said Lot, part Lot 2 and part Lot 1 DP 20272 produced to the middle of SH 30; thence easterly along the middle of SH 30 to a point in line with the middle of a stream adjoining the southern boundary of part Section 13 Block III Atiamuri Survey District and to and along the said stream to the middle of the Whangapoa Stream; thence southerly down the middle of the Whangapoa Stream to the point of commencement.

All that area bounded by a line commencing at a point in the middle of the confluence of the Wanganui and Ongarue Rivers and proceeding north-easterly along a right line to the right bank of the Wanganui River; thence generally north-easterly along that right bank to a point in line with the production of a right line between the north-eastern corner of Section 12, Block I, Hunua Survey District and the westernmost corner of Section 5, Block I, Hunua Survey District; thence southerly along that right line to the middle of Marsack Road; thence generally southerly along the middle of that road and Hikumutu Road to a point in line with the north-eastern boundary of Section 33, Block I, Hunua Survey District; thence generally south-easterly to and along that boundary, the northern and eastern boundaries of Reserve B and the northern boundaries of Part Section 16, Section 35, Part Reserve E and Sections 3 and 4, Block I, Hunua Survey District, to the south-western corner of Part Section 1, Block I, Hunua Survey District; thence northerly along the western boundary of the said Part Section 1 and Lot 1, DP 16781 and the production of the last-mentioned boundary to the middle of Marsack Road; thence easterly along the middle of that road to a point in line with the south-

eastern boundary of Part Section 38, Block I, Hunua Survey District; thence northerly to and along the south-eastern boundary of the said Part Section 38 and its production to the right bank of the Wanganui River; thence generally easterly along that bank to a point in line with the north-eastern boundary of Part Section 5, Block II, Hunua Survey District, (comprised in CT 5D/1160); thence south-easterly to and along the north-eastern boundary of the said Part Section 5 and the production of the last-mentioned boundary to the middle of Racecourse Road; thence south-westerly along the middle of that road and north-westerly along the middle of Mission Road to a point in line with the north-western boundary of Section 4, Block II, Hunua Survey District; thence generally southerly and easterly to and along the last-mentioned boundary and the southern boundaries of the said Section 4 to the western side of Mission Road; thence by a right line across that road to the south-eastern corner of Part Lot 2, DP 3628; thence easterly along a right line to the north-western corner of Section 14, Block II, Hunua Survey District; thence southerly along the western boundaries of Sections 14, 15, 16 and 17, Block II, Hunua Survey District, to the south-western corner of the said Section 17; thence easterly along the southern boundary of the said Section 17, to the western side of Valley Road; thence by a right line across that road to the south-western corner of Section 26, Block II, Hunua Survey District; thence south-easterly along the south-western boundary of the said Section 26, to the southernmost corner of that section; thence generally northerly along the western and north-western boundaries of Section 37, Block II, Hunua Survey District and the production of the last-mentioned boundary to the middle of the North Island Main Trunk Railway line; thence south-easterly along the middle of the said railway line to a point in line with the middle of SH 4 and its intersection with Mahoe Road; thence generally southerly to and along the middle of SH 4 and its production to the middle of the Wanganui River; thence generally south-easterly up the middle of that river to its headwaters; thence easterly along a right line to Trig Station Tongariro No. 2, in Block XII, Tongariro Survey District; thence southerly along a right line to Trig Station D, Ngauruhoe, in Block XVI, Tongariro Survey District; thence south-westerly along a right line to Trig Station H, Paretaitonga, in Block XI, Ruapehu Survey District; thence south-easterly along a right line to Trig Station Ruapehu, in Block XI, Ruapehu Survey District; thence easterly along a right line between the last-mentioned Trig Station Ruapehu and Trig Station XXVIII, Manukaiaapu, in Block XVI, Kaimanawa Survey District, to the middle of SH 1; thence generally southerly along that highway to a point in line with the northern boundary of Part Section 9, Block IX, Moawhango Survey District; thence westerly to and along the northern boundary of the said Part Section 9 and its production to the northern boundary of Section 10, Block IX, Moawhango Survey District and again westerly along the last-mentioned boundary to the north-western corner of the said Section 10; thence southerly along the western boundaries of Sections 10, 16 and 12, Block IX, Moawhango Survey District, (SO. 20013 and SO. 18831), and easterly along the southern boundary of the last-mentioned Section 12, (SO. 18831) to the western side of the North Island Main Trunk Railway; thence generally southerly down the western side of that railway line to its junction with SH 1; thence generally southerly along the western side of the said highway to a point in line with the northernmost corner of Section 21, Block IX Moawhango Survey District at right angles to the said highway; thence easterly by a right line through that corner to the middle of the North Island Main Trunk Railway; thence generally southerly along the middle of the said railway to a point in line with the eastern boundary of Section 3, Block XVI, Maungakaretu Survey District; thence southerly to and along the last-mentioned boundary and generally westerly along the southern boundary of the said Section 3 and its production to the middle of an unnamed legal road; thence generally southerly and westerly along the middle of that road and Ngaurukehu Road to the middle of Mangapapa Stream; thence down the middle of that stream to and up the middle of Taumokomoko Stream and the Panemanga Stream to a point in line with the southern boundary of Lot 1, DP 22604; thence westerly to and along that boundary and its production to the southern boundary of Lot 3, DP 18241; thence generally westerly along the southern boundaries of Lot 3, DP 18241, Ruanui 2B5, 2B6, 2B7 and Section 1, Block X, Maungakaretu Survey District and the production of the last-mentioned boundary to the middle of the Turakina River; thence down the middle of the said river to a point in line with the south-western boundary of Part Section 63, Block XIII, Maungakaretu Survey District; thence north-westerly and westerly to and along that boundary and the southern boundary of the said Part Section 63 to the south-western corner of Section 77, Block XVI, Ngamatea Survey District; thence north-westerly along the north-eastern boundary of the said Section 77 and its production to the middle of Hales Road; thence generally northerly along the middle of that road to a point in line with the north-eastern boundary of Section 69, Block XVI, Ngamatea Survey District; thence north-westerly along that boundary and its production to the middle of the Koukoupo Stream; thence up the middle of that stream to a point in line with the northern boundary of Section 11, Block VIII, Ngamatea Survey District; thence
