thence westerly to and along the northern boundary of the said Section 8 and its production to the northern boundary of Section 1, Block IV, Ngamatea Survey District and again westerly along that boundary and its production to the middle of the Whangaeahu River; thence down the middle of the said river to a point in line with the north-eastern boundary of Ohotu 6A1B; thence generally north-westerly to and along that boundary, to and down the middle of the Karokia Stream and the Haupokopoko Stream to a point in line with the north-western boundary of Lot 1, DP 27919; thence generally south-westerly to and along the last-mentioned boundary to the north-eastern boundary of Lot 2, DP 4978; thence north-westerly along that boundary and generally south-westerly along the north-western boundaries of Lot 2 and Lot 1, DP 4978 and the production of the last-mentioned boundary to the middle of SH 4; thence south-easterly along the middle of that highway to the middle of Aukaki Stream and down the middle of that stream to its confluence with the middle of the Mangawhero River; thence down the middle of the said river to a point in line with the southern boundary of Ohotu 9; thence generally westerly to and along that boundary and the southern boundary of Lot 3, DP 29354, to the easternmost corner of Lot 1, DP 29350; thence generally northerly along the eastern boundary of Lot 1, DP 29350 and its production to the middle of the Matahiwi Track; thence generally south-westerly along the middle of the Matahiwi Track to a point in line with the western boundary of Lot 2, DP 29348; thence northerly and generally easterly to and along the western and northern boundaries of the said Lot 2 and the production of the last-mentioned boundary to the middle of the Mangaetaroa Stream; thence down the middle of that stream to a point in line with the southern boundary of Mairehau 1; thence generally westerly to and along that boundary and the southern boundaries of Mairehau 2A and Part Mairehau 2, as shown on ML 2691, to the westernmost corner of the last-mentioned block; thence north-easterly along the north-western boundary of Part Mairehau 2 to the southernmost corner of Lot 4, DP 29363; thence north-easterly along the north-western boundary of the said Lot 4 and its production to the middle of the Mathiopo Stream; thence down the middle of that stream and the Mangoihe Stream to a point in line with the western boundary of Lot 5, DP 29340; thence northerly to and along that boundary and its production to the middle of the Mangoihe Track; thence generally westerly along the middle of that track to the middle of the Mataurihi Stream; thence up the middle of that stream to a point in line with the southernmost corner of Waharangi 4, 15; thence generally westerly to and along the southern boundaries of the said block to the eastern side of Otaranoho Road and along a right line to the north-eastern corner of Part Section 1, Block XIV, Rarete Survey District; thence generally south-westerly along the north-western boundaries of that part section and Part Ohoutahi 1A and the production of the last-mentioned boundary to the middle of the Wanganui River; thence up the middle of the Wanganui River to a point in line with the north-western boundary of Whakaihawaka C3A; thence south-westerly to and along that boundary and its production to the middle of Pipiriki Road; thence generally westerly along the middle of that road and the middle of Pokaka Road to where it meets the western watershed of the Wanganui River; thence northerly along that watershed to a point in line with the northern boundary of the former Section 2, Block XI, Taurakawa Survey District; thence westerly to and along that boundary and a right line to the north-eastern corner of Section 2, Block X, aforesaid; thence westerly along the northern boundary of that section, to and along the northern boundary of Section 4, Block IX, aforesaid; and a right line due west across a road reserve, the Waitotara River, Waitotara Valley Road and Section 3, Block V, the Totara Stream, Section 1, Block IX and Section 2, Block V, all Taurakawa Survey District, to a point on the eastern boundary of Section 17, Block XII, Omoana Survey District; thence northerly along that boundary and its production to the middle of Moeawatea Road; thence generally northerly along the middle of that road to a point in line with the northern boundary of Section 3, Block VIII, Omoana Survey District; thence westerly to and along the northern boundaries of Sections 3, 4, and 1, Block VIII, aforesaid, and a right line across Karewa Road, to and along the northern boundaries of Sections 21, 4, and part Section 1, Block VII, aforesaid, and the production of the last-mentioned boundary to the middle of Waitiri Road; thence northerly along the middle of that road to a point in line with the south-western boundary of Section 22, Block VII, aforesaid; thence westerly to and along that boundary and the bearings and distances shown on S.O. 5748 as follows 274°04' for 4.20 metres, 320°40' for 23.48 metres, 357°37' for 54.88 metres, 302°25' for 51.58 metres, 309°01' for 28.87 metres, 301°46' for 52.04 metres,

thence generally southerly along the eastern boundary of Section 5S, Tawhiwhi Settlement, a right line across Tauwharenikau Road, to and again southerly along the eastern boundaries of the said Section 5S and Section 9S, Tawhiwhi Settlement; thence southerly along the eastern boundaries of part Lot 1, DP 1644, and part Lot 6 DP 2383; thence southerly and westerly along the eastern and southern boundaries of part Lot 7, DP 2358, and a right line across Matemateaonga Road, to and again along the southern boundary of part Lot 7, aforesaid, and the last-mentioned boundary produced to the middle of the Patea River; thence up the middle of the Patea River to a point in line with the northern boundary of Section 11, Block VIII, Ngaere Survey District; thence westerly along a right line to and across a Reserve for Preservation of Forest to the said northern boundary; thence westerly and southerly along the northern and western boundaries of the said Section 11; thence westerly along the southern boundary of Section 5, Block VIII, aforesaid, and its production to the middle of Wingrove Road; thence northerly along the middle of that road to a point in line with the northern boundary of Section 19, Block XII, aforesaid; thence westerly to and along that boundary to Trig Station B (Rahui); thence generally northerly along the eastern and northern boundaries of part Lot 15, DP 577, and southerly and westerly along the eastern and southern boundaries of Lot 1, DP 2575, and south-westerly along the north-western boundary of part Lot 15, DP 577, and that boundary produced to the middle of Pukengahu Road; thence northerly along the middle of that road to a point in line with the northernmost corner of Lot 14, DP 1082; thence to that corner, and south-westerly and south-easterly along the north-western and south-western boundaries of the said Lot 14, to the middle of Hu Road; thence generally southerly along the middle of that road and westerly along the middle of Rawhitiroa Road to a point in line with the middle of Maata Road; thence generally southerly and westerly along the middle of that road and the middle of Mangawhero Road to a point in line with the middle of Mountain Road (SH 3); thence northerly along the middle of that road to a point in line with the middle of the Mangawhero Stream; thence generally westerly along the middle of that stream to a point where it meets the middle of the Waingongoro River; thence generally northerly along the eastern boundary of Taranaki Electorate, hereinafter described, to the Tasman Sea Mean High Water Mark; thence generally northerly along the Tasman Sea Mean High Water Mark to and generally easterly along the mean high water mark of Kawhia Harbour to the generally south-western boundary of the Electoral District of Waipa, hereinbefore described; thence generally south-easterly along that boundary to the north-eastern corner of Pt Maraeroa A3A; thence southerly along the eastern boundaries of the said A3A and Maraeroa A2 to Trig Station Pureora 1390; thence southerly by a right line to the source of the Ongarue River and generally westerly down that river to a point in line with the eastern boundary of Rangitoto Tuhua 3A2; thence to and along that boundary to Trig Station 1394 and northerly along the eastern boundary of the former Rangitoto Tuhua 36A1B2 to the southeastern corner of Rangitoto Tuhua 36A1A2 as shown on ML 12124; thence westerly along the southern boundaries of the said Block and the former Rangitoto Tuhua 36A1B2A2 as shown on ML 14216 to the eastern most corner of Section 1 Block II Ongarue Survey District; thence westerly along the southern boundaries of the said Section 1, Section 7 Block III Pahi Survey District and Section 5 Block III, aforesaid to the south-western corner of the said Section 5; thence southerly and westerly along the eastern and southern boundaries of Section 3 Block III Pahi Survey District and westerly along the southern boundary of Section 4 Block III Pahi Survey District to the south-western corner of the said Section 4; thence south-westerly along the south-eastern boundaries of Sections 4, 5, 11 and Pt 7, Block XIV, Mapara Survey District and Lot 4 DP 9455 produced to the middle of the North Island Main Trunk Railway; thence southerly along the middle of the said railway to a point in line with the northern boundary of Rangitoto Tuhua 76B8B2D; thence easterly along the production of the said northern boundary to the middle of the Ongarue River; thence southerly down the middle of the said river to a point in line with the north-western boundary of Ohura South N2E3C, to and along the said boundary crossing the intervening North Island Main Trunk Railway and SH 4 and the north-western boundary of Part Ohura South N2E3G3 Lot 11B2 to a point 140.8 metres from the western side of SH 4; thence southerly along a right line to a point on the north-western boundary of part Lot 1 DP 10342 (Taranaki Registry) being 201.2 metres from the western side of SH 4; thence south-westerly and south-easterly along the north-western and south-western boundaries of the said part Lot 1 to its south-western corner; thence south-easterly along a right line to the north-eastern corner of Lot 13 DP 11662 and southerly along the eastern boundaries of the said Lot 13 and part Ohura South N2E3G2D and its production to the middle of Kururau Road; thence south-westerly along the middle of Kururau Road, the middle of an unnamed legal road passing through Ohura South N2E1B and the middle of Wanganui River
