

Kawakawa Survey District, along a right line, across Paihia Road to the northwesternmost corner of Lot 1, DP 75428; thence easterly along the northern boundary of the last-mentioned Lot 1, the southern boundary of Lot 2, DP 75428 (now part of Lot 3, DP 107802), and the northern boundary of Lot 3, DP 75428 to the north-eastern corner of the last-mentioned Lot 3; thence southerly along the eastern boundary of the aforesaid Lot 3, to and along the western boundary of Lot 4, DP 75428 (now part of Lot 3, DP 107802), to the north-western corner of Allotment 147, Kawakawa Parish, Block IX, Russell Survey District; thence easterly along the northern boundaries of the last-mentioned Allotment 147 and Allotment 148, Kawakawa Parish, to and southerly along the eastern boundary of the aforesaid Allotment 148, and the last boundary produced to the south-eastern side the North Auckland Railway, thence north-easterly generally along the south-eastern side of the North Auckland Railway to the easternmost corner of the aforesaid Railway as shown on SO Plan 45201; thence south-easterly along a right line to its intersection with the middle of the mouth of the Karetu River, up the middle of the Karetu River, to its intersection with the western boundary of part Karetu A2B; thence southerly along that boundary and that boundary produced to its intersection with the middle of Waikare Road; thence easterly and north-easterly generally along the middle of Waikare Road, to a point in line with the northern boundary of part Old Land Claim 125, Block VII, Russell Survey District, along a right line, to and along the northern boundaries of the aforesaid part Old Land Claim 125, to and along the northern boundaries of Waikare 7A to the westernmost corner of part Tutaematai A (as shown on DP 27504); thence northerly along the western boundaries of the last-mentioned part Tutaematai A, and part Tutaematai B2 No. 3 (as shown on SO Plan 29247), and the last boundary produced to the middle of Russell Road; thence westerly and northerly along the middle of Russell Road to a point in line with the northern boundary of Section 6, Block VII, Russell Survey District; thence north-easterly along a right line to the easternmost corner of Section 4, Block VII, Russell Survey District; thence northerly generally along the generally western boundaries of that Section 4, to and along the north-western boundaries of part Tutaematai B2, No. 4, as shown on SO Plan 29247 to its northernmost corner; thence south-easterly along the north-eastern boundaries of the last-mentioned Tutaematai B2, No. 4, Lot 1 DP 101085 and parts Tutaematai B2, No. B2, crossing the intervening Rawhiti Road, to the westernmost corner of Whangaroa-Ngaiotonga 4G3; thence north-easterly along the north-western boundaries of the last-mentioned Whangaroa-Ngaiotonga 4G3, crossing the intervening Mahia Roadway, to and along the north-eastern boundaries of Whangaroa-Ngaiotonga 4G4, crossing the intervening Whangaruru North Road, to and along the eastern boundary of Whangaroa-Ngaiotonga 4A6E to its northernmost corner; thence easterly along the southern boundary of Whangaroa-Ngaiotonga 4A6D to its intersection with the line of mean high water of the South Pacific Ocean; thence northerly generally along that line of mean high water to the easternmost extremity of Section 2, Block XIIA, Bay of Islands Survey District, along a right line, to and along the eastern shores of Piery Island to the northernmost extremity of Piery Island, (Motukokaho); thence westerly along a right line to the easternmost extremity of Harakeke Island, Block IX, Bay of Islands Survey District, and continuing westerly along the northern shores of that island, to and north-westerly generally along the line of mean high water of the South Pacific Ocean, crossing the mouths of the Tapuaetahi Creek, the Tahoranui River, the Takou River, the Tauranga Stream, the Whangaroa Harbour, the Mangonui Harbour, the Taipa River, the Rangaunu Harbour, the Houhora Harbour, the Parengarenga Harbour, to and south-easterly along the line of mean high water of the Tasman Sea, crossing the mouths of the Herekino Harbour, the Whangape Harbour, the Hokianga Harbour, the Waimamaku River and the Wairau River to the point of commencement, and including the Three Kings Islands the Cavalli Islands, and other adjacent islands.

WHANGAREI

All that area bounded by a line commencing at a point, being the intersection of the middle of Waitaua Stream and the south-eastern boundary of Lot 1, DP 90821, Block VIII, Purua Survey District and proceeding easterly generally down the middle of Waitaua Stream and that middle line produced across Gillingham Road, to and along the said stream, as shown on SO Plan 973 and DP 236, and continuing along the middle of the last-mentioned stream to its intersection with the middle of Hatea River, Block V, Whangarei Survey District; thence south-easterly generally down the middle of the Hatea River to the northern side of Parau Valley Road; thence easterly along that roadside to the left bank of the Hatea River; thence southerly along that bank of the Hatea River to its intersection with the north-western side of Whareora Road, along a right line, due south to its intersection with the middle of Whareora Road; thence south-westerly along the middle of Whareora Road to its intersection with the middle of an unnamed legal road, forming the northern boundaries of Lots 1 and 2, DP 98080; thence easterly along the middle of that unnamed legal road to a point in line with the eastern boundary of Lot 2, DP 98080; thence southerly along a right line, to and along the eastern boundaries of the last-mentioned Lot 2, Lot 4, DP

37540 and Lot 4, DP 96725, Block IX, Whangarei Survey District to the southernmost corner of the last-mentioned Lot 4; thence westerly along the northern boundaries of part of Parahaki Maori Reserve (Bird Sanctuary, comprised in Certificate of Title 13D/1308) and the last-mentioned boundary produced to the middle of the Hatea River; thence southerly generally down the middle of the Hatea River to a point in line with the south-western boundary of part Parahaki No. 1, (comprised in Certificate of Title 542/37); thence south-easterly along a right line, to and along that south-western boundary and north-easterly along the south-eastern boundary of that part Parahaki No. 1, to the northernmost corner of part Parahaki No. 1, (comprised in Certificate of Title 58B/29); thence southerly along the eastern boundaries of that part Parahaki No. 1, to its intersection with the northern boundary of Lot 1, DP 102173, and continuing southerly generally along the generally western boundaries of part Parahaki Native Reserve, as shown on M.L. Plan 1095 (now part of Lot 1, DP 102173), to the southernmost corner of the last-mentioned part Parahaki Native Reserve; thence south-easterly generally along the generally north-eastern boundaries of part Lot 4, Deeds Plan 60 and Lot 55A, Deeds Plan 67 to the southernmost corner of that Lot 55A; thence easterly along the northern end of Dundas Road to its intersection with the middle of Dundas Road; thence south-easterly along a right line to the westernmost corner of Lot 4, DP 58065; thence north-easterly along the north-western boundaries of that Lot 4, Lots 3 and 2, DP 58065 and Lot 3, DP 46522 to the northernmost corner of the last-mentioned Lot 3; thence south-easterly along the north-eastern boundaries of that Lot 3, part Lot 1, DP 58065, Lot 1, DP 70352, the end of Memorial Drive and Lot 1, DP 53068, and the last boundary produced to the middle of an unnamed legal road, forming the northern boundary of Lot 6, DP 18256; thence south-easterly along the middle of that unnamed legal road to its intersection with the middle of Old Parua Bay Road; thence south-westerly generally along the middle of Old Parua Bay Road to a point in line with the northern boundary of Lot 28, DP 70057; thence easterly along a right line, to and along the last-mentioned northern boundary to its north-easternmost corner; thence south-easterly and south-westerly generally along a series of right lines crossing part Lots 13 and 12, DP 18256, bearing 180°00' distance 34.60 metres, bearing 90°00', distance 50.29 metres, bearing 180°00', distance 49.29 metres, bearing 101°00', distance 67.39 metres, bearing 125°30', distance 38.22 metres, bearing 225°30', distance 35.20 metres, bearing 183°00', distance 40.23 metres, bearing 226°20', distance 43.25 metres, bearing 270°00', distance 34.20 metres, bearing 300°30' to the eastern boundary of Lot 18, DP 70057; thence southerly along the eastern boundaries of that Lot 18 and Lots 17, 16, 15 and 14, DP 70057 to the southernmost corner of the last-mentioned Lot 14; thence north-westerly along the south-western boundary of that Lot 14 and that boundary produced to the middle of Kohe Street; thence south-westerly along the middle of Kohe Street to a point in line with the eastern boundary of Lot 13, DP 70057; thence southerly along a right line, to and along that eastern boundary and the eastern boundaries of Lot 12, DP 70057 to its southernmost corner; thence south-easterly along the south-western boundary of part Lot 12, DP 18256, to its southernmost corner; thence easterly along the northern boundary of part Section 30, Block IX, Whangarei Survey District and the generally southern boundaries of part Lot 26, DP 18256 to the north-eastern corner of Lot 1, DP 27781; thence south-easterly along the south-western boundaries of Lots 2 and 4, DP 27781 and the last boundary produced to the middle of Mackesy Road; thence easterly along the middle of Mackesy Road and Konini Street to its intersection with the middle of Tawhai Place; thence southerly along the middle of Tawhai Place to its intersection with the northern boundary of Lot 69, DP 18256; thence easterly along that northern boundary to its north-easternmost corner; thence southerly along the western boundaries of Lots 1 and 2, DP 113880 and the last boundary produced to the middle of Brook Road; thence easterly generally along the middle of Brook Road, to and along the middle of Awaroa Creek Road to a point in line with the south-western boundary of part Allotment 1, Wariara Parish, (comprised in Certificate of Title 9A/856), along a right line, to and along the south-western and southern boundaries of the last-mentioned part Allotment 1, to the northwesternmost corner of Lot 3, DP 26589; thence south-easterly and south-westerly along the north-eastern and south-eastern boundaries of Lot 1, DP 86341 to a point 33.17 metres (calculated) distance from the southernmost corner of the last-mentioned Lot 1; thence south-easterly along a right line, to and along a series of right lines parallel to and 50.29 metres distance from the north-eastern side of Riverside Drive and Onerahi Road, as shown on SO Plans 35933 and 35935, crossing the intervening Waimahanga Creek, to the northern boundary of Lot 2, DP 59041, along the northern and north-eastern boundaries of the last-mentioned Lot 2, to the easternmost corner of the last-mentioned Lot 2; thence north-easterly along the south-eastern boundary of Lot 2, DP 103343 to the northern corner of Lot 1, DP 47645; thence south-easterly along the north-eastern boundaries of Lots 1, 2, 3 and 4, DP 47645 and the last-mentioned boundary produced to its intersection with the production of the south-western boundary of part Lot 3, DP 24243, Block XIII, Whangarei Survey District, along a right line across
