thence generally north-easterly along right lines to Trig Station F, Marima, and the north-western corner of Section 9, Block IX, Mangahao Survey District; thence north-easterly along the north-western boundaries of Inglis Road, Section 4, Block V, Mangahao Survey District and Sections 3, 2 and 1, Block VI, Mangahao Survey District to the southern corner of Section 13, Block XIX, Mangahao Survey District; thence north-westerly along the south-western boundary of that section to the westernmost corner of the said Section 13; thence generally northerly along the eastern side of South Range Road to Pahiatua-Aokautere Road (Pahiatua Track); thence northerly along a right line to and along the eastern side of North Range Road; thence generally northerly to the south-western corner of part Section 1, Block I, Mangahao Survey District (CT 247/81); thence northerly along the western boundaries of part Section 1 aforesaid and Section 47, Block I, Mangahao Survey District and the production of the last-mentioned boundary to the middle of the Manawatu River; thence westerly down the middle of that river to a point in line with the south-eastern boundary of Section 1, Block X, Manchester District; thence north-easterly to and along that boundary, and the south-eastern boundaries of Lot 2, DP 27494, and part Lot 2, DP 239 (including the crossings of Saddle Road) and its production to the middle of Wharite Road; thence generally south-easterly along the middle of that road to a point in line with the western boundary of Section 2, Block II, Gorge Survey District; thence northerly, easterly, and southerly to and along the western, northern, and eastern boundaries of the said Section 2, to the southernmost corner of Part Section 52, Block XIV, Pohangina Survey District; thence north-easterly along the south-eastern boundary of the said Part Section 52, to the northern corner of Section 6, Block VII, Gorge Survey District; thence south-easterly along the north-eastern boundary of that section to Trig Station 60A, Wharite, in Block VII aforesaid; thence generally northerly along the summit of the Ruahine Range to Trig Station IS, in Block XVI, Pukeokahu Survey District; thence northerly generally along the summit of the Ruahine Range to its intersection with a right line between Trig Station 30 (Aorangi) in Block XI, Pukeokahu Survey District (Wellington Land District) and the confluence of the Makaroro River and the Makaroro Stream in Block IX, Wakarara Survey District (Hawke's Bay Land District); thence south-westerly along that right line to the said confluence; thence easterly along a right line to a point in the middle of the Mangamouku Stream due north of the northernmost point of Lot 1, DP 16107 in Block XI, Wakarara Survey District; All that area commencing from Trig Station AA Arawaru in Block VII, Arawaru Survey District and proceeding generally north-easterly along right lines to Trig Station F, Marima and the north-western corner of Section 9, Block IX, Mangahao Survey District; thence north-easterly along the north-western boundaries of Inglis Road, Section 4, Block V, Mangahao Survey District and Sections 3, 2 and 1, Block VI, Mangahao Survey District, to the southern corner of Section 13, Block XIX, Mangahao Survey District; thence north-westerly along the south-western boundary of that section to the westernmost corner of the said Section 13; thence generally northerly along the eastern side of South Range Road to Pahiatua-Aokautere Road (Pahiatua Track); thence northerly along a right line to and along the eastern side of North Range Road to the south-western corner of Part Section 1, Block I, Mangahao Survey District (CT 247/81); thence northerly along the western boundaries of Part Section 1 aforesaid and Section 47, Block I, Mangahao Survey District and the production of the last-mentioned boundary to the middle of the Manawatu River; thence generally westerly down the middle of that river and the boundaries of the Electoral District of Rangitikei hereinbefore described, to the junction of the middle of SH 56 and the middle of the Oroua River; thence generally southerly down the middle of that river and the Manawatu River to its intersection with the middle of the Tokomaru River; thence generally easterly up the middle of that river to its tributary coincidental with the southern boundary of Section 1, Block X, Arawaru Survey District; thence generally northerly along the middle of the said tributary to its intersection with the northern boundary of the said Section 1; thence easterly along that boundary to its intersection with an unnamed legal road; thence by a right line due east to the middle of the said road; thence generally southerly along the middle of the said road to a point in line with the easternmost corner of Section 10, Block X, Arawaru Survey District; thence southerly by a right line to and along the eastern boundaries of the said Section 10 and Sections 1 and 2, Block X, Arawaru Survey District, to the western boundary of Part Manawatu-Kukutaauaki 2A; thence northerly along the last-mentioned boundary and Part Mangahao No 1 to the point of commencement; excluding therefrom the Electoral District of Palmerston North hereinafter described.
