#### MIRAMAR

ALL that area bounded by a line commencing at a point on the mean high water mark of the sea at Elsdon Point in line with the north-eastern boundary of Lot 1, DP 48325, and proceeding generally north-westerly to and along that boundary and the north-eastern boundary of Lot 23, DP 44304, and the production of the last-mentioned boundary to the middle of Buckley Road; thence generally northerly along the middle of Buckley Road, Melrose Road, Southgate Road, and Buckley Road again to its intersection with Houghton Bay Road; thence southerly along the middle of the last-mentioned road and northerly along the middle of Hornsey Road to a point due east of the southernmost corner of Lot 37, DP 7794; thence westerly along a right line to that corner and northerly along the eastern boundary of Town Belt and its production to and along the middle of Manchester Street to a point due west of the westernmost point of Lot 1, DP 358; thence easterly by a right line to that corner and northerly along the western boundary of Lot 1, DP 358 and the eastern boundary of Town Belt, and the production of the last-mentioned boundary to and along the middle of Crawford Road and Alexandra Road to a point in line with the south-western boundary of Lot 8, DP 9958; thence generally north-easterly to and along the middle of a formed, not legal, unnamed road to a point on the north-western boundary of part Lot 1, DP 17217 (comprised in C.T. 631/18) 15 metres north-east of the south-western boundary of part Lot 1 aforesaid; thence generally northerly along the north-western boundaries of part Lot 1, aforesaid, and Lot 4, DP 30001 to the southern side of Palliser Road; thence generally northerly by a right line to and along the middle of Palliser Road and Moeller Street to a point in line with the middle of Oriental Terrace; thence easterly to and along the middle of that road and Oriental Parade to a point in line with the middle of Hay Street; thence northerly along a right line to the mean high water mark of Wellington Harbour; thence generally easterly, southerly, and westerly along the line of the mean high water mark to the point of commencement, including all wharves and other extensions seawards.

#### WAIRARAPA

All that area bounded by a line commencing at a point on the mean high water mark in Palliser Bay in line with the north-eastern boundary of Orongorongo A1 in Block X, Pencarrow Survey District and proceeding north-westerly to and along that boundary and that of Lot 1, DP 54486 to the summit of the Rimutaka Ranges; thence generally north-easterly along that summit and that of the Tararua Ranges to Trig Station I, Mount Dundas; thence generally north-easterly along a right line between that Trig Station and a point of intersection by a right line between Trig Station I, Mt Dundas and Trig Station AA, Arawaru to a right line bearing 298° from Trig Station K, Tawhero; thence south-easterly along that right line to Trig Station K Tawhero; thence generally easterly along the southern boundary of Section 4, Block XIII, Tararua Survey District; thence south-easterly by a right line bearing 107° to the northern boundary of Part Section 9, Block IV, Mikimiki Survey District; thence south-westerly along a right line bearing 219°05' to a point in the middle of the Ruamahanga River in line with the north-western boundary of the said Part Section 9; thence generally south-easterly down the middle of the Ruamahanga River to a point in the middle of that river in line with the middle of the Masterton—Castlepoint Road; thence easterly to and along the middle of that road to a point in line with the eastern boundary of Part Section 5 Tauweru District (C.T. 330/24); thence generally southerly to and along that boundary and its production to the middle of the Tauweru River; thence generally south-westerly down the middle of that river and generally south-easterly up the middle of Pohatu Stream to a point in line with the south-western boundary of Section 2, Block XI, Otahoua Survey District; thence south-easterly to and along that boundary and the western boundary of Section 3, Block XI, Otahoua Survey District to the northwestern boundary of Lot 1 DP 49498; thence generally south-westerly along that boundary and the north-western boundaries of Lot 3, DP 22775, Part Lot 1, DP 1569, Lots 2 and 3, DP 1569 and Section 1, Block XIV, Otahoua Survey District to the southern boundary of the last mentioned section; thence easterly along that boundary and its production to the middle of Westmere Road; thence south-westerly along the middle of that road to a point in line with the south-western boundary of Section 1, Westmere Settlement; thence generally south-easterly to and along that boundary and the south-western boundary of Section 7, Westmere Settlement and its production to the middle of the Wainuioru River; thence generally easterly up the middle of that river to and generally south-easterly up the middle of the Kuamahanga Stream to a point in line with the north-western boundary of Section 7, Block VIII, Wainuioru Survey District; thence north-easterly to and along that boundary and the north-western boundary of Lot 1, DP 26422 to the northernmost point of the last mentioned Lot 1; thence southerly along the western boundary of Lot 1, DP 58263 to the northern boundary of Lot 1,

DP 13663; thence easterly along that boundary and generally easterly along the south-western boundary of Run 49 and its production (including the crossing of a road) to the middle of the Kaiwhata River; thence northerly up that river to a point in line with the southern boundary of Part Section 12, Block I, Kaiwhata Survey District; thence generally easterly to and along that boundary and the southern boundary of Lot 2, DP 10603; thence south-easterly along the south-western boundaries of Section 11, Block IV, Kaiwhata Survey District and southerly along the western boundary of Lot 1, DP 20237 and Part Lot 2, DP 20237 and its production to the middle of the Kaiwhata River; thence generally easterly down the middle of that river to its mouth; thence south-westerly, northerly and easterly along the mean high water mark of the sea coast to the point of commencement.

#### NELSON

All that area, bounded by a line commencing at a point on the low water mark on the seaward side of the Boulder Bank, in line with the north-eastern boundary of Lot 2, D.P. 10042 and proceeding thence in a south-easterly direction by a right line to and along the north-eastern boundary of the said Lot 2, D.P. 10042 to the north-western side of Atawhai Drive (SH 6); thence again south-easterly by a right line across Atawhai Drive (SH 6) to the northernmost corner of part Section 16, District of Suburban North, as shown on D.P. 3360; thence again south-easterly along the north-eastern boundary of the said part Section 16, the north-eastern boundaries of Lots 13 to 17, D.P. 6881, and the last-mentioned boundary produced across the north-eastern end of Ellendale Street to and along the north-eastern boundary of part Section 16, District of Suburban North, being the land comprised in Certificate of Title 5B/1259, to its easternmost corner; thence south-westerly along the south-eastern boundaries of part Sections 16, 15 and 14, District of Suburban North, and the last-mentioned boundary produced to the north-eastern boundary of Section 12, District of Suburban North; thence south-easterly along the north-eastern boundary of the said Section 12, to its easternmost corner; thence generally south-westerly along the south-eastern boundaries of parts Sections 12 and 11, District of Suburban North, being part of the land comprised in Certificate of Title 4C/1337 and Lot 4, D.P. 6498, to the north-eastern side of Dodson Valley Road; thence south-easterly and south-westerly along the north-eastern side and south-eastern end of the said Dodson Valley Road to the easternmost corner of Lot 1, D.P. 9928; thence south-westerly along the south-eastern boundary of the said Lot 1, D.P. 9928 to its southernmost corner; again south-westerly by a right line to the southernmost corner of part Section 8, District of Suburban North; thence north-westerly along the south-western boundary of the said part Section 8, to a point in line with the north-western boundary of Lot 1, D.P. 5647; thence south-westerly by a right line to and along that boundary to the westernmost corner of the said Lot 1, D.P. 5647, being a point on the south-eastern boundary of Lot 3, D.P. 10543; thence again south-westerly along the south-eastern boundary of the said Lot 3, D.P. 10543 and the south-eastern boundaries of Lot 13, D.P. 10853 and Lots 5, 8, 19, 9, 12, 13 and 18, D.P. 9345 to the southernmost corner of the said Lot 18, D.P. 9345; thence again south-westerly by a right line to and along the south-eastern boundary of Lot 16, D.P. 8506 to its southernmost corner; thence again south-westerly by a right line to the northernmost corner of Section 61, District of Suburban North; thence south-westerly along the north-western boundaries of the said Section 61, and Sections 60 and 59, District of Suburban North to the northernmost corner of Section 58, District of Suburban North; thence generally southerly, easterly, and northerly along the western, southern and eastern boundaries of the said Section 58 to the southernmost corner of the said Section 59; thence northerly, easterly, again northerly and again easterly along the eastern, southern and other eastern and southern boundaries of the said Section 59, to the westernmost corner of part Section 11, District of Brook Street and Maitai; thence south-easterly along the south-western boundary of the said part Section 11 and that boundary produced to the true left bank of the Maitai River; thence generally north-westerly, southerly and westerly along the true left bank of that river to the north-western corner of Section 37, Block IX, Wakapuaka Survey District; thence southerly along the western boundary of the said Section 37 to the northern boundary of Section 7, Block B, District of Wakatu; thence southerly, easterly and again southerly along the eastern, northern and other eastern boundaries of the said Section 7, and the last-mentioned boundary produced across a legal road to the north-eastern corner of Section 8, Block B, District of Wakatu; thence again southerly along the eastern boundaries of the said Section 8 and Sections 9 and 10, Block B, District of Wakatu; thence south-westerly along the south-eastern boundaries of the said Section 10 and Section 11, Block B, District of Wakatu, and the last-mentioned boundary produced across a legal road to the easternmost corner of Section 19, Block B, District of Wakatu; thence again south-westerly along the south-eastern boundaries of the said Section 19 and Sections 20 and 21, Block B, District of Wakatu, to the northernmost corner of Section 1, District of Brook Street and Maitai; thence generally south-easterly along the north-eastern boundary of the said Section 1, the north-eastern boundaries of part Section 36, Section 44 and other part of part Section
