thence south-easterly and south-westerly along the north-eastern and south-eastern boundaries of the said part Section 35, the south-eastern boundary of Rural Section 1, District of Brook Street and Maitai and the last-mentioned boundary produced through Sections 22 and 14, Square 18, to its intersection with the production of the south-western boundary of part Section 3 of 8, District of Brook Street and Maitai; thence north-westerly to and along the south-western boundary of the said part Section 3 of 8, across Lot 50, D.P. 210 and again along the south-western boundary of the said part Section 3 of 8 to its westernmost corner; thence north-easterly along the north-western boundaries of the said part Section 3 of 8 and Sections 10, 8 and 7, District of Brook Street and Maitai, to a point on the south-western boundary of Section 29, Block D, District of Wakatu; thence north-westerly along the south-western boundaries of the said Section 29 and Section 28, Block D, District of Wakatu and the last-mentioned boundary produced across the south-western end of Gramplan Road to the southernmost corner of Section 21, Block D, District of Wakatu and along the south-western boundary of the said Section 21 to the easternmost corner of part Section 6, District of Suburban South, shown on D.P. 1637; thence south-westerly along the south-eastern boundary of the said part Section 6, that boundary produced across Market Road and again along the south-eastern boundary of the said part Section 6 and the south-eastern boundaries of part Section 31, Block IV, Waimea Survey District and part Section 7, District of Suburban South, shown on D.P. 1637, to the easternmost corner of part Lot 1, D.P. 12693; thence north-westerly along the north-eastern boundary of the said part Lot 1, D.P. 12693 to its intersection with Waimea Road; thence south-westerly along the south-eastern side of the said Waimea Road and The Ridgeway to the westernmost corner of Lot 3, D.P. 12693; thence south-easterly along the north-eastern side of Enner Glynn Road to a point in line with the southern boundary of part Section 131, District of Suburban South, being part of land described in Gazette 1982, page 1755; thence south-westerly by a right line across the said Enner Glynn Road and part Section 131 to the easternmost corner of Lot 1, D.P. 2812; thence generally south-westerly along the north-western boundaries of Lot 2, D.P. 2812 to its southernmost corner; thence south-easterly by a right line across part Section VI, District of Suburban South, being part of the land comprised in Certificate of Title 28/296, to the easternmost corner of Lot 3, D.P. 3300; thence south-westerly along the south-eastern boundaries of Lot 3, D.P. 3300, and Section 102, District of Suburban South, and the production of the last-mentioned boundary to the southern side of Marsden Valley Road; thence generally north-westerly along the south-western side of Marsden Valley Road to the easternmost corner of Lot 1, D.P. 5554; thence south-westerly along the south-eastern boundaries of the said Lot 1, D.P. 5554 and part Lot 5, D.P. 2072, to the north-eastern side of Songer Street; thence north-westerly along the north-eastern side of Songer Street to a point in line with the north-western boundary of part Section 162, District of Suburban South; thence generally south-westerly by a right line across Songer Street to and along the north-western boundaries of the said part Section 162 and Section 160, District of Suburban South to the westernmost corner of the said Section 160; thence generally south-westerly by a right line across Ngawhatu Road to and along the north-western boundaries of Lot 1, D.P. 5276, Lot 1, D.P. 7328 and part Lot 2, D.P. 635 to a point in line with the production of the south-western boundary of Lot 21, D.P. 5220; thence north-westerly by a right line across Suffolk Road to and along the south-western boundary of the said Lot 21, D.P. 5220, the south-western boundaries of Lots 3 to 21, D.P. 5503, the south-western boundary of Lot 3, D.P. 5372, the south-western end of McMahon Street, the south-western boundary of Lot 4, D.P. 5372, the south-western boundary of Lot 1, D.P. 5220, and that boundary produced across Main Road Stoke (SH 6) to its north-western side; thence south-westerly along the north-western side of the said Main Road Stoke (SH 6) to the south-western corner of Lot 1, D.P. 7156; thence north-westerly along the south-western boundary of the said Lot 1, D.P. 7156, and the south-western boundaries of Lots 2 to 5, D.P. 7224, to a point on the south-eastern boundary of Section 159, District of Suburban South; thence north-easterly along the south-eastern boundary of the said Section 159 to its easternmost corner; thence north-westerly along the north-eastern boundary of the said Section 159 to the easternmost corner of part Lot 2, D.P. 1928; thence north-westerly along the north-eastern boundary of the said part Lot 2, D.P. 1928, the north-eastern boundary of part Lot 1, D.P. 2298 and that boundary produced to the middle line of Nayland Road; thence north-easterly along the middle line of Nayland Road to a point in line with the north-eastern boundary of Lot 1, D.P. 11310; thence north-westerly across Nayland Road to and along the north-eastern boundary of the said Lot 1, D.P. 11310 to its northernmost corner; thence westerly by a right line across the Waimea Inlet to Pipe XII on the southern side of Point Road, as shown on D.P.

1689; thence north-westerly by a right line bearing 299° 12', distance 132.35 metres to O.P. XIII, as shown on D.P. 1689, (being the south-western side of Point Road); thence north-easterly by a right line bearing 6°, distance 885.14 metres, to the sea coast of Tasman Bay, being a point on the seaward boundary of Section 116, District of Suburban South; thence generally north-easterly along the seaward boundaries of the said Section 116, Section 114, part Section 85 and Section 99, District of Suburban South and the seaward side of Rocks Road (SH 6) to its intersection with the production of a line bearing 123° 42', distance 284.29 metres, as shown on S.O. Plan 8460; thence north-westerly by a right line to the low water mark at Wave Point on Haulashore Island; thence generally northerly along the seaward low water mark of Haulashore Island to the training wall on the southern side of the new entrance (The Cut); thence generally north-easterly along a line at right angles to the said training wall across the new entrance (The Cut) to the low water mark on the Boulder Bank, and along the seaward low water mark of the Boulder Bank to the point of commencement.

All that area, bounded by a line commencing at the mouth of the Kahurangi River and proceeding generally south-easterly up the middle of the Kahurangi River and the south-western boundary of Block XIV, Wakamarama Survey District, to Mount Teddy; thence generally southerly along the summit of the Tasman Mountains, Peel, Arthur, Matiri, and Lyell Ranges to Bald Hill; thence generally southerly along a leading spur to the confluence of the Eight Mile or Boundary Creek with the Buller River; thence due south along a right line to the summit of the Deepdale Ridge; thence generally southerly along the said Deepdale Ridge and the Brunner and Victoria Ranges to the southern boundary of Block X, Burnett Survey District; thence easterly along the southern boundaries of Blocks X and XI, Burnett Survey District to the middle of the Maruia River; thence generally southerly up the middle of the Maruia River to a point in line with the northern side of Boundary Road; thence easterly to and along the northern side of Boundary Road, crossing SH 65, to the western boundary of Section 21, Block XVI, Burnett Survey District; thence southerly along the western boundary of the said Section 21 and southerly and easterly along the western and southern boundaries of Section 22, Block XVI, Burnett Survey District to the south-western corner of Block XIII, Matakitaki Survey District; thence easterly along the southern boundary of the said Block XIII to the summit of the eastern watershed of the Maruia River; thence generally south-easterly along that watershed to the summit of the Spenser Mountains; thence generally north-easterly along the summits of the Spenser Mountains and the St. Arnaud Range passing through Mounts Faerie Queene, Humboldt, Belvedere Peak, Mackay, Cotterell and St. Arnaud to and along the south-eastern boundary of Section 11, Block XIV, Motupiko Survey District to the south-eastern corner of the said Section 11; thence north-westerly along the north-eastern boundary of the said Section 11 to and across the end of a public road to its northern side; thence generally westerly along the northern side of the said road to its intersection with the southern side of SH 63; thence generally north-easterly along the southern side of SH 63 to the north-eastern boundary of Section 3 Square 34; thence north-westerly across SH 63 to and along the said north-eastern boundary of Section 3 to Trig. Station Top 2, situated in Block XV Motupiko Survey District; thence north-easterly along a right line to Ward Pass situated in Block XIII Rintoul Survey District; thence generally north-easterly along the summit of the Richmond Range passing through Bushy Top, Bishops Cap, and Mount Rintoul to Ada Flat; thence north-westerly approximately 1200 metres to the source of the Pelorus River on the watershed between the Pelorus and Lee Rivers; thence generally north-easterly down the middle of the Pelorus River to its confluence with Heringa Creek; thence generally north-westerly up the middle of Heringa Creek to its source and along a right line to Trig Station B, Saddle Hill, situated in Block III Maungatapu Survey District; thence generally north-easterly and northerly along the summit of the Bryant Range passing through Mount Duppa and the Rai Saddle to Trig. Station H, South Castor Peak, situated in Block I Tapumutu Survey District; thence north-westerly along the leading ridge to North Castor Peak, situated in Block VIII, Whangamoā Survey District and again north-westerly along a right line to Pukerau Point; thence generally south-westerly, north-westerly and again south-westerly along the sea coast of Tasman Bay, Golden Bay, and the Tasman Sea crossing the mouths of all harbours, inlets and rivers to the point of commencement, including all adjacent islands and excluding the Nelson Electoral District, hereinbefore described.

WEST COAST

All that area, bounded by a line commencing at the mouth of the Kahurangi River and proceeding generally southerly along the general western boundary of the Tasman Electoral District, hereinbefore described, to the summit of the Spenser Mountains; thence generally south-westerly along that summit to the summit of the Southern Alps; thence generally south-westerly along that summit to Mount Aspiring; thence north-westerly along a right line to the northernmost corner of Martins Bay Survey District, being a point
