

Cranford Street; thence south-easterly along the middle of Cranford Street to a point in line with the original north-western boundary of Lot 2, D.P. 13589; thence south-westerly to and along that original north-western boundary to the north-eastern boundary of part Rural Section 308 comprised in C.T. 20K/507; thence north-westerly and south-westerly along the north-eastern and north-western boundaries of that part rural section and the last-mentioned boundary produced across Grassmere Street to the northernmost corner of part Rural Section 308 comprised in C.T. 23B/81; thence south-westerly and south-easterly along the north-western and south-western boundaries of the last-mentioned part Rural Section 308 to and along the south-western boundaries of parts Rural Section 308 comprised in Cs.T. 392/41, 21K/289 and 143/258 and the last-mentioned boundary produced to the middle of Grants Road; thence generally south-westerly, along the middle of Grants Road, Papanui Road, Blighs Road, Wairakei Road, Ilam Road to and generally north-westerly along the middle of Brookside Terrace, Greens Road, Wairakei Road, to and generally south-westerly along the middle of Charlcott Street, Kendal Avenue, Hartford Street, Arlington Street and Kendal Avenue again to the middle of Memorial Avenue; thence north-westerly, northerly and easterly along the middle of Memorial Avenue, Russley Road and Harewood Road to a point in line with the south-eastern boundary of Lot 1, D.P. 2712; thence north-easterly to and along that boundary and the south-eastern boundary of part Lot 3, D.P. 2712 comprised in C.T. 501/245 and that boundary produced to the middle of Sawyers Arms Road; thence south-easterly, generally northerly, easterly and northerly along the middle of Sawyers Arms Road, Gardiners Road, Styx Mill Road and Main North Road (SH 1), to a point in line with the middle of the Styx River; thence generally north-easterly to and along the middle of the Styx River and its production to the middle line of the old main channel of the Waimakariri River; thence northerly along the middle line of the said old main channel of the Waimakariri River to the middle line of the main channel of that river, being a point on the southern boundary of the Rangiora Electoral District, hereinbefore described; thence easterly along that boundary to the point of commencement.

ST ALBANS

All that area, bounded by a line commencing at the middle line of Rothesay Road, at the western end of that road, being a point on the southern boundary of the Christchurch North Electoral District, hereinbefore described; and proceeding southerly along the western end of that road to the south-western corner thereof; thence south-westerly along the production of the north-western boundary of part Rural Section 32752 contained in New Zealand Gazette, 1982, page 1642, to the northernmost corner of that part Rural Section; thence generally southerly along the western boundaries of the said part Rural Section 32752, and part Lot 1, D.P. 909 contained in New Zealand Gazette, 1982, page 1642, and the last-mentioned boundary produced to the middle of Mairehau Road; thence generally south-westerly and south-easterly along the middle of Mairehau Road and Beach Road to and generally southerly along the middle of Frosts Road, Travis Road, Barkers Road, and the production of the last-mentioned middle line to the middle of the Avon River; thence westerly up the middle of that river to a point in line with the western boundary of Lot 169, D.P. 41473; thence southerly to and along that western boundary and the western boundaries of Lots 138, 139, 148, 149, 152, D.P. 41473 and the last-mentioned boundary produced across Cowes Street to and along the western boundary of Lot 153, D.P. 39361 to the westernmost corner of the last-mentioned lot; thence south-easterly and south-westerly along the north-eastern and south-eastern boundaries of Lot 38, D.P. 51100 and the last-mentioned boundary produced to the middle of Briarmont Street; thence north-westerly along the middle of Briarmont Street to a point in line with the south-eastern boundary of Lot 25, D.P. 45875; thence south-westerly to and along that boundary and the south-eastern boundary of Lot 14, D.P. 45875 to the northernmost corner of part Lot 1, D.P. 9403 comprised in C.T. 15B/685; thence westerly and southerly along the northern and western boundaries of that part Lot 1 and the last-mentioned boundary produced to the middle of Breezes Road; thence westerly along that middle line and its production to the middle of the Avon River; thence generally westerly up the middle of that river (through Kerrs Reach) and Dudley Creek and the production of the last-mentioned middle line to a point in line with the middle of Averill Street; thence generally westerly to and along the middle of Averill Street and Stapletons Road to a point in line with the middle of Guild Street; thence along the production of the last-mentioned middle line to and along the middle of Guild Street, Hills Road, Edgeware Road, Springfield Road, Holly Road to the middle of Papanui Road; thence north-westerly along that middle line to the intersection of the middle lines of Papanui Road and Blighs Road, being a point on the southern boundary of the Christchurch North Electoral District; thence northerly and easterly along the generally southerly boundary of that Electoral District to the point of commencement.

FENDALTON

All that area, bounded by a line commencing at the intersection of

the middle lines of Grahams Road and Wairakei Road being a point on the generally southern boundary of the Christchurch North Electoral District, hereinbefore described; and proceeding generally easterly along that boundary to the western boundary of the St Albans Electoral District, hereinbefore described; thence generally south-westerly along the generally western boundaries of that district and the Christchurch Central and Sydenham Electoral Districts, hereinafter described, to a point in the middle of the Heathcote River, in line with the small right lined portion of the south-eastern boundary of part Lot 1, D.P. 9987, comprised in C.T. 18K/1028; thence north-easterly to and along that boundary to the south-western boundary of part Rural Section 146 contained in New Zealand Gazette, 1981, page 220; thence north-westerly along the last-mentioned boundary to the westernmost corner of that part rural section; thence continuing north-westerly along a right line to the southernmost corner of Rural Section 41341; thence north-westerly and north-easterly along the south-western and north-western boundaries of Rural Section 41341 to the northernmost corner of that section; thence north-easterly along the middle of Wigram Road to a point in line with a line parallel to and 5 metres north-east of the south-western boundaries of Lots 39 and 3, D.P. 49364; thence north-westerly to and along that line produced, and the original middle line of Annex Road to the middle of Blenheim Road; thence northerly generally along the middle of Blenheim Road, Hansons Lane, Riccarton Road, Yaldhurst Road (SH 73), Brodie Street, Athol Terrace and Waimairi Road and its production to a point in the middle of Waimairi Stream; thence north-westerly up the middle of that stream, to the middle of Grahams Road; thence north-easterly along the middle of that road to the point of commencement.

CHRISTCHURCH CENTRAL

All that area, bounded by a line commencing at the intersection of the middle lines of Holly Road and Papanui Road and proceeding generally southerly along the middle of Papanui Road; thence westerly along the middle of Bealey Avenue and its production to the middle of the Avon River; thence generally westerly along the middle of that river to a point in line with the middle of Deans Avenue; thence southerly to and along the middle of Deans Avenue to, and generally easterly along the middle lines of Moorhouse Avenue (Part SH 1), Waltham Road (SH 1) and the Main South Railway to the middle line of Ensors Road; thence generally north-easterly along the last-mentioned middle line and the middle of Ferry Road (SH 74) and Hargood Street to the middle line of Linwood Avenue; thence north-westerly along the last-mentioned middle line to a point in line with the western boundary of Lot 1, D.P. 8825 (Bromley Cemetery); thence northerly to and along that boundary and its production to the middle line of Keighleys Road; thence generally northerly along the middle of Keighleys Road, McGregors Road, Rural Section 40295, Butterfield Avenue, Buckleys Road, Kerrs Road, and the last-mentioned middle line produced to the middle line of the Avon River; thence westerly along the middle line of that river to the southern boundary of the St Albans Electoral District, hereinbefore described; thence westerly along that boundary to the point of commencement.

AVON

All that area, bounded by a line commencing at the intersection of the middle of Rothesay Road and the mean high water mark of the South Pacific Ocean, being a point on the southern boundary of the Christchurch North Electoral District, hereinbefore described, and proceeding generally southerly along the mean high water mark of the South Pacific Ocean to a point in line with the north-western boundary of Reserve 224; thence south-easterly along a right line across the mouth of the Estuary of the Avon and Heathcote Rivers to the north-eastern corner of part Reserve 2507 contained in New Zealand Gazette, 1881 page 1482; thence southerly along the eastern boundary of that part reserve to the mean high water mark of the South Pacific Ocean; thence generally westerly along that mean high water mark and the mean high water mark of the Estuary of the Avon and Heathcote Rivers and the last-mentioned mean high water mark produced to the middle of Main Road, at McCormacks Bay; thence westerly along that middle line to a point in line with the north-westerly production of the middle line of Mt Pleasant Road; thence north-westerly along that production to the mean high water mark of the Estuary of the Avon and Heathcote Rivers; thence generally westerly along that mean high water mark and its production to a point in line with the middle line of Humphries Drive; thence generally north-westerly along that middle line and the middle line of Linwood Avenue to a point on the eastern boundary of the Christchurch Central Electoral District, hereinbefore described; thence generally northerly along that boundary and the eastern boundary of the St Albans Electoral District, hereinbefore described; to the southern boundary of the Christchurch North Electoral District, hereinbefore described; thence generally easterly along that southern boundary to the point of commencement.

SYDENHAM

All that area, bounded by a line commencing at the intersection of the middle lines of Ensors Road and the Main South Railway, being a point on the southern boundary of the Christchurch Central Electoral District, hereinbefore described, and proceeding
