Barker Road to the middle line of the Main South Railway; thence generally southerly along the middle line of the Main South Railway to a point in line with the production of the middle line of St Leonards Road, Temuka; thence generally westerly along that production to the western side of the Main South Railway; thence generally southerly along the western side of the Main South Railway to a point in line with the north-eastern side of Richard Pearse Drive, produced; thence south-easterly along that production to the western side of McNair Road; thence northerly along that roadside to a point in line with the generally southern boundary of Lot 34, D.P. 6860; thence generally north-easterly across McNair Road to and along the generally southern boundary of the said Lot 34 and south-easterly along the south-western boundary of Lot 29, D.P. 6860 to the western side of Grange Settlement Road; thence generally southerly along that roadside to a point in line with the southern boundary of part Rural Section 3152 comprised in C.T. 389/236; thence generally easterly, across Grange Settlement Road, to and along the southern boundaries of the said part Rural Section 3152, part Rural Section 3152 comprised in C.T. 440/292 and the production of the last-mentioned boundary to the middle of Factory Road; thence north-easterly along that middle line to a point in line with the southern boundary of part Rural Section 3153 comprised in C.T. 25A/47; thence generally easterly to and along the southern boundaries of the said part Rural Section 3153, Lot 40, D.P. 6860, part Rural Section 3153 comprised in C.T. 21K/110 to its intersection with the north-western boundary of part Rural Section 2483 comprised in New Zealand Gazette, 1964, page 1970, Temuka District High School; thence north-easterly along that boundary to the westernmost corner of Lot 1, D.P. 4894; thence south-easterly along the south-western boundary of that Lot and its production to the middle line of Guild Road; thence south-westerly along that middle line to the middle line of Richard Pearse Drive; thence south-easterly along that middle line to a point in line with the south-eastern side of Murray Street; thence south-westerly along that roadside to a point in line with the north-eastern side of Rawhiti Street; thence south-easterly along a production of the last-mentioned roadside to the northwestern boundary of Reserve 2558 contained in New Zealand Gazette 1883, page 253; thence generally easterly and southerly along the generally northern and eastern boundaries of the lastmentioned reserve to the middle line of Milford Clandeboye Road; thence generally easterly along that middle line to a point on the west bank of Taumatakahu Stream; thence generally westerly and southerly along the west bank of the Taumatakahu Stream and its south-easterly down the middle of the Temuka River; thence generally south-easterly down the middle of the last-mentioned river and Opihi River to the mean high water mark of the South Pacific Ocean; thence generally north-easterly along that mean high water mark to a point in line with the eastern boundary of Section 22, Maori Reserve 878 (Taumutu), Block VII, Southbridge Survey District, being a point on the southern boundary of the Selwyn Electoral District, hereinbefore described; thence generally northwesterly along that boundary to Mathias Pass on the summit of the Main Divide, being a point on the south-eastern boundary of the West Coast Electoral District, hereinbefore described; thence gen-erally south-westerly along the summit of the Main Divide to the point of commencement including all wharves and extensions seaward and all adjacent islands.
