WAITAKI

All that area bounded by a line commencing at a point on the mean high water mark of the South Pacific Ocean in line with the middle of Awamoa Central Road and proceeding generally north-westerly to and north-westerly and north-easterly along the middle of that road and Awamoa Road to a point in line with the north-eastern boundary of Lot 1, D.P. 15762; thence north-westerly to and along that boundary to the northernmost corner of Lot 1; thence north-easterly and northerly along the south-eastern and eastern boundaries of Lot 3, D.P. 5893, and the eastern boundary of Lot 11, D.P. 1617, and the production of the last-mentioned boundary to the middle of SH 1; thence generally south-westerly along the middle of that SH, and its production to the western side of the Main South Railway; thence south-westerly along the middle of No. 1 SH to the middle of White Rocks Road; thence northerly along the middle of White Rocks Road to its intersection with the southern boundary of Block III, Oamaru Survey District; thence westerly along that boundary and its production to the middle of Fortification Road; thence north-easterly along the middle of Fortification Road, Cormacks Kia Ora Road and, Ngapara Weston Road to a point in line with the eastern boundary of Lot 1, D.P. 18452; thence northerly to and along that boundary and the eastern boundary of Lot 5, D.P. 18452 and the production of the last-mentioned boundary to the south-eastern boundary of Lot 2, D.P. 4696; thence generally north-easterly along that boundary and its production to the middle of Airedale Road; thence generally northerly and westerly along the middle of Airedale Road, Oamaru Creek Road and Coal Pit Road to a point in line with the western boundary of Lot 3, D.P. 220; thence northerly to and along that boundary to the south-eastern corner of Lot 1, D.P. 7831; thence westerly along the southern boundary of that Lot 1 and north-westerly along the south-western boundaries of that Lot 1 and Section 9S, Pukenui Settlement and the production of the last-mentioned boundary to the middle of Ridge Road; thence generally westerly along the middle of Ridge Road to a point in line with the eastern boundary of Section 15A, Plunket Settlement; thence northerly to and along that boundary and its production to the middle of Ruddenklau Road; thence westerly along the middle of that road to the eastern boundary of Block V, Awamoko Survey District; thence northerly along the eastern boundaries of Blocks V and II, Awamoko Survey District to the middle of the Waitaki River; thence generally north-westerly along the middle of the last-mentioned river, Lake Waitaki, Lake Aviemore, Lake Benmore and the Ohau River to the easternmost point of Lake Ohau; thence generally northerly along the eastern shores of Lake Ohau to and along the middle of the Hopkins River and the Richardson Glacier to the summit of Mt Hopkins on the Southern Alps; thence north-easterly along the summit of the Southern Alps to McClure Peak, Block IV, Torlesse Survey District, being a common point on the south-eastern boundary of the West Coast Electoral District and the south-western boundary of the Ashburton Electoral District, hereinbefore described; thence south-easterly along the south-western boundary of that Electoral District to the intersection of the middle of the Temuka River and the Opihi River, being a point on the north-eastern boundary of the Timaru Electoral District, hereinbefore described; thence generally north-westerly, southerly and south-easterly along the north-eastern, western, and south-western boundaries of that Electoral District, to the mean high water mark of the South Pacific Ocean; thence generally southerly along that mean high water mark to the point of commencement.

OTAGO

All that area, bounded by a line commencing at Mt Hopkins on the summit of the Southern Alps and proceeding generally south-westerly along that summit passing through Mt McKerrow, Mt Humphries, Mt Nihokohatu, Mt Ward, Mt Jackson, Mt Strauchon, Mt Maitland, Hassing Peak, Mt Holdsworth, Mt Enderby, Mt Tole, Mt Wray, Mt Brewster, Mt Kaye, Haast Pass, Mt Cross East Peak, Lindsay Peak, West Peak, The Keystone, Mt Kinross, Mt Burke, Mt Cameron, Mt Stuart, Mt Bertha, Mt Actor, Eyetooth, Misty Peak, Foggy Top, Young Peak, Governors Pass, Mt Doris, Siberia Saddle, Mt Dreadful, Stewart Pass, Trident Peak, Mt Alba, Newland Pass, The Sentinel, Mercury Peak, Apollo Peak, Pollux, Chasm Pass, Mt Ragan, Mt Taurus, Pearson Saddle, Pickelhaube Peak, Fastness Peak, Moncrieff Peak, Aeroplane Peak, Charybdis, Scylla and Popes Nose to Mount Aspiring; thence north-westerly along a right line between Mount Aspiring and the northernmost corner of Martins Bay Survey District to the intersection of that right line and the watershed between the Cascade and Pyke Rivers on the summit of the Red Hill Range, Humboltside Survey District; thence generally south-easterly along that watershed to Simonin Pass; thence southerly along a right line to the confluence of Limbo Stream and the Cascade River; thence southerly along the middle of Limbo Stream to a point in line with the leading north-westerly ridge from Picador, situated in Humboltside Survey District; thence south-easterly to and along that leading ridge to Picador; thence easterly along the watershed of Retreat Creek

and Limbo Stream passing through Matador to Toreador Peak on the summit of the Olivine Range; thence generally south-westerly along the summit of the Olivine Range passing through Persephone Col, Typhoon Peak, Holloway Peak, Mount Temple, Invitation Col, Trinity, Trinity Pass, Gyrae, Darkness Peak, Pic d'Argent, Pic d'Argent Col, Little Ark, The Tower, Intervention, Forgotten River Col, Blockade Peak, Key Rock, Mount Gates and Possibility Col to Albert Peak on the summit of the Barrier Range; thence generally south-westerly along the watershed of the Forgotten and Dart Rivers passing through Betty Peak, Mallory Peak and Irvine Peak to Terminal Peak; thence south-westerly along a right line to Brenda Peak; thence generally south-westerly along the watershed of the Holyford and Dart Rivers, passing through Fohn Peak, Fohn Saddle, Tantalus Peak, Niobe Peak, Poseidon Peak, Park Pass, Nereus Peak, North Col, Conical Hill, Harris Saddle, Trig N, Ocean Peak and Emily Pass to Emily Peak; thence generally south-westerly along the main ridge of the Ailsa Mountains to a point due east of the Greenstone Saddle; thence due west through that Saddle to the summit of the Livingstone Mountains; thence southerly along that summit to the north-western corner of Run 756, situated in Upper Wakatipu and Von Survey Districts; thence generally southerly and south-easterly along the generally western and south-western boundaries of Run 756 aforesaid, to an unnamed peak at grid reference 119780 (NZMS 1, S131); thence south-easterly along a right line to an unnamed peak at the grid reference 131765 (NZMS 1, S131); thence generally south-easterly along the watershed of the Mararoa and Greenstone Rivers to the summit of the Thomson Mountains; thence generally southerly along that summit through grid reference 240636 (NZMS 1, S131), to the unnamed peak at grid reference 176549 (NZMS 1, S131); thence generally southerly along the watershed between the Oreti and Von Rivers passing through Trig L Mount Lookup, and Trig J, Block X, Mavora Survey District, to Hummock Peak; thence south-easterly, easterly and north-easterly along right lines to Jane Peak, Eyre Peak and James Peak situated in Nevis Survey District; thence generally southerly along the summits of the Hector Mountains and the Slate Range, passing through Trig F, Block V, Lorn Survey District, Lorn Peak, and Tennants Peak to its intersection with the middle of the Garston Nevis Road; thence north-easterly along the middle of that road to a point in line with the northern boundary of Run 323C situated in Block VI, Kingston Survey District; thence north-easterly to and along that boundary to the north-eastern corner of that Run 323C; thence south-easterly along a right line to Trig J, Mount Tennyson, situated in Block III, Rockside Survey District; thence generally easterly along the watershed between the Nevis, Waikaitia and Nokomai Rivers to Trig K, Block IV, Rockside Survey District; thence north-easterly along right lines through Trig H to Trig D Obelisk Survey District; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of Run 626 to the northern boundary of Run 249A; thence generally north-easterly along that boundary and its production to the middle of the Fraser River; thence north-easterly down the middle of the Fraser River to its intersection with the middle of the Hawks Burn; thence north-westerly up the middle of the Hawks Burn to its intersection with the south-western boundary of Run 249; thence north-westerly and north-easterly along the south-western and north-western boundaries of Run 249 and Part Section 4 and the production of the last-mentioned boundary to the middle of the Clutha River; thence generally north-westerly up the middle of the Clutha River to a point in line with the southern boundary of Section 154 Block I, Cromwell Survey District; thence generally easterly to and along that boundary and the southern boundaries of Section 16, Block VI, Section 1, Block XVI and Section 1, Block XV, Wakefield Survey District to the southernmost corner of the last-mentioned section; thence north-easterly along the south-eastern boundaries of Section 1, Block XV and Section 1, Block XII, Wakefield Survey District to a point in line with the south-western boundary of Run 238N; thence south-easterly to and along the south-western boundaries of Run 238N and Section 3, Block XIV, Wakefield Survey District to the northernmost corner of Section 3, Block I, Lauder Survey District; thence south-westerly along the north-western boundaries of Sections 3 and 1, Block I, aforesaid and Sections 2 and 1, Block III, Tiger Hill Survey District to the westernmost corner of Section 1, aforesaid; thence generally south-easterly along the southern boundaries of Sections 1 and 9, Block III, Tiger Hill Survey District to the southernmost corner of Section 9 aforesaid; thence southerly along the eastern boundaries of Blocks III and VII Tiger Hill Survey District to the middle of SH 85; thence north-easterly along the middle of SH 85 to a point in line with the middle of an unnamed road forming the northern boundary of Part Run 223G; thence south-easterly to and along the middle of that road and its production to the middle of the Manuherikia River; thence generally south-easterly along the eastern boundary of Block XXII and the northern and eastern boundaries of Block XIX Tiger Hill Survey District to a point in line with the north-western boundary of Section 13, Block XIX aforesaid; thence south-westerly to and along that boundary and easterly along the southern boundary of that section to the northernmost corner of Section 14, Block XIX aforesaid; thence south-westerly along the north-western boundary of that section to its westernmost corner;
