

thence south-westerly along a right line to the north-western corner of Cairnside Survey District; thence southerly along the western boundary of Cairnside Survey District to the northern boundary of run 567; thence generally southerly along the northern and eastern boundaries of Runs 567 and 641 to the north-western side of a road intersecting Section 1, Block IX, Long Valley Survey District; thence due east to the middle of that road; thence generally south-easterly and north-easterly along the middle of that road to a point due east of Trig C on the eastern boundary of Section 1, Block IX, Long Valley Survey District; thence due west to that trig; thence generally north-easterly, easterly, south-easterly, and south-westerly along the summit of a leading ridge and the middle of the unnamed road along the ridge passing through Runs 810 and 566, Trig Y in Section 1, Block VII Trig F in Section 1, Block XII, Trig D, Bottle Rock, all situated in Long Valley Survey District, and Trig Q, Davidsons Top, in Run 656 and Run 658, all situated in St. Abbs Survey District to Trig H Lammerlaw Top, on the Lammerlaw Range; thence generally south-easterly along the middle of an unnamed road on the summit of the Lammerlaw Range to Trig G, Block III, Hedgehope Survey District; thence north-easterly along the middle of that unnamed road to a point in line with the generally north-western boundary of Section 15, Block IV, Hedgehope Survey District; thence north-easterly to and along that boundary to the northernmost corner of that section; thence southerly along the eastern boundary of that section and its production to the middle of an unnamed road forming the northern boundary of Section 21, Block IV, Hedgehope Survey District; thence south-easterly and north-easterly along the middle of that road to a point in line with the generally south-western boundary of Section 26, Block VII, Lee Stream Survey District; thence generally south-easterly to and along that boundary and the south-western boundary of Lot 2, D.P. 17864 and its production to the middle of Lee Stream; thence generally south-easterly down the middle of that stream to the confluence of Lee Stream and the Taieri River, situated on the north-western boundary of Block I, Dunedin and East Taieri Survey District; thence generally north-easterly up the middle of the Taieri River to a point due west of Trig S, Swampy Spur; thence due east to Trig S; thence southerly along the eastern boundary of Section 3 Block V, Dunedin and East Taieri Survey District, and its production to the northernmost corner of Section 8 Block V, aforesaid; thence south-westerly along the south-eastern boundaries of Sections 11, 10 and 9, Block V, aforesaid, and the production of the last-mentioned boundary to the middle of Cedar Road; thence north-westerly along the middle of that road to a point in line with the eastern boundary of Section 55 Block V, aforesaid; thence southerly to and along the eastern boundaries of Sections 55 and 54 Block V, Dunedin and East Taieri Survey District, to the southernmost corner of the last-mentioned section; thence south-easterly along the north-eastern boundary of Section 53 Block V, aforesaid, to the easternmost corner of that section; thence south-easterly along the south-western boundary of Lot 2, D.P. 7092 and its production, and Lot 1, D.P. 7092 and north-easterly along the south-eastern boundary of that Lot 1 to the south-western side of Finnerty Road; thence generally south-easterly and north-easterly along the south-western and south-eastern sides of Finnerty Road to the south-western boundary of Section 73, Block V, Dunedin and East Taieri Survey District; thence south-easterly along the south-western boundary of that section to its southernmost corner; thence due east to the right bank of the Water of the Leith and generally northerly along that bank to a point in line with the south-western boundary of Lot 2, D.P. 5108; thence north-westerly to and along that boundary and north-easterly along the north-western boundaries of that Lot 2 and Sections 82 and 83, Block V, Dunedin and East Taieri Survey District, to the northernmost corner of the last-mentioned section; thence due east to the western boundary of Section 4, Block VIII, North Harbour and Blueskin Survey District; thence south-easterly along the south-western boundary of that section to its southernmost corner; thence north-easterly along the south-eastern boundary of Section 4, aforesaid, and its production to the easternmost corner of part Section 1, Block VIII, aforesaid; thence south-easterly along the production of the north-eastern boundary of part Section 1, aforesaid, to the middle of Cowan Road; thence north-easterly along the middle of that road to a point in line with the south-western boundary of Section 61, Block VIII, aforesaid; thence north-westerly in line with that boundary to the south-eastern boundary of Lot 3, D.P. 12466; thence north-easterly along the south-eastern boundary of Lot 3, aforesaid, to the northernmost corner of Section 61, Block VIII, aforesaid; thence south-easterly and north-easterly along the south-western and south-eastern boundaries of Section 62, Block VIII, aforesaid to the westernmost corner of Lot 7, D.P. 18407; thence south-easterly, north-easterly and again south-easterly along the south-western boundary of Lot 7, D.P. 18407 and the south-western, south-eastern, and again south-western boundaries of Part Section 48, Block VIII, aforesaid and the production of the last-mentioned boundary to the north-western boundary of Section 369R, Block VII, North Harbour and Blueskin Survey District; thence south-westerly along that boundary to a point in line with the north-eastern boundary of Lot 7, Block II, D.P. 253; thence south-easterly to and along the north-eastern boundary of that lot and the north-

eastern boundaries of Lots 6, 5, 4, and 1, Block II, D.P. 253, to the easternmost corner of the last-mentioned lot; thence south-westerly along the south-eastern boundary of Lot 1, Block II, D.P. 253, to a point in line with the south-western boundary of Lot 5, D.P. 5250; thence south-easterly to and along the south-western boundary of that lot and its production to the north-western boundary of Section 2 of 4, Block IX, North Harbour and Blueskin Survey District; thence south-westerly and south-easterly along the north-western and south-western boundaries of that section to the northernmost corner of part Section 2 of 5, Block IX, North Harbour and Blueskin Survey District; thence south-westerly along a right line between that corner and Trig Station E (Signal Hill) to its intersection with the south-western boundary of part Section 2 of 5, aforesaid; thence south-easterly along the south-western boundaries of that section and Section 63, Block IX aforesaid to the north-western boundary of Section 13, Upper Harbour West Survey District; thence south-westerly and south-easterly along the north-western and south-western boundaries of that Section 13 and the production of the last-mentioned boundary to the south-eastern boundary of the area vested in the Otago Harbour Board by the Otago Harbour Board Land Vesting Act 1910; thence generally north-easterly along that boundary to its intersection with the production of the south-eastern side of Station Road; thence north-westerly along that production to the high water mark of the Otago Harbour; thence generally north-easterly along the high water mark of the Otago Harbour to a point in line with the south-western boundary of Section 448 Town of Port Chalmers; thence north-westerly to and along that boundary to the north-western corner of that Section 448; thence north-westerly along a right line to the intersection of the production of the south-western boundary of Section 3, Lower Harbour West Survey District with the mean high water mark of the Otago Harbour; thence generally north-easterly along the mean high water mark of the Otago Harbour and the sea to a point in line with the middle of Awamoa Central Road; being a common point on the boundary of the Waitaki Electoral District, hereinbefore described; thence generally north-westerly along the generally south-westerly boundary of that Electoral District to Mount Hopkins, being the point of commencement and also including Goat Island and Quarantine Island and all wharves and extensions seawards.

#### DUNEDIN WEST

All that area, bounded by a line commencing at Trig Station S (Swampy Spur), Block III, North Harbour and Blueskin Survey District and proceeding due west to the middle of the Taieri River; thence generally south-westerly down the middle of that river to a point in line with the north-eastern boundary of Section 11, Block I, Dunedin and East Taieri Survey District; thence south-easterly to and along that boundary and the north-eastern boundary of Section 12, Block I, aforesaid, and its production to the middle of an unnamed road; thence generally southerly along the middle of that road to its intersection with the middle of Taieri View Road; thence south-easterly along a right line to the northernmost corner of Lot 11, D.P. 15058; thence generally south-westerly along the north-western and south-western boundaries of Lot 11, aforesaid, to the north-western boundary of Lot 9, D.P. 15058; thence south-westerly and south-easterly along the north-western and south-western boundaries of Lot 9, aforesaid, and the production of the last-mentioned boundary to the middle of Tirohanga Road; thence north-easterly along the middle of that road to a point in line with the south-western boundary of Lot 2, D.P. 15054; thence south-easterly to and along that boundary, the south-western boundary of Lot 1, D.P. 11976 and the production of the last-mentioned boundary to and along the south-western boundaries of Lots 1 and 2, D.P. 10709, and the production of the last-mentioned boundary to the middle of SH 87; thence south-easterly along the middle of that State Highway to a point in line with the north-western boundary of part Section 1, Block VII, East Taieri Survey District; thence south-westerly to and along that boundary and the south-eastern boundaries of part Sections 8, 9, 10, Block VII, aforesaid, to the intersection of the last-mentioned boundary with the middle of the Silver Stream; thence generally westerly down the middle of that stream to its intersection with north-eastern boundary of part Lot 19, D.P. 1846; thence south-easterly along the north-eastern boundaries of part Lots 19 and 20, D.P. 1846, part Section 5, Block VII, East Taieri Survey District, and the production of the last-mentioned boundary to the westernmost corner of Lot 1, D.P. 17203; thence south-easterly and north-easterly along the south-western and south-eastern boundaries of Lot 1, aforesaid, to the easternmost corner of that lot; thence south-easterly along the north-eastern boundaries of part Sections 9 and 3, Block III, East Taieri Survey District and the production of the last-mentioned boundary to the middle of Gladstone Road; thence south-westerly along the middle of Gladstone Road to a point in line with the south-western boundary of Lot 1, D.P. 15155; thence south-easterly to and along that boundary and the south-western boundaries of Lot 1, D.P. 10036 and Lot 2, D.P. 10404 to the southernmost corner of the last-mentioned lot; thence south-easterly along the north-western boundary of Lot 2, D.P. 16408 to the westernmost corner of Lot 2, aforesaid; thence south-easterly along the south-western boundaries of Lot 2, D.P. 16408, Lot 4, D.P. 7572, Lot 3, D.P. 18406, Lot 2, D.P. 19585,
