HOBSON

All that area bounded by a line commencing at the intersection of the line of mean high water of the Tasman Sea and the middle of the mouth of the southern branch of the Waipoua River, Block V, Waipoua Survey District, and proceeding easterly generally along the boundaries of the Bay of Islands Electoral District hereinbefore described to its intersection with the line of mean high water of the South Pacific Ocean; thence southerly generally along that line of mean high water, crossing the mouths of, the Whangaruru Harbour and the Whangarei Harbour and other inlets and including Lots 1 and 2, DP 62492, an area coloured pink as shown on SO Plan 23413, 3.7358 hectares (9a-0r-37p), and an area coloured pink as shown on SO Plan 24253, 3.5423 hectares (8a-3r-0.5p), Block VIII, Ruakaka Survey District, to a point due east of the southern boundary of Allotment 350, Ruakaka Parish; thence westerly along a right line, to and along the last-mentioned southern boundary and that boundary produced across Section 50, Block XIV, Ruakaka Survey District to its intersection with the middle of SH 1; thence northerly along the middle of SH 1 to a point in line with the southern boundary of Lot 1, DP 71747; thence westerly along a right line, to and along the last-mentioned southern boundary and the southern boundary of Lot 1, DP 45683, and the last-mentioned boundary produced to the middle of Doctors Hill Road; thence southerly along the middle of Doctors Hill Road to its intersection with the middle of Mountfield Road, Block XIV, Ruakaka Survey District; thence westerly along the middle of Mountfield Road to a point in line with the eastern boundary of part Allotment 81, Ruakaka Parish; thence southerly along a right line, to and along the last-mentioned boundary, to and westerly along the southern boundaries of that part Allotment 81, Allotment 144, part Allotment 59, Allotment SW 58, all the aforesaid Allotments being in Ruakaka Parish, and that boundary produced across Lot 1, DP 29180 and Mountfield Road, to and along the southern boundaries of part Allotment 75, Allotment 37, along a right line across an unnamed legal road, to and along the southern boundaries of Allotment SE 36, Allotment NW 36, and Allotment 35, all the aforesaid Allotments being in Ruakaka Parish to the northernmost corner of Lot 1, DP 1578; thence south-westerly along the north-western boundary of an area of Crown Land forming the north-western boundary of Lot 1, DP 1578, crossing the intervening Ormiston Road, to and along the north-western boundaries of Allotment 222 and Allotment 245, Waipu Parish to the westernmost corner of the last-mentioned Allotment 245; thence north-westerly along the north-eastern boundaries of Allotments 195, 550, 391 and 496, Waipu Parish, Lot 1, DP 44520, part Allotments 389 and 327, Waipu Parish, to and south-westerly along the north-western boundary of Allotment 327, Waipu Parish and the last-mentioned boundary produced to its intersection with the middle of Waipu Caves Road, Block IX, Ruakaka Survey District; thence northerly generally along the middle of Waipu Caves Road, to and along the middle of an area marked A, as shown on SO Plan 50924, 1.1019 hectares, to and along the middle of Mangapai Caves Road, to and along the middle of an area marked F, as shown on SO Plan 59643, 3157 square metres, to and again along the middle of Mangapai Caves Road, to a point in line, with the middle of Tauraroa River; thence northerly generally along a right line, to and down the middle of the said river to a point in line with Peg III as shown on SO Plan 3060; thence north-easterly along a right line to that Peg III and along the middle of Monk Road to its intersection with the middle of McCullough Road; thence westerly generally and northerly generally along the middle of McCullough Road to its intersection with the middle of Mangapai Road; thence easterly along the middle of Mangapai Road to a point in line with Paneiraira Creek; thence westerly generally along a right line, to and up the middle of the Pareiraira Creek to a point in line with the north-western boundary of Allotment 2A, Mangapai Parish (now part of Lot 2, DP 93727), Block IX, Tangihua Survey District, and along a right line, to and along the last-mentioned boundary and the north-western boundary of part Allotment 2, Mangapai Parish, crossing the intervening North Auckland Railway and along a right line across Ormandy Road, to and along the southern boundary of part Allotment 79, Maungakaremea Parish and the said boundary to its intersection with the middle of the Tauraroa River; thence south-westerly generally up the middle of the said river and up the middle of the river as shown on SO Plan 766 and continuing up that river, crossing the intervening Tawaroa Road, Omana Road, Kaitaringa Road, Pikiwahine Road, to and up the middle of Manganui River to its intersection with the middle of Mititai Road, and along the middle of Mititai Road, to and along the middle of Allotment 228, Okahu Parish, to and along the middle of Tokatoka Road to a point in line with the northern boundary of an area coloured blue as shown on SO Plan 41817, 296 square metres (11.7 perches); thence easterly along a right line to the northernmost corner of the last-mentioned area coloured blue; thence south-westerly generally along a right line, to and along the generally southern boundaries of an area of closed road, coloured green as shown on SO Plan 41817, 5.7895 hectares (14a-1r-9p), to and along the generally north-western boundaries of part Allotment

167A, Oamaru Parish, to and along a right line and continuing along the generally south-eastern boundary of an area coloured blue as shown on SO Plan 18062, 1.6137 hectares (3a-3r-38p) to its southernmost corner; thence north-westerly and southerly along the north-eastern and western boundaries of an area coloured blue as shown on SO Plan 18062, 2.5207 hectares (6a-0r-36.6p), to the easternmost corner of Allotment NW 36, Tokatoka Parish as shown on SO Plan 3035A; thence north-westerly along the north-eastern boundaries of that last-mentioned Allotment to the easternmost corner of Allotment SE 30, Okahu Parish, Block IV, Tokatoka Survey District; thence south-westerly along the south-eastern boundaries of Allotments SE 30, SE 29 and 226, along a right line across Tokatoka Road, to and along the south-eastern boundaries of part Allotment 34A and part Allotment 204, along a right line across Dreadon Road, to and along another part Allotment 204, and Allotments 205 and 203, along a right line across Tokatoka Road, to and along the south-eastern boundary of Allotment 20, all the aforesaid Allotments being in Okahu Parish, to its intersection with the north-western boundary of part Allotment N 30, Tokatoka Parish, Block VII, Tokatoka Survey District, and along the last-mentioned boundary and that boundary produced to its intersection with the middle of Tokatoka Road, and along the middle of Tokatoka Road, to and along the middle of Allotment 113, Tokatoka Parish, to and again along the middle of Tokatoka Road, to and along the middle of an unnamed legal road forming the southern boundaries of Allotments 31, NE 18 and SW 18, Whakahara Parish, to its intersection with the middle of Evan Road; thence north-westerly along the middle of Evan Road to a point in line with the north-western boundary of Allotment NE 12, Tokatoka Parish; thence south-westerly along a right line, to and along the last-mentioned boundary and that boundary produced to its intersection with the middle of an unnamed legal road forming the southern boundaries of Allotments 1 and 17, Whakahara Parish, and along the middle of that unnamed legal road and that middle line produced across SH 12 and the Wairoa River to the right bank of that river being the line of mean high water, Block VI, Tokatoka Survey District; thence southerly generally along that line of mean high water of the Wairoa River, to and along the line of mean high water of the Kaipara Harbour, to and northerly along the line of mean high water of the Tasman Sea to the point of commencement and including the Poor Knights Islands, the Mokohinau Islands, Hen and Chicken Islands and other adjacent islands, and excluding the Whangarei Electoral District hereinbefore described.

KAIPARA

All that area bounded by a line commencing at the intersection of the line of mean high water of the South Pacific Ocean and a point due east of the southern boundary of Allotment 350, Ruakaka Parish, Block XIV, Ruakaka Survey District and proceeding westerly generally, to and along the boundaries of the Hobson Electoral District hereinbefore described to its intersection with the left bank of the Wairoa River, Block VI, Tokatoka Survey District; thence south-easterly generally along that left bank of the Wairoa River, crossing the mouth of the Awaroa River, to and along the southern boundary of an area of mangroves, as shown on SO Plan 13791, to and along the southern boundary of Burgess Island, and again across another mouth of the Awaroa River, to and along the line of mean high water of the Kaipara Harbour, crossing the mouths of the Arapaoa River, the Otamatea River and the Whakakiki River, to and north-easterly generally along the line of mean high water of the Oruawhoro River, crossing the mouth of the Kaira Creek, to and along the southern side of Oruawhoro School Road, Block X, Otamatea Survey District, to and south-westerly generally along the line of mean high water of the Oruawhoro River, to and south-easterly generally along the line of mean high water of the Kaipara Harbour, crossing the mouths of the Otekawa Creek and the Waikiri Creek, and excluding Section 2, part Section 3, Sections 7, 8, 4, 6 and 5, all aforesaid Sections being in, Block III, Tauhoa Survey District, to and again along the line of mean high water of the Kaipara Harbour, crossing the mouth of the Makarua River, to and along the line of mean high water, as shown on ML Plan 3704, SO Plans 30273, 48767, 31287 and 3, Block VI, Kaipara Survey District, to and south-westerly and north-westerly generally along the line of mean high water of the Kaipara Harbour, crossing the mouths of the Kaipara River, the Upokonui Creek, the Puharakeke Creek, the Parakawa Creek and the Mairaitahi Creek, to and along the line of mean high water, as shown on SO Plan 715A, to and southerly generally along the line of mean high water of the Tasman Sea to its intersection with the middle of Okiritoto Stream, Block VIII, Kumeu Survey District; thence north-easterly generally up the middle of that stream and Raurataua Creek to a point due west of peg VII, as shown on SO Plan 18990, Block IX, Kumeu Survey District; thence due east along a right line to peg VII aforesaid, to and south-easterly along the middle of an area coloured red, as shown on SO Plan 18990, 9323 square metres, (2a-1r-8.6p), to and south-westerly along the middle of Murawai Road to its intersection with the middle of Valley Road; thence south-easterly generally along the middle of Valley Road to its intersection with the middle of Cable Road; thence north-easterly generally along the middle of Cable Road to its intersection with the middle of Hinau Road; thence northerly
