

SCHEDULE B

DESCRIPTIONS OF THE BOUNDARIES OF THE
MAORI ELECTORAL DISTRICTS

NORTHERN MAORI

All that area bounded by a line commencing at a point on the line of mean high water of the Tasman Sea at the North Head of the Manukau Harbour, Block VI, Waitakere Survey District and proceeding north-westerly, easterly and south-easterly generally along the line of mean high water of the Tasman Sea and the South Pacific Ocean, crossing the mouths of the Kaipara Harbour, the Waipoua River, the Wairau River, the Waimamaku River, the Hokianga Harbour, the Whangape Harbour, the Hekekinu Harbour, the Parengarenga Harbour, the Houhora Harbour, the Ranganu Harbour, the Taipa River, the Manganui Harbour, the Whangaroa Harbour, the Tauranga Stream, the Takou River, the Tahoranui River, and Tapuetahi Creek to a point due west of the westernmost extremity of Harakeke Island, Block IX, Bay of Islands Survey District; thence due east along a right line to that westernmost extremity of Harakeke Island, and continuing easterly along the generally northern shores of that island to the easternmost extremity of that island, and along a right line to the northernmost extremity of Piery Island (Motukokako); thence southerly generally along the eastern shores of that island, to and along a right line, to the easternmost extremity of Section 2, Block XIII, Bay of Islands Survey District, and continuing south-easterly generally along the line of mean high water of the South Pacific Ocean, crossing the mouths of the Whangaruru Harbour, and the Whangarei Harbour and all other inlets, and including Lots 1 and 2, DP 62492, an area coloured pink, as shown on SO Plan 23413, 3.7358 hectares, (9a-0r-37p), and an area coloured pink, as shown on SO Plan 24253, 3.5423 hectares (8a-3r-0.5p), Block VIII, Ruakaka Survey District, and continuing along that line of mean high water of the South Pacific Ocean, crossing the mouths of the Waipu River, the Wairahi Stream, the Mangawhai Harbour, the Pakiri River, and excluding Cape Rodney, Okakari Point Marine Reserve, as shown on SO Plan 58975, 547.0000 hectares, Block I, Rodney Survey District, crossing the mouths of the Kohuroa Stream and the Whangateau Harbour, the Matakana River, the Mahurangi Harbour, the Te Muri o Tarakiki Stream and the Puhoi River, excluding part Section 1, Block IV, Waiwera Survey District, crossing the mouths of the Waiwera River, the Orewa River, Weiti River and the Okura River and continuing south-easterly along that line of mean high water, crossing the mouth of the Wairau Creek to the northernmost corner of Lot 17, DP 7449; thence easterly along the production of the northern boundary of the last-mentioned Lot 17, to and south-easterly along the line of mean low water of the Hauraki Gulf, to and south-easterly and south-westerly generally along the generally north-eastern and south-eastern boundaries of Endowment Land, as shown on DP 1009, (comprised in Certificate of Title 63/74), Block VI, Rangitoto Survey District, to and south-easterly across the mouth of the Waitemata Harbour to the northernmost extremity of Section 18, (Bastion Rock, Recreation Reserve), Block IX, Rangitoto Survey District, along the eastern boundaries of the last-mentioned Section 18, to and easterly along the line of mean high water of the Waitemata Harbour to a point due west of the northernmost extremity of Allotment 410, Pakuranga Parish, (Musick Point), Block X, Rangitoto Survey District, along a right line due east to its intersection with the middle of the Tamaki River; thence south-westerly generally up the middle of the Tamaki River, to and south-easterly up the middle of the Otara Creek, up the middle of a tributary of the Otara Creek to a point in line with the north-easternmost boundary of Lot 159, DP 51623, (Recreation Reserve), along a right line, to and along that north-eastern boundary to the westernmost corner of Lot 170, DP 51623; thence north-easterly along the north-western boundaries of that last-mentioned Lot 170, and Lots 171 and 172, DP 51623 to the northernmost corner of the last-mentioned Lot 172; thence south-easterly generally along the north-eastern boundaries of Lots 173, 174, and 176, DP 51623, to and easterly along the northern boundaries of Lots 185, 188 and 189, DP 51623, Block VII, Otahuhu Survey District, and that last-mentioned boundary produced to its intersection with the middle of Springs Road; thence southerly along the middle of Springs Road, East Tamaki Road and Preston Road, and continuing south-westerly along the middle of Preston Road, crossing the intervening Auckland-Hamilton Motorway, to and along the middle of Reagan Road and Puhinui Road to a point in line with the south-western boundary of Lot 4, DP 41167; thence south-easterly along a right line, to and along that last-mentioned south-western boundary of Lot 4 and Lots 23, 24, 25, 26 and 32, DP 61877, to and south-westerly along the north-western boundaries of Lot 1, DP 60601, and Lot 11, DP 63401, to the northernmost corner of part Clendon's Grant, (comprised in Certificate of Title, 1521/23, cancelled); thence south-easterly along the north-eastern boundaries of the last-mentioned part of Clendon's Grant, and that boundary produced to its intersection with the middle of Puhinui Stream; thence south-westerly generally down the middle of the aforesaid stream, to and down the middle of part Old Bed

Puhinui Stream, as shown on SO Plan 57297, to and again down the middle of the aforesaid stream, crossing the intervening Plunket Avenue, to its intersection with the north-western boundary of an area marked G, as shown on SO Plan 55517, 268 square metres, to and along the north-western boundary of that area marked G, and along the north-western boundary of an area marked D, as shown on SO Plan 55517, 687 square metres to its intersection with the north-eastern side of the North Island Main Trunk Railway; thence north-westerly along the north-eastern side of that railway to a point in line with the north-western boundary of Section 29, Block X, Otahuhu Survey District; thence south-westerly along a right line to its intersection with the middle of the aforesaid railway; thence north-westerly along the middle of that railway to a point in line with the north-western boundary of Lot 148, DP 43645, Block VI, Otahuhu Survey District; thence north-easterly along a right line, to the westernmost corner of the last-mentioned Lot 148; thence north-westerly generally along the generally south-western boundaries of Lot 240, DP 43645 to the north-eastern corner of Section 37, Block VI, Otahuhu Survey District, along the north-eastern boundary of that Section 37, and that boundary produced to its intersection with the middle of the North Island Main Trunk Railway; thence northerly along the middle of that railway, crossing the intervening Massey Road, and that middle line produced to the middle of Portage Road; thence south-westerly along the middle of Portage Road to its intersection with the eastern boundary of an area coloured green, as shown on SO Plan 23535, 1315 square metres (0a-1r-12p); thence northerly along the last-mentioned eastern boundary, to and along the eastern boundaries of an area of Railway Land, as shown on SO Plan 23535, 1.8919 hectares, (4a-2r-28p), to its northernmost corner; thence westerly along the northern boundary of the last-mentioned area of Railway Land, to and along the eastern and northern boundaries of Section 28, Block VI, Otahuhu Survey District to its intersection with the western side of the North Island Main Trunk Railway; thence northerly along the western side of that railway, to and along the left bank of Anns Creek to its intersection with the western boundary of part Buckland's Grant, as shown on DP 11884, along that western boundary, to and along the north-western boundary of the last-mentioned part Buckland's Grant, to a point in line with the eastern boundary of Lot 3, DP 50674; thence northerly along a right line, to and along that eastern boundary to its northernmost corner; thence north-easterly generally along the south-eastern boundaries of Lot 2, DP 50674 and Section 58, Block VI, Otahuhu Survey District, along the eastern boundaries of that Section 58, to and along the north-western boundary of part Buckland's Grant, as shown on DP 27058, and the last-mentioned boundary produced to its intersection with the middle of Great South Road; thence northerly along the middle of Great South Road to a point in line with the right bank of Anns Creek; thence westerly generally along a right line, to and along that right bank of Anns Creek and the line of mean high water of the Manukau Harbour to the north-eastern corner of Lot 1, DP 105353, Block V, Otahuhu Survey District; thence southerly along the eastern boundaries of that Lot 1 and Lot 1, DP 98342 to the south-eastern corner of that Lot 1; thence westerly generally along the generally southern boundaries of that last-mentioned Lot 1, part Lot 2 and Lots 4 and 3, DP 90270, Lot 1, DP 26531, Allotment S 45, Small Lots Near Onehunga, Lots 6, 2 and part Lot 1, DP 25356, the southern end of Alfred Street, Lot 19, DP 61642, and again that part Lot 1, DP 25356 to the south-western corner of that part Lot 1; thence southerly and easterly along the eastern and southern boundaries of Lot 1, DP 78168, and that southern boundary produced to the western side of Mangere Bridge (SH 20); thence southerly along the last-mentioned side of Mangere Bridge to its intersection with the southern boundary of Lot 2, DP 20709; thence westerly along the generally southern boundaries of that Lot 2 and Sections 7 and 2, Block V, Otahuhu Survey District to the south-western corner of that last-mentioned Section 2; thence northerly along the western boundaries of the last-mentioned Sections 2 and 7, and the western boundary of part Tidal Lands, Manukau Harbour, as shown on SO Plan 17449 to its intersection with the south-western side of Orpheus Drive (not legal road); thence north-westerly along that last-mentioned south-western side of Orpheus Drive to its intersection with the line of mean high water of the Manukau Harbour and along that line of mean high water of the Manukau Harbour, to and along the south-eastern boundaries of Lot 1, DP 68578, (Recreation Reserve), to and again along the said line of mean high water of the Manukau Harbour, to and along the southern boundaries of Lot 2, DP 92189, Block VII, Titirangi Survey District, to and again along the line of mean high water of the Manukau Harbour, to and along the eastern, southern and western boundaries of Lot 1, DP 95921, to and again along the line of mean high water aforesaid, including those areas marked A, B and C, as shown on SO Plan 53502, to and along the line of mean high water of Little Muddy Creek and Big Muddy Creek, to and again along the line of mean high water of the Manukau Harbour to the point of commencement, including the islands of Three Kings, Cavalli, Poor Knights, Mokohinau, Hen and Chicken, Great Barrier, Little Barrier, Kawau, Motuora, Tiritiri-Matangi, The Tor, Browns, Waiheke, Kermadec, Rangitoto,
