thence generally southerly along the western boundary of Section 37 to the southernmost point of Section 26, Block II, Hunua Survey District; thence north-westerly along the south-western boundary of the said Section 26, to the eastern side of Valley Road; thence westerly by a right line to and along the southern boundaries of Section 17, Block II, Hunua Survey District to the south-western corner of the said Section 17; thence generally northerly along the western boundaries of Sections 17, 16, 15 and 14, Block II, Hunua Survey District to the north-western corner of Section 14, aforesaid; thence westerly along a right line to the south-eastern corner of Part Lot 2, DP 3628; thence westerly along another right line to the easternmost corner of Section 4, Block II, Hunua Survey District; thence westerly, north-westerly and north-easterly along the southern, south-western and north-western boundaries of the said Section 4, to its northernmost point; thence along a right line to the middle of Marsack Road; thence south-easterly along the middle of Marsack Road, north-easterly along the middle of Racecourse Road to a point in line with the north-eastern boundary of Part Section 5, Block II, Hunua Survey District; thence to and along the said boundary and its production to the left bank of the Wanganui River; thence north-easterly along the left bank of the Wanganui River to its intersection with the southerly production of the original south-western boundary of Ohura South G4M1, shown on S.O. 19220 (South Auckland Registry) situated in Block II, Piopiotea Survey District; thence north-westerly along that production to its intersection with the middle of Echolands Road; thence northeasterly along the middle of that road to a point in line with the south-western boundary of Lot 1, DPS 26994; thence to and along that boundary to a point 60.35 metres distant from the northwestern side of Echolands Road; thence westerly along a right line to the northernmost corner of part Ohura South G4M2B; thence north-westerly along a right line to the north-eastern corner of Ohura South G4L1A1; thence westerly along the northern boundary of G4L1A1 and its production to its intersection with the eastern boundary of part Ohura South G4L2B2B; thence northerly and westerly along the eastern and northern boundaries of the said part G4L2B2B to the north-western corner of the last-mentioned

section; thence northerly and westerly along the eastern and northern boundaries of Ohura South G4J2B and the last-mentioned northern boundary produced to a point on the eastern boundary of part Ohura South G4H; thence northerly and north-westerly along the western and south-western boundaries of the said part G4H to its westernmost point; thence south-westerly, and generally northwesterly along the south-eastern and generally south-western boundaries of Section 23, Block XIII, Tuhua Survey District, and the last-mentioned boundary produced to the middle of Lairdvale Road; thence north-easterly along the middle of that road to a point in line with the north-eastern boundary of Section 18, Block XIII, Tuhua Survey District; thence north-westerly to and along that boundary to its intersection with the middle of the Man-gakohikatoa Stream; thence south-westerly along the middle of that stream and its production to its intersection with the middle of Simmons Road; thence north-westerly along the middle of that road to a point in line with north-eastern boundary of Section 59 Block XIII, Tuhua Survey District; thence north-westerly to and along the last-mentioned boundary to its intersection with the middle of a stream flowing through Sections 59 and part Section 14, Block XIII, aforesaid; thence generally north-westerly down the middle of that stream and its production to the middle of Taringamotu Road thence generally northerly along the middle of Taringamotu Road and the middle of a public road forming the generally eastern boundary of Section 62, Block XIII, Tuhua Survey District, and a production of the northern end of the said public road to the middle of the Taringamotu River; thence generally easterly up the middle of that river to its intersection with the generally southern boundary of part Waihaha I, (Pureora State Forest Park, Gazette, 1978, page 2463), situated in Block IX, Puketapu Survey District; thence generally north-easterly along the generally south-easterly boundaries of part Waihaha 1, Waihaha 2, and Waihaha 3A, and northerly along the eastern boundary of the last-mentioned 3A Block to its north-east corner; thence generally northerly along the generally western boundaries of Tihoi 3B8A and Section 1 Blk VIII Hurakia S.D. to Trig Station 1390, Pureora situated in Block III, Hurakia Survey District; thence northerly along the eastern boundaries of Maraeroa A2, parts A3A and A3B2, crossing the intervening Scott Road (SH 30) to the north eastern most corner of the last said Block; thence northerly along the western boundary of part Pouakani 2, to the southernmost corner of part Pouakani B7; thence generally north easterly along the south eastern boundary of the said Block, crossing the intervening Ranginui Block Road and the last mentioned boundary produced to the middle of the Waiteti Stream; thence generally north-easterly down the middle of the said stream to its intersection with the middle of the Waipapa River; thence generally norththe middle of the Waikato River, situated in Block XVI Wharepapa Survey District; thence generally northerly down the middle of the Waikato River to its intersection in Block XII, Maungatautari Survey District with a right line between Trig Station 807, Uraura, in Block VII, Ngautuku Survey District, and Trig Station 1427, Maungatautari, in Block VII, Maungatautari Survey District; thence northwesterly along that right line to its intersection with the middle of another Waiteti Stream; thence generally westerly along the middle of that stream to its intersec-tion with the middle of Orepunga Road; thence generally northeasterly along the middle of that road to its intersection with the aforesaid right line between Trig Stations 807 and 1427; thence north-westerly along that right line to Trig Station 1427, aforesaid, and along another right line to the easternmost corner of Section 11, Block II, Maungatautari Survey District; thence north-westerly down the middle of that river to a point in line with the western boundary of Section 21, Block IX, Cambridge Survey District; thence northerly to and along that boundary, a right line across SH 1, to and along the western boundary of Lot 2, DP 14436, to the middle of the Karapiro Stream; thence generally easterly along the middle of that stream to a point in line with the south-eastern boundary of part Lot 2 DP 31473; thence to and along the last-mentioned boundary to the westernmost boundary of north part Allotment 240, Hautapu Parish; thence generally easterly along the generally southern boundary of the said part Allotment 240 to a point in line with the southern end of Cox Road; thence easterly along the said end of Cox Road to the middle, to and northerly along the middle of that road to its intersection with the middle of Whitehall Road; thence along a right line to the south-eastern corner of part Lot 2, DP 3569; thence northerly along the eastern boundary of the said part Lot 2
