thence southerly along the middle of Foster Road to its intersection with the middle of Trigg Road; thence south-easterly generally along the middle of Trigg Road to its intersection with the middle of Motu Road; thence southerly generally along the middle of Motu Road to its intersection with the middle of Tawa Road; thence north-easterly generally along the middle of Tawa Road, to and along the middle of Access Road to a point in line with the eastern boundary of Lot 1, DP 55344, Block V, Waitemata Survey District; thence south-easterly and south-westerly along the north-eastern and south-eastern boundaries of that Lot 1 to the southernmost corner of the aforesaid Lot 1; thence south-easterly and south-westerly along the north-eastern and south-eastern boundaries of Lot 1, DP 55944, and that last-mentioned boundary produced to its intersection with the middle of Farrand Road; thence south-easterly along the middle of Farrand Road to its intersection with the middle of Waitakere Road; thence north-easterly along the middle of Waitakere Road and the middle of Trotting Course Drive, crossing the intervening North Auckland Railway, and that middle line produced to its intersection with the middle of the Kumeu River; thence north-westerly generally up the middle of that river to a point in line with the southern boundary of part Allotment 1, Waipareira Parish, Block V, Waitemata Survey District, 1619 square metres, (0a-1r-24p), as shown on DP 26853; thence easterly along a right line, to and along that southern boundary and that last-mentioned boundary produced to its intersection with the middle of SH 16; thence south-easterly generally along the middle of that SH 16 to a point in line with the middle of Brighams Creek; thence north-easterly along a right line, to and down the middle of that creek to its intersection with the middle of Rangitopuni Creek, Block VI, Waitemata Survey District; thence northerly generally up the middle of that creek to a point in line with the middle of Mill Flat Road; thence south-easterly along a right line, to and along the middle of Mill Flat Road to its intersection with the middle of SH 18; thence north-easterly generally along the middle of that SH 18 to its intersection with the middle of SH 1, Block II, Waitemata Survey District; thence south-easterly generally along the middle of that SH 1 to its intersection with the middle of Albany Heights Road; thence north-easterly generally along the middle of Albany Heights Road and the middle of Wright Road to its intersection with the middle of East Coast Road; thence north-westerly along the middle of East Coast Road to a point in line with the left bank of Okura River; thence north-easterly and westerly generally along a right line, to and along that left bank and the right bank of a tributary of that Okura River, crossing the intervening Haigh Access Road to a point in line with the northern boundary of Lot 1, DP 93504, Block XV, Waiwera Survey District; thence westerly along a right line, to and along that northern boundary and that last-mentioned boundary produced to its intersection with the middle of East Coast Road; thence north-westerly generally along the middle of East Coast Road to its intersection with the middle of SH 1; thence north-easterly along the middle of that SH 1 to a point in line with the eastern boundary of part Allotment 15, Okura Parish as shown on DP 3450; thence northerly along a right line, to and along that boundary to its intersection with the right bank of the Weiti River; thence north-easterly generally along that right bank to a point in line with the north-eastern boundary of part Allotment 60, Waiwera Parish, as shown on DP 9624; thence north-westerly along a right line, to and along that boundary and that last-mentioned boundary produced to its intersection with the middle of Wainui Road; thence westerly generally along the middle of Wainui Road to a point in line with the western boundary of Lot 1, DP 42190, Block XI, Waiwera Survey District; thence north-westerly along a right line, to and along that boundary to its westernmost corner; thence north-easterly along the northern boundaries of the aforesaid Lot 1 and Lots 1, 2, 3, 4, 5, 6, and 7, DP 40724 to its intersection with the south-western boundary of Lot 4, DP 67675; thence north-westerly along that boundary to its westernmost corner; thence north-easterly and easterly along the south-eastern boundary of Lot 2, DP 67675 and the southern boundary of Lot 1, DP 99777 to its easternmost corner; thence north-westerly generally along the north-eastern boundaries of the aforesaid Lot 1, and that last-mentioned boundary produced to its intersection with the middle of an unnamed legal road; thence south-easterly along the middle of that unnamed legal road to its intersection with the middle of Leigh Road; thence northerly generally along the middle of Leigh Road to its intersection with the generally southern boundary of Allotment 676, Waiwera Parish; thence westerly generally along that boundary to its intersection with the line of mean high water of the Orewa River; thence westerly and north-easterly generally along that line of mean high water to its intersection with the generally western boundary of

Lot 86, DP 107158; thence north-westerly along that last-mentioned boundary and that boundary produced to the middle of an unnamed legal road; thence north-easterly generally along the middle of that unnamed legal road to a point in line with the south-western boundary of Lot 1, DP 35842; thence north-westerly along a right line, to and along that boundary to its westernmost corner; thence north-easterly along the north-western boundary of the said Lot 1 and that boundary produced to its intersection with the middle of Maire Road; thence north-westerly along the middle of Maire Road to a point in line with the western boundary of Allotment 709, Waiwera Parish; thence northerly along a right line, to and along that last-mentioned boundary and that boundary produced to its intersection with the middle of West Hoe Road; thence north-easterly along the middle of West Hoe Road to its intersection with the middle of an unnamed legal road, forming the western and north-western boundaries of part Allotment NW 232, Waiwera Parish; thence northerly and south-easterly generally along the middle of that unnamed legal road to its intersection with the north-western boundary of Lot 2, DP 66936, Block VII, Waiwera Survey District; thence north-easterly along that boundary and that last-mentioned boundary produced across Nukumea Stream, to and along the south-eastern boundary of Allotment 228, Waiwera Parish to its south-easternmost corner; thence north-westerly and north-easterly along the south-western and north-western boundaries of Lot 1, DP 48277 and the north-western boundary of Lot 15, DP 47676 and that last-mentioned boundary produced to its intersection with the middle of Hillcrest Road; thence easterly generally along the middle of Hillcrest Road to a point in line with the eastern boundary of part Allotment 227, Waiwera Parish; thence northerly along a right line, to and along that last-mentioned eastern boundary, to and along the eastern end of an unnamed legal road, forming the western and north-western boundaries of Allotment 227 aforesaid, and that last-mentioned boundary produced across Lot 1, DP 62075, to and along the western boundary of part Lot 1, DP 62076 and that last-mentioned western boundary produced to the middle of Otanerua Stream; thence north-easterly generally down the middle of that stream to a point in line with the northern boundary of part Allotment 378, Waiwera Parish; thence easterly along a right line to its intersection with the middle of SH 1; thence northerly generally along the middle of that SH 1, to and along the middle of an area coloured green, as shown on SO Plan 42709, 3518 square metres (0a-3r-19.1p), to and again along the middle of that SH 1 to its intersection with the middle of Weranui Road; thence westerly generally along the middle of Weranui Road to a point in line with the eastern boundary of Lot 72, DP 4653, Block III, Waiwera Survey District; thence southerly along a right line, to and along that boundary to its southernmost corner; thence westerly along the southern boundaries of the aforesaid Lot 72, and Lots 71, 70, 69, 68, 67, 66, 65, and 64, DP 4653, to and along the western boundary of that Lot 64 and that last-mentioned boundary produced to its intersection with the middle of Weranui Road; thence westerly along the middle of Weranui Road for a distance of 90 metres; thence due north along a right line to the middle of the Waiwera River; thence easterly generally down the middle of that river to a point due north from the northernmost corner of The Strand; thence due north along a right line to the left bank of the Waiwera River, being the line of mean high water of the Hauraki Gulf; thence north-easterly generally along that line of mean high water, excluding part Section 1, Block IV, Waiwera Survey District, and crossing the mouths of the Puhoi River, the Te Muri o Tarakiki Stream, the Mahurangi Harbour, the Matakana River, the Whangateau Harbour and the Kohuroa Stream, and excluding Cape Rodney, Okakari Point Marine Reserve, as shown on SO Plan 58975, 547.0000 hectares, Block I, Rodney Survey District, to and north-westerly generally along the said line of mean high water crossing the mouth of the Pakiri River, to and along that line of mean high water of the South Pacific Ocean, crossing the mouths of the Mangawhai Harbour, the Wairahi Stream and the Waipu River, to and again along that line of mean high water of the South Pacific Ocean to the point of commencement, and including Kawau Island, Motuora Island, and other adjacent islands.

All that area bounded by a line commencing at the south-westernmost corner of Lot 64, DP 4653, Block III, Waiwera Survey District and proceeding northerly along the western boundary of that Lot 64 and the last-mentioned boundary produced to its intersection with the middle of Weranui Road; thence westerly along the middle of Weranui Road for a distance of 90 metres; thence due north along a right line to the middle of the Waiwera River; thence easterly generally down the middle of that river to a point due north from the northernmost corner of The Strand; thence due south along a right line, to and along the line of mean high water of the Hauraki Gulf, crossing the intervening Waiwera Road, to its intersection with the westernmost corner of Lot 3, DP 60697; thence southerly along the eastern side of SH 1 to its intersection with the northernmost boundary of part Allotment 378, Waiwera Parish; thence southerly generally along that line of mean high water to its intersection with the westernmost corner of Lot 25, DP 29547, Block VII, Waiwera Survey District; thence southerly along
