### ORDER IN COUNCIL

At Wellington this 9th day of March 1987

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 7 of the National Parks Act 1980, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby declares that the land described in the Schedule hereto shall, as from the 14th day after the date of the publication of this Order in Council in the *Gazette*, be national park subject to the National Parks Act 1980 and shall be added to and form part of the Westland National Park.

79,6488 hectares, more or less, being Lots 1 and 3, D.P. 2214 (formerly parts Rural Sections 2437 and 2496), Rural Section 6092 (formerly part Rural Section 5406), situated in Blocks XIV and XV, Gillespies Survey District. S.O. Plan 10370.
