Amending Declarations Taking Land for Soil Conservation and River Control Purposes and for Better Utilisation and Notices Declaring Land to be Crown Land in Blocks I, II, IV and V, Whakatane Survey District, Whakatane County and the Borough of Whakatane

PURSUANT to section 55 of the Public Works Act 1981, the Minister of Works and Development hereby:

(a) Amends the declaration dated 10 April 1975 published in the *New Zealand Gazette* of 17 April 1975, No. 34 at page 868 and registered as H. 035392, South Auckland Land Registry, declaring land taken for soil conservation and river control purposes and better utilisation and to be Crown land in Block I, Whakatane Survey District, Whakatane County by inserting after the word "taken" in the fourth line the words "subject to the pipeline easement created by Court Order S. 301562, South Auckland Land Registry";

(b) Amends the declaration dated 22 December 1975 published in the *New Zealand Gazette* of 15 January 1976, No. 2 at page 77 and registered under No. H067340, South Auckland Land Registry, declaring land taken for soil conservation and river control purposes and to be Crown land in Block I, Whakatane Survey District, Whakatane County by inserting after the word "taken" in the fourth line the words "subject as to the land firstly described to the water easement created by Court Order S. 301562, South Auckland Land Registry";
