(part Tapanui Domain); thence north-easterly along a right line, crossing part Section 19, Sheddon Road and Sections 24 and 20 all in Block IX, Rankleburn S.D., to the south-westernmost corner of part Run 163A; thence north-easterly along the north-western boundary of said part Run 163A to the south-western boundary of part Section 3, Block X, Crookston S.D.; thence north-easterly across said part Section 3 and Black Gully Road to and along the north-western boundary of said part Run 163A to the south-western corner of Section 4, Block X, Crookston S.D.; thence along the western and northern boundaries of the said Section 4 and the western boundary of Section 6, Block X aforesaid to the north-western boundary of part Run 163A; thence along the north-western boundaries of said part Run 163A and Run 709 to Trig Station L; thence northerly along the western boundaries of Blocks XIX and XVI, Crookston S.D. and Section 18, Block XVII, Crookston S.D. to the southern side of No. 90 State Highway; thence along a right line across said highway to the south-western corner of Section 16, Block XVII, Crookston S.D.; thence along the western and northern boundaries of said Section 16 and the northern and eastern boundaries of Section 17, Block XVII, Crookston S.D. to the northern side of No. 90 State Highway; thence along a right line across said highway to the north-eastern corner of Section 19, Block XVII, Crookston S.D.; thence along the eastern boundary of said Section 19 and the northern boundaries of Blocks XVI and I, Crookston S.D. and the last-mentioned boundary produced to the left bank of the Clutha River; thence generally north-easterly along the said left bank to and generally north-easterly along the said left bank to and generally north-easterly along the left bank of the Talla Burn to the southern boundary of Section 1, Block I, Lammerlaw S.D.; thence easterly, northerly and westerly along the southern, eastern and northern boundaries of said Section 1 to the right bank of the Talla Burn; thence north-easterly along said right bank to and north-westerly along the south-western boundary of Run 658 to the south-easternmost corner of Section 2, Block I, Lammerlaw S.D.; thence along a right line to Trig Station H (Lammerlaw Top) Lammerlaw S.D.; thence generally northerly along the watershed through Trig Station Q (Davidsons Top) St Abbs S.D. along a right line between said Trig Station C and Trig Station W, Manorside S.D. to its intersection with the south-western boundary of Section 1, Block V, Manorside S.D.; thence north-westerly along that boundary and generally northerly along the western boundaries of Section 1, Block V aforesaid, Section 1, Block III, Manorside S.D., Lot 4, D.P. 9807, Runs 622 and 621 and Section 1, Block IX, Poolburn S.D. and the last-mentioned boundary produced to the south-western boundary of Section 3, Block XI, Gimmerburn S.D.; Section 2, Block XVII, Blackstone S.D. and Section 24, Block XVI, Blackstone S.D. to the south-eastern side of the Ida Valley Back Road; thence south-westerly along that side of the road to a point in line with the western boundary of Block XVI, Blackstone S.D.; thence northerly to and along that boundary to and along the south-eastern boundary of Block XII, Blackstone S.D.; the south-western and north-western boundaries of Run 224X, the north-western boundary of Run 224Y and the south-western boundary of part Run 224A (Blackstone Hill) to the westernmost corner of said run; thence westerly along a right line to the confluence of the Manuherikia River and Dunstan Creek; thence northerly along the middle of said creek to the northern boundary of Block VII, Blackstone S.D.; thence along the northern boundaries of said Block VII and Block VIII, Blackstone S.D. and the western boundary of Block III, St Bathans S.D. to the northern boundary of the said Block III; thence westerly along a line being the western production of the northern boundary of said Block III to a point on the southern boundary of Block VII, St Bathans S.D. also being a point on the north-eastern boundary of Section 34, Block II, St Bathans S.D.; thence north-westerly and south-westerly along the southern boundary of said Block VII to the middle of Dunstan Creek; thence generally north-westerly along the middle of said creek to a point on a right line between Geodetic Trig Station, Nicholas Peak, Block IX, St Bathans S.D. and Trig Station A A (Mount St Bathans), Block XVI, St Bathans S.D.; thence north-easterly along that right line to Trig Station A A aforesaid; thence easterly along the northern boundaries of St Bathans and Turmagain Survey Districts to the summit of the Hawkund Range; thence generally south-easterly along that summit to Trig Station I (Mount Ida); thence generally easterly along the southern boundary of Run 573 to and easterly along the watershed running across the south-western corner of Run 574 to the south-eastern boundary of said Run 574; thence generally north-easterly along the south-eastern boundary of Run 574 to the watershed running across the north-eastern corner of Run 576; thence generally southerly and north-easterly along that watershed to Trig Station Y, Block IX, Kyeburn S.D.; thence generally southerly along the eastern boundaries of Runs 576 and 736 to Trig Station I (Mount Nobbler); thence southerly along the middle of the road that forms the north-eastern boundaries of Runs 736 and 206D to a point in line with the eastern boundary of Run 206E; thence southerly to and along that boundary and along the northern boundary of part Run 203C to Trig Station A, Kakanui Peak; thence along the eastern boundaries of Section 1, Block VI, Swinburn S.D. and Section 3, Block X, Swinburn S.D., the north-eastern boundaries of Section 2, Block X, Swinburn S.D. and Section 2, Block IX, Waihero S.D., the north-eastern and south-eastern boundaries of Section 3, Block IX, Waihero S.D. and the eastern boundary of Section 1, Block IX aforesaid to the south-eastern corner of said Section 1; thence south-easterly along the summit of Horse Range to a point on the south-eastern boundary of Run 699, 800 metres from the north-eastern corner of Section 31, Block VIII, Waihero S.D.; thence southerly along the south-eastern boundary of said Run 699 to and south-easterly along the north-eastern boundaries of Blocks VIII, V and III, Waihero S.D. to the south-eastern boundary of Lot 5, D.P. 11132; thence southerly along that boundary to the northern side of Razorback Track; thence south-easterly along said side of that track and that side produced to the eastern side of Razorback Road; thence southerly along said roadside to and south-easterly along the northern side of the road that forms the northern boundary of part Section 4, Block XIV, Moeraki S.D. to a point in line with the eastern boundary of said part Section 4; thence southerly to and along that boundary to and along the northern and eastern boundaries of Block XII, Moeraki S.D. and the northern boundary of Block VI, Moeraki S.D. to the south-eastern side of a public road passing through Section 31, Block XI, Moeraki S.D.; thence north-westerly along that roadside to and south-easterly along the south-western side of a road that passes through Section 46, Block XI, Moeraki S.D. to the western side of Horse Range Road; thence southerly along said roadside to a point in line with the south-western boundary of Section 919R, Block IX, Moeraki S.D.; thence generally south-easterly to and along that boundary to the southernmost corner of said Section 919R; thence south-easterly along the south-western side of the closed road that intersects D.P. 211 and that roadside produced to the northern boundary of Block III, Moeraki S.D.; thence easterly and northerly along the said northern boundary to the high-water mark of the sea coast; thence generally southerly along the sea coast to Heyward Point; thence along the eastern and southern boundaries of Section 50 (Scenic Reserve) to and southerly along the eastern boundaries
