S. 19374, the south-eastern and southern boundaries of part Maungatautari 3A5A1 Block and the last-mentioned boundary produced across a Public Road to the south-eastern boundary of part Lot 4, D.P. 12622; thence along the south-eastern and south-western boundaries of said part Lot 4, the south-eastern and north-western boundaries of Lot 1, D.P. 33188, the north-western boundary of Section 25, Block V, Maungatautari S.D., the southern boundary of part Puahue 5C Block, to the south-western boundary of part Lot 1, D.P. S. 4675; thence north-westerly along the south-western boundaries of said part Lot 1, Sections 32 and 31, Block V, Maungatautari S.D., Sections 8 and 7, Block I, Maungatautari S.D. and Sections 7 and part 4, Nolan Settlement to and westerly along the southern boundary of part Lot Settlement to and westerly along the southern boundary of part Lot 9, D.P. 3114 to the north-westernmost corner of Section 1, Puahue Settlement; thence north-westerly along a right line to a point in Block III, Puniu S.D. on the north-eastern boundary of part Lot 1, D.P. 17300 that is intersected by the western boundary of Pukekura D.P. 17300 that is intersected by the western boundary of Pukekura Parish; thence north-easterly and north-westerly along said Parish boundary to a point in line with the north-western boundary of part Allotment 225, Pukekura Parish (C.T. 1425/69); thence north-easterly across Muir Road to and along that boundary to and along the north-western boundaries of D.P. 4096 (C.T. 1254/62), part Allotment 225, Pukekura Parish (C.T. 1206/170), D.P. Lot 2 to a point in line with the north-western boundary of Allotment 1, Pukekura Parish; thence north-easterly across the Cambridge-Ohaupo Road to and along that boundary and that boundary produced to the middle of the Waikato River; thence generally northwesterly along the middle of said river to and north-easterly along the middle of the Mangaonua Stream to the middle of the Mangaone Stream; thence south-easterly along the middle of said stream to the northern boundary of Lot 8, D.P. 15238; thence along the northern boundary of Lot 8, the north-eastern boundary of Lot 1, D.P. S. 18737 and the western boundary of Lot 5, D.P. 14934 to the southern side of Bruntwood Road; thence south-easterly along said roadside to a point in line with the western boundary of Lot 2, D.P. 11179; thence northerly to and along that boundary and along the northern boundaries of Said Lot 2 and Lot 1, D.P. 11179, the western boundaries of Lot 8, D.P. 16757, the western and northern boundaries of Lot 8, D.P. 16757, the western and northern boundaries of Lot 8, D.P. 16757, the northern boundary of Lot 9, D.P. 16757 and the last-mentioned boundary produced to the middle of Marychurch Road; thence northerly along the middle of said road and easterly along the middle of Church Road to a point in line with the eastern boundary of Section 1, Block VIII, Hamilton S.D.; thence northerly to and along that boundary to and easterly along the northern boundary of Section 1, Block VIII, Hamilton S.D., then cortherne western boundary of Section 1 and that boundary produced across Victoria Road, Section 4, Block I, Cambridge S.D., Lot 1, D.P. 22825 and Lots 1 and 2, D.P. 33155 to the south-western boundary of Section 35, Te Miro Settlement; thence north-westerly along said south-western boundary to Trig Station 50, Pukemoremore, the point of commencement.

Poverty Bay Electric Power Board Electricity Supply Licence 1987

I, Robert James Tizard, Minister of Energy, acting pursuant to section 20 of the Electricity Act 1968, hereby licence Poverty Bay Electric Power Board hereinafter called the Electrical Supply Authority to supply electricity, and to lay, construct, put up, place and use all electric lines and works which may from time to time be required for the distribution and supply of electricity within the area specified in the Schedule hereto.

This licence is issued subject to the following conditions:

CONDITIONS

1. This licence may be cited as the Poverty Bay Electric Power Board Electricity Supply Licence 1987.

2. The Electrical Supply Authority shall comply with the provisions of this licence, the Electricity Act 1968 and all enactments made in amendment of or substitution for that Act, any Electrical Codes of Practice made under that Act, the Electrical Supply Regulations 1984, the Electrical Wiring Regulations 1976 and all regulations made in amendment of or substitution for any of those regulations.

3. Any notice to be given to the Electrical Supply Authority shall be sufficient if sent by registered post letter to the offices of the Electrical Supply Authority.

4. Any notice to be given on the part of the Minister of Energy shall be sufficient if given in writing signed by the Minister or by any persons acting under the authority of the Minister.

5. Any notice to be given to the Minister of Energy shall be sufficient if given in writing to or sent by registered post letter addressed to the Secretary of Energy, Ministry of Energy, Wellington.

6. This licence shall not be construed as granting a consent to generate electricity pursuant to section 25 of the Electricity Act 1968.

7. This licence shall come into force on the 1st day of April 1987 and shall continue in force for a period of 21 years from that date unless it is sooner lawfully determined in accordance with clauses 8 or 9 hereof.

8. The Governor-General in Council may pursuant to section 22 of the Electricity Act 1968 cancel this licence if the Electrical Supply Authority is in breach of the provisions contained in clause 2 of these conditions.

9. This licence may be cancelled by the Minister of Energy at the request of or with the consent of the Electrical Supply Authority.

10. At the expiry or cancellation of this licence, the Electrical Supply Authority shall as required by notice in writing by the Minister of Energy remove all buildings, poles and other erections and all transmission lines, plant and other machinery and other
