*Road Stopped in Blocks XII and XV, Mangaorongo Survey  
District, Otorohanga District*

PURSUANT to Part VIII of the Public Works Act 1981, the Minister of Works and Development:

(a) Pursuant to section 116, declares the portions of road described in the Schedule hereto to be stopped and
