*Declaring a Sewage Easement to be Acquired over Land for
Maori Housing Purposes in Gisborne City*

PURSUANT to section 20 of the Public Works Act 1981, the Minister of Works and Development declares that, an agreement to that effect having been entered into, a sewage easement to be forever appurtenant to the land held for Maori housing purposes described in the Second Schedule is hereby acquired (and may be surrendered at any time by notice in the *Gazette*) on the 18th day of June 1987 vesting in the Crown (called the grantee) the right to drain sewage across the land described in the First Schedule hereto by means of piped drains, such grant being in accordance with paragraphs 4 and 5 of the Seventh Schedule of the Land Transfer Act 1952 provided that:

- (1) The owner of the land in the First Schedule (called the grantor) may at his cost (including all legal and survey costs) relocate the pipeline and in so relocating the grantor shall ensure that there is no disruption of the Crown's right to drain sewage.
- (2) The grantor shall not erect any building or structure nor plant any tree or shrub over the pipeline, or any relocated pipeline.
