PURSUANT to regulation 17 of the Import Control Regulations 1973,* the Minister of Trade and Industry hereby gives the following notice:

NOTICE

1. (1) This notice may be cited as the Import Control Exemption Notice (No. 10) 1987.

(2) This notice shall come into force on the 19th day of June 1987.

2. Goods of the classes specified in the First Schedule hereto, imported from and being the produce or manufacture of any country, are hereby exempted from the requirement of a licence under the said regulations.

3. The exemption from the requirement of a licence under the said regulations, in respect of the classes of goods set forth in the Second Schedule hereto, included in the exemption notice shown in the Second Schedule hereto, is hereby withdrawn.
