south-eastern corner of that Block; thence generally easterly along the northern boundaries of Section 20, Block X, Tatua Survey District, Section 5, Block XI, Tatua Survey District and Lot 1, D.P. S. 35815 to the north-western corner of Section 14, Block XI, Tatua Survey District, thence north-easterly and south-easterly along the north-western and north-eastern boundaries of the said Section 14 to the northern corner of Lot 1, D.P. S. 36522; thence south-easterly along the northeastern boundary of the said Lot 1, crossing State Highway No. 5, to and along the north-eastern boundaries of Section 19, Block XI, Tatua Survey District and part Tahorakuri No. 4 Block and its production to the middle of the Waikato River; thence down the middle of that river to its confluence with the middle of the Parariki Stream in Block XII, Tatua Survey District and proceeding generally south-westerly up the middle of that stream to the north-eastern boundary of Tauhara North No. 1 Block; thence south-easterly and south-westerly along the north-eastern and south-eastern boundaries of that block, crossing Broadlands Road, to and south-westerly along the south-eastern boundaries of parts Tauhara North 3B, 3B Roadway, 3B again, 3B Roadway again, 3B again and 3A Blocks to the southernmost corner of the last-mentioned Block in Block III, Tauhara Survey District; thence south-easterly along the north-eastern boundaries of part Tauhara Middle 4A2A Block and Lot 1, D.P. S. 27812 in Block XIII, Takapau Survey District; thence south-easterly to and along that boundary to the southernmost corner of that Lot 2; thence north-easterly along the north-western boundaries of Run 60 and part Run 59 to the northernmost corner of the last-mentioned Run as shown on S.O. 39706 in Block III, Takapau Survey District; thence south-easterly along the north-eastern boundary of part Run 59 to the western boundary of land on D.P. 20113; thence northerly along that boundary to its north-western corner; thence westerly along the northern boundaries of Sections 53 and 45, Block XV Paeroa Survey District to the westernmost corner of Section 29, Block XV, Paeroa Survey District; thence northerly along the western boundaries of Section 29 aforesaid and Section 20, Block XI, Paeroa Survey District to its intersection with a right line between Trig. 31, Paeroa in Block V, Paeroa Survey District and Trig. 2120 Tawhiuau in Block XIV, Galatea Survey District; thence easterly along that right line to its intersection with the production of another right line between Trig. 18 Maungawhamana in Block III, Ruawahia Survey District and Trig. 38 Ahiwhakamura in Block X, Kaingaroa Survey District; thence south-easterly along a right line to Trig 78A Pekepeke in Block III, Wheao Survey District; thence southerly along a right line to Trig. 76 Taupiri in Block XII, Wheao Survey District: thence south-westerly along a right line to the easternmost corner of Heruiwi 4A1 Block in Block III, Heruiwi Survey District; thence southerly along a right line to Trig. B Pukeroa in Block XI, Heruiwi Survey District; thence easterly along a right line to Trig. Te Taumutu in Block XVI, Heruiwi Survey District being a point on the south-eastern watershed of the Rangitaiki and Whakatane Rivers; thence generally southerly along that watershed to the northernmost corner of Pohokura No. 1 Block in Block IV, Runanga Survey District; thence southerly and easterly along the western and southern boundaries of Pohokura No. 1 aforesaid to the western boundary of the former Tataraakina No. 11 Block in Block II, Waitara Survey District; thence southerly and southeasterly along the eastern and north-eastern boundaries of that former Tataraakina No. 11 Block and the last-mentioned boundary produced to the middle of the Mohaka River in the Hawkes Bay Land District; thence generally south-westerly up the middle of that River and generally westerly up the middle of the Waipunga River to a point in line with the northern boundary of Lot 3, D.P. 13787; thence westerly to and along that boundary and its production to the western side of Turangakumu Road; thence southerly along that roadside and the western side of Kowaro Roadway to the southernmost corner of Section 1, Block XI, Tarawera Survey District; thence westerly along a right line to the western side of State Highway No. 5; thence southerly along that roadside and south-westerly along the north-western side of Kowaro Roadway to the north-eastern boundary of part Tarawera 8 Block; thence generally westerly along the generally northern boundary of part Tarawera 10A, the abutment of Omarowa Roadway and continuing generally south-westerly along the generally north-western boundary of Tarawera 10A aforesaid to a point in line with the middle of a tributary of the Toropapa Stream as shown on M.L. 1404; thence south-westerly to and up the middle of that tributary to the southern boundary of Block X, Tarawera Survey District, approximately 200 metres east of the boundary between Blocks IX and X, Tarawera Survey District; thence westerly along the southern boundaries of Blocks X and IX, Tarawera Survey District to the eastern boundary of Wharetoto No. 1 Block; thence southerly and westerly along the eastern and southern boundaries of that block and the production of the last-mentioned boundary to the middle of the Mohaka River; thence generally southeasterly down the middle of that river to a point in line with the southern boundary of Tapapa No. 3 Block; thence westerly, to and along that boundary and north-westerly along the southeastern boundary of that Block and its production to the middle of the Oamaru River; thence generally north-easterly down the middle of the Oamaru and Mohaka Rivers to a point in line with the production of the eastern boundary of part Kaimanawa 1A Block in Block V, Aripia Survey District; thence northerly to and along the eastern boundary of that Block and Kaimanawa 1B Block to its intersection with the boundary of Kaimanawa 1E Block; thence northerly and westerly along the eastern and northern boundaries of the lastmentioned block to the north-eastern corner of Section 1, Block XII, Waitahanui Survey District; thence westerly along the northern boundary of the said Section 1 to its intersection

with the middle of the Te Arero Stream, thence down the
